2 **Date:** 8/17/99

3 **Present:** Analiese Presley and Detective Theresa Pfeiffer

4 Pfeiffer: Have a seat right here. (inaudible) Ok. Where ever you'd like to sit feel free.  
5 You can just move that. Ok. Analiese I appreciate you coming in and I just want to go over  
6 some of the things we talked about on the 5<sup>th</sup> of August when Detective Fike and I came by your  
7 apartment.

8 Presley Ok.

9 Pfeiffer: On South Side, cause, what is today? Is it the...

10 Presley The 17<sup>th</sup>.

11 Schindler: All day long.

12 Pfeiffer: I think I've lost a day somewhere. Ok. We talked about hmm...I guess it would  
13 have been the day of the 30<sup>th</sup> of the July of '99. And that was the day that, it was a Friday. And  
14 that was the day you and Talitia had planned, Talitia Watson, a friend of yours, had plans for  
15 later on.

16 Presley Uh-huh (affirmative)

17 Pfeiffer: And you told Detective Fike and I that you had spoken to Julius Jones that day on  
18 the phone, off and on, while you were at work.

19 Presley Uh-huh (affirmative)

20 Pfeiffer: Ok, lets just start there. Ok, so you said he called you several times during the  
21 day?

22 Presley Yes.

23 Pfeiffer: Ok. And that, what did you tell me?

24 Presley Well while I was over at, he just called off and on and just, because I didn't really  
25 have anything, that much work to do. So he just called to see what I was doing, was talking to  
26 him uh, cause we had previously made plans to out of town.

27 Pfeiffer: Go out of town? To where?

28 Presley Dallas.

29 Pfeiffer: Ok. Was that for that weekend? I'm sorry.

1 Presley Isn't that where Six Flags is? Where ever Six Flags is.

2 Pfeiffer: There is, there is a Six Flags in Arlington, which is near Dallas.

3 Presley Oh ok, well...hmm, we had made plans like a few weeks before and so this week I  
4 was (inaudible) ok, we can go this week. Or this weekend and so hmm, we never had made  
5 plans, then Talitia and me or whatever was like, "well we want to go to the club Saturday, so..." I  
6 told him that, well I didn't tell him I wanted to go to the club, I just told him I didn't want to go  
7 any more.

8 Pfeiffer: And that would have been the weekend of the 30<sup>th</sup>?

9 Presley Uh-huh (affirmative)

10 Pfeiffer: Through the, ok. Ok, so like the next day you guys were gonna leave?

11 Presley Yeah. Well we probably would have left that night, but I didn't feel like goin'  
12 so...

13 Pfeiffer: Ok. So then what happened from there? About what time was the last time you  
14 spoke to him on the phone at work?

15 Presley At work, it had to be about 3 something. 3 P.M., 3, 3:30.

16 Pfeiffer: Ok. Did Talitia call you anytime that you knew before she came over, about  
17 some things she'd seen on the news?

18 Presley Yeah.

19 Pfeiffer: Ok what did she tell you about that?

20 Presley She said, she (inaudible) the news because uh, there was a shoot out on 122<sup>nd</sup> and  
21 Greystone. And so she was (inaudible) so she was like uh, are you sure Julius is ok, or he's not  
22 going, are they over there with you? And I was like, "Man, you know shut up quit playing."  
23 And I was like, "No, he's not involved," and she was like, "Oh ok," And so then, she doesn't  
24 have a phone...then I was looking at the news and then he calls. And I was like, oh man, you  
25 know, that's his house and everything. So, and he was like, he was like, you know, "I'm about  
26 to leave here." And I was like, "Ok, where you going?" And he was going, "I don't know yet."  
27 And I was like, "Well when are you leaving?" Cause he was just ,acting, I don't, I don't know,  
28 like he was dying or something. Like I was never gonna see him again. I was like, (inaudible),  
29 he was like, "I love you. and I miss, I miss you and I'm gonna call you." And because I never

1 returned his pages whenever he paged he was telling me, “whenever I page you, you have to call  
2 me back.” You know, it was like, “Ok, you know that’s fine.” And so uh, I ask him why he  
3 was leaving and he was like, “Man, some stuff happened,” he was like, “and they think I’m  
4 involved,” and he was like, “so I have to go,” or whatever, so I can locate me a lawyer or  
5 something and get it all cleared up.” I was like, “Ok.” You know, fine. And uh...

6 Pfeiffer: Go ahead.

7 Presley Uh, so then I ask him, cause at that time uh, he was, he said something about  
8 somebody (inaudible) or somebody stole a car and he was suppose to be involved or something.  
9 And so I ask him, I was like, “What kind of car?” Cause I didn’t know what kind of car it was  
10 on TV, I just knew it was something happened in Edmond. And he was like, “Something that  
11 happened in Edmond.” And so about that time uh, the man who got killed, his picture came up  
12 and they said something about suburban. So I ask him, I said, “Was this suburban?” And he  
13 kinda hesitated and then he was like, “Yeah.” And so I was like, “So what happened?” And he  
14 was like, “I don’t know,” he was like, “Somebody died and they,” he was like, “And they think I  
15 was involved.” He didn’t tell me that they thought he did it and so I was like, “Well do you  
16 know who did it? What happened?” He was like, “West, me and Westside and Day Day.”

17 Schindler: Westside being Chris Jordan.

18 Pfeiffer: Chris Jordan, yes. Better known as...

19 Presley He said, “We wasn’t even there, we were hmm, on the South Side and uh, we  
20 were just suppose to take the car to it’s destination.” And uh, he was like, “It was two other  
21 guys.” And I was like, “Well who is it?” You know, “Just tell me,” and he was like, “No, I  
22 don’t want to say it over the phone.” And I was like, “Oh, ok.” And then that was, that was  
23 basically it.

24 Pfeiffer: So he was saying that there was two other guys...

25 Presley Involved.

26 Pfeiffer: That were involved...

27 Presley They were suppose to go take the car, go steal it I guess. And he was just suppose  
28 to like drive it somewhere.

29 Pfeiffer: To it’s destination?

1 Presley Yeah.

2 Pfeiffer: Ok. And did he say something to you about uh...a camera in a store? Where he  
3 dropped the car off at?

4 Presley Yeah, they were uh...I guess after they were suppose to be taking the car  
5 somewhere he said that they were probably on a camera in a store, he was probably seen driving  
6 it on the camera or something. And he was like, because Day Day said, suggested that they  
7 leave it at this store instead of taking it to the shop that they were suppose to take it to. And so  
8 he said, so him and Day Day should be on camera. And he was like, "but I don't think Westside  
9 was with us." So that, I guess at the grocery store I guess where they found it something, I don't  
10 know.

11 Pfeiffer: Where they found the suburban?

12 Presley I guess, I don't know, he never, he didn't say what store he just said at a store.

13 Pfeiffer: Ok. You told us that you had found a gun in Julius' car at one time. Tell me  
14 about that.

15 Presley Well one day I was just going through his car and...

16 Pfeiffer: Now which car is this?

17 Presley This is the Cutlass Supreme. The gold car. It's the one him and Westside  
18 (inaudible).

19 Pfeiffer: Oh ok.

20 Presley It was, it was like a gun in between where, like in between the seats, it's like a  
21 little one. Kind of like a little one, (inaudible).

22 Pfeiffer: Like a console?

23 Presley Yeah.

24 Pfeiffer: In between the seats, like the front seats?

25 Presley Uh-huh (affirmative)

26 Pfeiffer: Ok.

27 Presley And so I was just going through there and I think, I think that's where I found the  
28 gun. I mean I saw it, you know, "Why do you have that?" and he was, at the time there were  
29 some guys that were wanting to fight him. And they were like, looking for him and everything.

1 They were even telling me, you know, “If I see your boyfriend, you know, I’m gonna shoot him  
2 or kill him.”

3 Pfeiffer: Now who’s this?

4 Presley I don’t even know their names. Just like guys at the clubs.

5 Pfeiffer: Which clubs?

6 Presley Like at MICKEY’S and CASONOVA’S.

7 Pfeiffer: Why did they say they wanted to...

8 Presley I don’t know...

9 Pfeiffer: Do harm to Julius?

10 Presley I know this one guy, Isaiah, but I didn’t know, they use to be like best friends all  
11 of a sudden he just didn’t like him anymore and he wants to fight him. Over, I guess, he owed  
12 him some money or...I don’t know. But they, they quit liking each other.

13 Schindler: Julius owed Isaiah some money?

14 Presley No, Isaiah owed Julius some money, and so Julius is trying to get him money, but  
15 Isaiah...I don’t know, this and, Julius quit liking Isaiah because he said he was the reason why  
16 he went to jail. Over the car. That...

17 Pfeiffer: Which car?

18 Presley The last time he went to jail. The car that he had bought from Isaiah.

19 Pfeiffer: Was that the white Honda?

20 Presley Yeah.

21 Pfeiffer: In Norman?

22 Presley When he was found at, found in driving the...

23 Presley I think so. I don’t know where it’s gonna be at.

24 Pfeiffer: Ok.

25 Presley The white Honda.

26 Pfeiffer: And describe the gun. You described it for me before, but describe it again.

27 Presley Uh...it’s was like, he could hold it in his hand, it was like, (inaudible), the barrel  
28 part I guess.

29 Pfeiffer: Uh-huh (affirmative)

1 Presley Like hung over his, over his fingers at the end, like a little piece hang, hung down.  
2 Pfeiffer: Ok.  
3 Presley And it was square like.  
4 Pfeiffer: And he's, what color did you say it was?  
5 Presley (inaudible)  
6 Pfeiffer: Silver?  
7 Presley Yeah.  
8 Pfeiffer: Ok. And when was this you found the gun in his car?  
9 Presley Maybe like January...or February.  
10 Pfeiffer: Ok, and were shirts going to be out of the car that he and Westside shared?  
11 Presley Yes  
12 Pfeiffer: Way back then?  
13 Presley Yeah. Well no, I guess it wasn't. I don't know when it was, like I guess maybe  
14 march or April. Somewhere around in...  
15 Schindler: But the key is...the gold car?  
16 Presley Uh-huh (affirmative)  
17 Schindler: That Chris and Julius shared.  
18 Presley Yes.  
19 Pfeiffer: And so that's where you found it?  
20 Presley Yeah.  
21 Pfeiffer: Ok. You also said you've found uh, some things in his regular glove box.  
22 Presley Uh-huh (affirmative)  
23 Pfeiffer: When you were looking through there. Can you tell me what those were?  
24 Schindler: Damn you could make a great ex-wife going through guy's cars.  
25 (Laughing)  
26 Pfeiffer: You bet.  
27 Presley Uh...there was like a whole bunch of condoms, box of condoms and there was a  
28 red bandanna and I think that was about it. (inaudible)  
29 Pfeiffer: Ok. Do you know Laymon Jordan? And that would be Westside's brother.

1 Presley Huh-uh (negative).  
2 Pfeiffer: Have you ever seen him?  
3 Presley Unless he was one of those guys that they came out, the, the day I went over  
4 there. But I don't know 'em.  
5 Pfeiffer: Ok. Ok...  
6 Schindler: Who does Laymon look like, maybe if you describe him, she might know  
7 whether she's seen him before.  
8 Pfeiffer: I do not know. Yet.  
9 Schindler: Yet.  
10 Pfeiffer: But I will know eventually so...we'll, we'll all learn. So we'll see. Uh...going  
11 back to Wednesday and this would have been the day of the murder.  
12 Presley Uh-huh (affirmative)  
13 Pfeiffer: Did you go to church that day? With your mother?  
14 Presley Uh-huh (affirmative)  
15 Pfeiffer: And what church did you go to?  
16 Presley Kingdom Hall.  
17 Pfeiffer: Kingdom Hall?  
18 Presley Uh-huh (affirmative)  
19 Pfeiffer: And where's that at?  
20 Presley It's on 21<sup>st</sup> and Hood.  
21 Pfeiffer: 21<sup>st</sup> and...  
22 Presley And Hood.  
23 Pfeiffer: Hood Street? H O O D?  
24 Presley Uh-huh (affirmative)  
25 Pfeiffer: Ok. Is that NE 21<sup>st</sup>?  
26 Presley Yeah.  
27 Pfeiffer: Ok. And did your mom, and what is your mother's name?  
28 Presley Cornell Presley.  
29 Pfeiffer: Cornell?

1 Presley Uh-huh (affirmative)  
2 Pfeiffer: C O R N E L  
3 Presley N E L L  
4 Pfeiffer: L, ok. Did she come and get you?  
5 Presley Uh, no I drove, no, yeah, she came and picked me up.  
6 Pfeiffer: Ok, so she came to...your brother's apartment on South Side?  
7 Presley Uh-huh (affirmative)  
8 Pfeiffer: On SE 59<sup>th</sup> and picked you up? And what time did she come and get you?  
9 Presley About 7.  
10 Pfeiffer: About 7?  
11 Presley 7:15.  
12 Pfeiffer: Ok. And drove you over to this address at NE 21<sup>st</sup> and Hood?  
13 Presley Uh-huh (affirmative)  
14 Pfeiffer: Ok, what time did church start approximately?  
15 Presley About 7:30.  
16 Pfeiffer: About 7:30? Ok. And did you get there right on time or a little bit after?  
17 Presley A little bit, yeah, we were like, we were a little late.  
18 Pfeiffer: Little late? Ok.  
19 Presley (inaudible)  
20 Pfeiffer: Ok, and how long does church last?  
21 Presley Uh, I think it was over about 9:30 or 10:00.  
22 Pfeiffer: 9:30 or 10. Is that kind of a usual thing for Wednesday night? Church, at this  
23 church?  
24 Presley Uh-huh (affirmative)  
25 Pfeiffer: Goes from about 7:30 to 9:30 or 10?  
26 Presley Uh-huh (affirmative)  
27 Pfeiffer: Ok. Ok. Uh...what night uh...Julius said he paged you. And this would have  
28 been after church.  
29



1 Presley I don't remember, I don't remember that. He might have but I was probably at  
2 work. (inaudible) cause I left straight from there, changed clothes at like Taco Bell, and my  
3 mom took me to work.

4 Pfeiffer: So you did not go back to your apartment?

5 Presley Huh-uh (negative) Not until like, not till I got off work.

6 Pfeiffer: What time, being what time?

7 Presley About 2:30 or 3.

8 Pfeiffer: In the morning?

9 Presley Uh-huh (affirmative)

10 Pfeiffer: Ok. So...it would have been the 28<sup>th</sup> of July, that would have been that  
11 Wednesday when you left the church, your mom took you to a Taco Bell?

12 Presley Uh-huh (affirmative)

13 Pfeiffer: Why a Taco Bell?

14 Presley Cause that's where we went to go eat.

15 Pfeiffer: So you ate? Ok. And what time were you suppose to be at work that night?

16 Presley 10:30.

17 Pfeiffer: 10:30?

18 Presley Uh-huh (affirmative)

19 Pfeiffer: And this is at UPS?

20 Presley Uh-huh (affirmative)

21 Pfeiffer: Ok. So you did not go back to the apartment?

22 Presley Huh-uh (negative)

23 Pfeiffer: Ok. Would you have called him from work? If he had paged you?

24 Presley Uh, I can't call him from work, well I probably could have, but it...

25 Pfeiffer: Is there a pay phone or a business phone?

26 Presley There's, their phones around, but I don't, I didn't call nobody that night, until I  
27 got home.

28 Pfeiffer: Do you recall...

29 Schindler: Having worked at UPS for 9 years while trying law school.

1 Presley You don't have time.

2 Schindler: You don't have time.

3 Pfeiffer: No, I bet you don't. I bet it is a busy place. Ok. Do you remember saying  
4 uh...to Talitia that you recall Julius paging you that night after church and that you called him  
5 back? Do you recall any of that conversation?

6 Presley Huh-uh (negative). No. I just remember, I don't even remember, I didn't talk to  
7 anybody I don't think.

8 Pfeiffer: On that Wednesday night?

9 Presley Huh-uh (negative).

10 Pfeiffer: Would he (inaudible) for you to talk to him?

11 Presley Yeah probably, I probably would have called him back but I don't remember  
12 calling him back. Because I remember the next day, well I know when I got home from work  
13 that night, I paged, I had called him or paged him. And he called me back. And so, that  
14 Thursday afternoon he called me after I had woke up and, well he had called me that morning.  
15 But when I finally woke up I talked to him. I ask him where he was and he said, "I was over at  
16 Westside's brother's house."

17 Pfeiffer: And so this would have been Thursday morning?

18 Presley Yeah. So Wednesday night...

19 Pfeiffer: The 29<sup>th</sup>?

20 Presley Yes, on Wednesday night I guess that is where he is suppose to be. I don't  
21 remember talking to him that night.

22 Pfeiffer: Ok. So...so Thursday morning you spoke to him?

23 Schindler: No, he had called her Thursday morning but she was asleep. She called him after  
24 she got up.

25 Pfeiffer: Thank you, thank you. Ok, and so you called him back. And he said he had  
26 been at Westside's brother's...

27 Presley Apartment.

28 Pfeiffer: Apartment? Did he say who had been with him?

29 Presley Him and Westside and I guess his brother.

1 Pfeiffer: Ok, he say anything else?

2 Presley Not about that night, I think we just talked.

3 Pfeiffer: Ok. Ok. Bear with me while I review my notes here. I wish I could commit  
4 everything to memory but...it fades as, as you age. (laughs)

5 Schindler: Testify sister (inaudible).

6 Pfeiffer: There you go. Ok. Let's see.

7 Schindler: You're not nearly as old as I am, so...

8 Pfeiffer: Oh you never know.

9 Schindler: Oh no. That's a given. Hell I'm older than Dill.

10 Pfeiffer: Oh no.

11 Schindler: Quite a bit older than Dill.

12 Pfeiffer: Now that I do find hard to believe. (laughs)

13 Schindler: May 27<sup>th</sup>, 1950.

14 Pfeiffer: You are older than he is.

15 Schindler: I know.

16 Pfeiffer: Yeah, but not by quite a bit though!

17 Schindler: It's what, I think he's 46?

18 Pfeiffer: 47, 46, yeah.

19 Schindler: 46?

20 Pfeiffer: Yeah.

21 Schindler: He is about...

22 Pfeiffer: Just a baby. Let's see...ok. I ask you uh...when we were talking to you last time  
23 when you had met Westside or about, what time frame did Westside seem to come into Julius'  
24 circle of friends.

25 Presley Well after he got out of jail, I don't remember when.

26 Pfeiffer: Was it this year?

27 Presley Yeah.

28 Pfeiffer: Was it over the white Honda? Or something else?

29 Presley Yeah, after he went to jail for the white Honda. Yeah.

1 Pfeiffer: Did he say how he met Westside?  
2 Presley Huh-uh (negative) Well I ask him where he came from cause I had never heard  
3 him or talked to him and uh, I, it was just, (inaudible) hangs around somebody else so, I ask him  
4 and he said that , “Oh we went to school together, he use to play basketball at Marshall.” And  
5 he, he was a good friend.  
6 Pfeiffer: He said Westside was a good friend?  
7 Presley Uh-huh (affirmative)  
8 Pfeiffer: What you told me last time is...when he got out of jail Julius and Westside were  
9 buddies.  
10 Presley Uh-huh (affirmative)  
11 Pfeiffer: Is that how you recall it?  
12 Presley Yeah.  
13 Pfeiffer: Ok. Uh did he spend a lot of time with Westside?  
14 Presley Yeah, they were always together after that.  
15 Pfeiffer: Ok.  
16 Schindler: After the Honda incident?  
17 Presley Yeah.  
18 Pfeiffer: Ok. Ok...lets go back to the 30<sup>th</sup> and that would have been Friday. You said  
19 that...I guess you and Talitia had spoken, she talked about the news, she kind of said, “and that’s  
20 not right.” Then you’re watching the news, Julius calls you, you have the conversation, Talitia  
21 arrives at your apartment. Is that right?  
22 Presley Yeah.  
23 Pfeiffer: Ok. During this time you told me that he calls a few times while you’re at the  
24 apartment?  
25 Presley Uh-huh (affirmative)  
26 Pfeiffer: And he’s wanting you to do what?  
27 Presley He wanted me to come and see him. Well he wants to see me before he left.  
28 Pfeiffer: Ok.  
29

1 Presley : So he wants to know if he can come over there and I told him I was leaving.  
2 So...well at first he ask, he didn't, he didn't say he wants to come over, he just says he wants to  
3 see me. And like the first conversation and when he called back he was like, "Well I'm gonna  
4 come see you," you know, said, "I'm leaving." And it was like, "Well find out where you are  
5 going or whatever and, and call me back and let me know or, or I'll call you back in a few  
6 minutes." And so when he called back he, I told him that I was going to go ahead and leave with  
7 Talitia and they were gonna go to a ball game at 8 and so, we had to go back to our apartment  
8 cause she had to change clothes and everything. And so he was like, "well ask her to come,  
9 come by here." And I was like, "I live there and she know I wanted her to take me with, I didn't  
10 want to ask her and she was like, like I'm not gonna take you." And so I didn't ask and I didn't  
11 even plan on going on over there so...well I told him I was. But I didn't. I told her, you know,  
12 "lets just go ahead and go to your apartment, I'll just, next time he pages then I'll just tell him  
13 something." We came up there and didn't make it. So we went to Sonic and we were gonna  
14 get some drinks and then, she was like, "Now you realize Julius is suppose to leave and you  
15 might not see him again," you know I was like, "Yeah. I guess so." So then I just looked at her  
16 like, "are you gonna take me (inaudible)." "I'll go ahead and take you over there."

17 Pfeiffer: Where did he say to take...

18 Presley He...

19 Pfeiffer: You over there. Where's over there?

20 Presley It's a little bar, the apartments he was at. At the time he said they were called,  
21 "Pickwick" and I didn't know where they were. And so he was just like....they were off the  
22 highway, I guess over there off of May.

23 Pfeiffer: South May?

24 Presley Yeah. So and I don't know what street but... it was like, you know, over there by  
25 Outback and he was like giving me a description of how to get there and so, he told me how to  
26 get there from my brother's apartment and so we just went ahead and went the ways that he told  
27 us to go. And then when we got to, when we pulled up, I couldn't remember the apartment  
28 name, I just know it's like a name and so. I was like that's it, Pickwick" so then we pull in, went  
29 around and (inaudible) back,, cause he told us to just pull up in the back and he will be outside.

1 So we pulled around there and we were driving down the, driving towards the back, but we don't  
2 see him. So I said, "Well, he's not here, so let's just go ahead and go, cause I don't know which  
3 apartment he's in" And so we were about to leave when, it was a white guy sitting outside. He  
4 was on a cell phone and he said uh, he was like, "Who y'all looking for?" And he, well he  
5 hollered at us to come back. Cause we had passed him. And so when came back, he said, "Who  
6 you looking for?" I say, "Julius." And so he's like, "Ok, hold on just a second." So he gets on  
7 his cell phone and like a couple seconds later Julius is coming down some stairs. And so he  
8 comes out to the car and he just, give him a kiss or whatever and he told me, "Whenever I page  
9 you, call me back." And "I love you and I miss you." (inaudible) And so I said, "Well if I have  
10 any money I'll page you, I'll call you right back." And he was like, "Well ok." He was like,  
11 "If you haven any money?" And I say, "Yeah, if I have any change, like 35 cents to call you  
12 back I'm not gonna be by a phone, we'll probably be out and about tonight. So he reaches in his  
13 pocket gives me, pulls out a twenty and gave it...

14 Pfeiffer: A twenty?

15 Presley Uh-huh (affirmative). Gave me twenty dollars and was like, "Ok, now you don't  
16 have any excuse (inaudible) so call me back." And then pulled off and left.

17 Pfeiffer: Ok. Did you see somebody pull up behind you before you left?

18 Presley Yeah. Umm. A girl, white girl...

19 Pfeiffer: A white girl?

20 Presley Yeah.

21 Pfeiffer: What'd she look like?

22 Presley She was kind big and she had like brown hair, pulled back in a ponytail. That's  
23 all I remember.

24 Pfeiffer: Was somebody with her?

25 Presley Yeah, she had like, it looked like, it was a black guy that got out the passenger  
26 seat.

27 Pfeiffer: Uh-huh (affirmative)

28 Presley And it was like, I think some kids in the back seat and looked like there were  
29 doing laundry so like some baskets of clothes and stuff.

1 Pfeiffer: Uh-huh (affirmative)

2 Presley And so he pulled, he gets out of the car and he's like, "Ok, lets go." And so  
3 Julius, as soon as he says that Julius walked off and then he turned around and gave me a kiss  
4 and it was like, "Ok, I'll see ya later."

5 Pfeiffer: Talitia said, you can tell me if this your recollection. That you said, when the  
6 black guy got out of the car that pulled up behind you, at Pickwick Apartments, he said to Julius,  
7 "We gotta move."

8 Presley Yeah.

9 Pfeiffer: Is that what he said?

10 Presley Yeah.

11 Pfeiffer: We gotta move?

12 Presley Yeah.

13 Pfeiffer: Ok. Was it...

14 Presley I think, they were, yeah, I think it was, we gotta move or we gotta go, something  
15 like that.

16 Pfeiffer: So they were in back?

17 Presley Uh-huh (affirmative)

18 Pfeiffer: And when you drove off who did you see standing there talking?

19 Presley It was Julius, that black guy, the white guy that was sitting outside.

20 Pfeiffer: And what'd the white guy look like?

21 Presley He was kind of short, uh...baggy clothes...I can remember there's like a big T-  
22 shirt and some baggy jeans...

23 Schindler: (inaudible)

24 Presley Huh-uh (negative) I don't think so.

25 Schindler: What color's his hair?

26 Presley Uh...like brown.

27 Pfeiffer: Long, short?

28 Presley Short, it was like a short cut.

29 Pfeiffer: And how old do you think he was?

1 Presley Probably about 19, 20, (inaudible) maybe 18.

2 Pfeiffer: Can you describe the black guy that got out of the car?

3 Presley I don't know what he looked like. Tall, he was about a little taller than Julius.

4 And...

5 Schindler: Big build?

6 Presley Nah, he's kind of skinny.

7 Pfeiffer: Do you remember what he was wearing?

8 Presley Huh-uh (negative) uh, I think, I want to say like a plaid like shirt.

9 Pfeiffer: Uh-huh (affirmative)

10 Presley With like some white jeans.

11 Schindler: How old was he?

12 Presley He was probably about 20. About 20 (inaudible). 20, 21.

13 Pfeiffer: What about his hair?

14 Presley I can't remember. I think it was short though, like a short cut, but I don't

15 remember.

16 Pfeiffer: Ok. Ok. And did you have any more communication with Julius that night?

17 Presley Huh-uh (negative). When he paged me, he just put I love you and I miss you.

18 Pfeiffer: Is that in code?

19 Presley Yeah.

20 Pfeiffer: And he paged you and put I love you, I miss you. And how did you know it was

21 him paging you?

22 Presley Cause he is the only one that knows the code.

23 Pfeiffer: Oh I see. You have your own special code? Ok. Ok, then what did you do

24 after you left there?

25 Presley We left we went (inaudible) apartment, she changed clothes, we went out to eat

26 and...after we ate we went to her dad's house hmm, and I called her brother's and sister's

27 (inaudible) and their friends were all around watching the news. And (inaudible) they had, they

28 were playing Nintendo and then you know, the small screen, they had the news on it and that

29 was kind of odd. And we was like, "Why are you all watching the news?" And they were like,



1 “They just said Julius killed somebody,” and so all the little kids run up to me at the door,  
2 “you’re boyfriend killed somebody,” you know, I was like, “No, no he didn’t.” And so I go in  
3 and they were like, uh, “They said Julius did it? Are you sure?” And they were like, “Yeah,  
4 they showed his picture.” And I looked at Talitia and we were like, “Whoa, you know, way.”  
5 And so uh, about that time they had flipped on the channel and they, they went back and Julius’  
6 picture came up and Julius Jones, talking about he murdered somebody in Edmond. So I was  
7 like...you know, kind of shocked and everybody was like... “your boyfriend, you, you go with a  
8 murderer.” And I was like, “No, he didn’t do it. He told me he didn’t do it.” And so there was,  
9 they were like, “Well you know the police are gonna come looking for you,” and I was like...  
10 “Whatever, they’re not, they’ll, they’re not gonna come looking for me.” And so we, my little  
11 brother called over to her, her dad’s house.

12 Pfeiffer: And who’s your little brother?

13 Presley: Mark. He’s like 11 and so he called over there, he was like, “Are y’all watching  
14 the news?” And he was like, “Man, Julius is on TV,” and so they were like, “yeah, your sister’s  
15 over here.” He’s like, “Put her on the phone.” So we get on the phone and he’s like, “Yeah, they  
16 just said Julius killed somebody.” And he was like, “Man,” he was like shocked. And I was  
17 like, “Well he told me he didn’t do it Mark,” and he was like, “Man, Julius can’t kill nobody.”  
18 And I was like, “Well you know that’s what we think,” and so he was, I was like, “Well did  
19 Momma see it and Daddy,” and he was like, “Well Momma saw it.” And so uh, about that time  
20 she (inaudible) she got on the phone and she was like uh, “Chris called over here for you.”

21 Pfeiffer: Chris?

22 Presley: I guess Westside.

23 Pfeiffer: Westside called for you

24 Presley Yeah.

25 Pfeiffer: Ok.

26 Presley And I was like, Chris called me? I was like, “Are you sure?” And she was like,  
27 “Yeah, somebody named Chris called over here for you.” And I was like, “What’d they want?”  
28 She was like, “They didn’t say, they just said, tell (inaudible) please call.” And she was like, “I  
29 told ‘em you don’t stay here anymore.” And so I was like, “So why would he call over there?”

1 Schindler: Did Chris ever call you before?

2 Presley Huh-uh (negative) I didn't even know he knew my Mom's number. If that was  
3 the Chris. I'm assuming that that was him.

4 Pfeiffer: Ok, but it was just a Chris, so you're Mom didn't know for sure?

5 Presley She didn't know who it was and so...

6 Pfeiffer: About what time was that?

7 Presley Uh, I talked to my mom about 10 so, and I ask her what time he called and she  
8 was like earlier, "I guess about 8 or 9 or something."

9 Pfeiffer: Ok. No, it wouldn't have been Chris Jordan then. He was in custody at that  
10 time.

11 Schindler: Already had him. (Laughs).

12 Presley I don't know. I don't know if it was 8 or 9 though. I don't know what time he  
13 called.

14 Pfeiffer: Ok.

15 Presley So...and then she goes, "Are you ok?" " I was like, "yeah, I'm fine." She's like,  
16 "Ok," and so uh, I just got off the phone with her cause we started taling about some other stuff  
17 and Talitia's ready to go. Cause we was suppose to go to some movies that night.  
18 So...(inaudible), "we fixing to go, so I'm gonna call you later." And she was like, "Ok." So we  
19 left and we went back to her apartment. She changed clothes and then I laid down and cause we  
20 were suppose to meet uh, my friend Myesha, cause she had like (inaudible) s'pose to be  
21 watching movies and...

22 Pfeiffer: Myesha Moore?

23 Presley Uh-huh (affirmative)

24 Pfeiffer: Ok.

25 Presley So I was suppose to go to the movies, so I was calling her trying to find her and  
26 she wasn't at work. And uh, she wasn't at home. So we were like, "Well, you know, we can't  
27 find her so what are we gonna do?" Talitia still wants to go to the movie so we went ahead and  
28 that when (inaudible).

29 Pfeiffer: About what time was this that you went to the movies?

1 Presley About 12.

2 Pfeiffer: Ok. And did you go eat anywhere that night?

3 Presley Yeah, we went to Ted's.

4 Pfeiffer: What time?

5 Presley Oh it was about 8, 8:30.

6 Pfeiffer: Ok. P.M.?

7 Presley Uh-huh (affirmative)

8 Pfeiffer: It was that night on Friday the 30<sup>th</sup>?

9 Presley Uh-huh (affirmative)

10 Pfeiffer: Ok. And in between leaving the Pickwick Apartments uh...and going back to  
11 Talitia's apartment, when did you go to Ted's?

12 Presley Uh, after we left her apartment.

13 Pfeiffer: So you left South Side, went to her apartment, then went to Ted's and went to  
14 her...

15 Presley Dad's house.

16 Pfeiffer: Dad's house. Then went to?

17 Presley Back to her house. Her apartment and then she like, I think she did her hair or  
18 something and went to the movies. (inaudible)

19 Pfeiffer: Ok. Hmm...

20 Schindler: You just like my daughters.(inaudible)

21 Pfeiffer: A lot driving involved. Ok. Let me go back when you were at the Pickwick  
22 Apartments cause I neglected to ask you about when that car pulled up behind you, what kind of  
23 car, did you...

24 Presley It was like a light tan, brownish color I think.

25 Pfeiffer: Ok. Was it a big car, little car?

26 Presley It was like a, a newer Cadillac I think. That's what it looked like to me. But I  
27 don't know cars so...

28 Pfeiffer: Was it a 2 door or 4 door or could you tell?

29 Presley 4 door.

1 Pfeiffer: 4 door? Ok. Ok and you think it was what color?  
2 Presley Like a light tan or brownish color.  
3 Pfeiffer: But a light colored car?  
4 Presley Uh-huh (affirmative)  
5 Pfeiffer: Ok. Hmm, let's see. Last time we spoke to you, you said that about a week  
6 before Julius was arrested this last time....  
7 Presley Uh-huh (affirmative)  
8 Pfeiffer: That he had called you and told you something about a Lexus vehicle. He had.  
9 Presley Yeah.  
10 Pfeiffer: Tell me about that.  
11 Presley He called and said and uh, "I have this Lexus uh, I think you'd be cute in it. You  
12 know you can drive around." I was like, "Ok, you know, where'd you get this from?" And he  
13 was like, "Oh me and Westside got it." And so I ask (inaudible), ok, I just sit, you know, like  
14 mad at him, cause I told him, I was like you know, "You're trying to be a little thug and you're  
15 not so... you need to quit, you know, hanging around Westside so uh..." He was like, he's, I  
16 guess, I guess...they had supposedly had "jacked it" or something. I don't know. He just told me  
17 that he had it. And so he was like, "Yeah so you can drive around a Lexus and everything and  
18 that way you won't have to depend on your brother." I was like, I got upset and I think I started  
19 cussing around but, and I was like, "And I told you if you gonna be doing stuff like I don't have  
20 time for you. You know if you want to live like that go ahead, you know, but I don't want to be  
21 around you." So, I, I think I hung up and then he called back. He's like, "Man, I'm just  
22 playing, I'm just playing, I don't have a Lexus." And so then I was like, "Don't play like that  
23 cause you're not all like that." And so (inaudible) he was like, "You don't want to take this  
24 Lexus somewhere." And I was like, "I thought you said you didn't have a Lexus." And then he  
25 just kind of avoided the question and he tried to change the subject.  
26 Pfeiffer: Did he say where he was gonna take it?  
27 Presley No. I don't think so, I think, or to Texas I think.  
28 Pfeiffer: Do you remember telling Detective Fike and I that he said he was gonna take the  
29 Lexus to Dallas and sell it?

1 Presley Yeah. Texas. Yeah, yeah I guess it was Dallas.

2 Pfeiffer: And sell it in Dallas?

3 Presley Uh-huh (affirmative)

4 Pfeiffer: And he told you what color it was...what color did he tell you?

5 Presley White Lexus, he said it was a white Lexus.

6 Pfeiffer: Did he say where that he'd gotten it from, where they had stolen it from?

7 Presley Huh-uh (negative)

8 Pfeiffer: He didn't say? But he said that he and Westside had gotten it?

9 Presley Uh-huh (affirmative)

10 Pfeiffer: Ok. Had he ever talked about taking other cars somewhere to sell?

11 Presley Huh-uh (negative)

12 Pfeiffer: Just this Lexus?

13 Presley Yeah.

14 Pfeiffer: You told us what he told you about the white Honda that he was arrested out of,  
15 tell me about that.

16 Presley Uh...well he told me, well, I found out later what really happened but, he said that  
17 uh, Isaiah had found a car, or Isaiah got a car and they found it at the mall. Because the found  
18 some keys at the mall and so they picked up the keys and they went, over and it had an alarm on  
19 it. So they went around pushing the button in the parking lot in the area trying to find out which  
20 car it was. So they were I guess, gonna go, go ahead and take it. So they finally found it.  
21 Isaiah, put some rims on it and washed and was driving around that day and that night. And  
22 then that weekend I think and they, they put like uh, a radio, a system in there and uh, I think  
23 Isaiah was suppose to have sold it to Julius. And so Julius I guess bought it or whatever, I guess  
24 that's why Isaiah and Julius were upset with each other. Because Julius said that it was stolen,  
25 but Isaiah was, had told him that it wasn't. (inaudible) yeah so he said that they, he owed him  
26 some money, because it was his, I think Julius' rims that they had put on there. And so Isaiah  
27 like sold him I guess the radio system or whatever they had put in there. Like the, the speakers  
28 and everything. And Julius was like, Julius had it and so he came and showed it to me and  
29 everything. And so I later on found out that this girl I work with, well somehow at work we was

1 talking about a white Honda. And she was like, “Man, there’s this white Honda, it’s so tight, and  
2 I was suppose to have it,” and she saw, I think he came through to see me and she saw it. And  
3 she was like, you know, “that’s nice,” and she ask about it and uh, I was like, “I don’t know  
4 where he got it from.” So she uh, cause I didn’t know her and I didn’t know...

5 Pfeiffer: Uh-huh (affirmative)

6 Presley Enough, I was like, “I don’t know where he got it from.” So she said, “Well, my  
7 boyfriend had a white Honda and he was gonna give it to me but he got mad and threw the keys  
8 at Cross Roads Mall. And then she was like, and so now I don’t have that car and so I was like,  
9 “They stole it.” And she said, “Yes,” I talked to Julius about it and he was like, “Nah, they, they  
10 said that they had bought it, they found out who they was and they got it from that guy. And  
11 they sold it to me. I was like, Oh ok so...Then he goes to jail for it. And so he gets upset out  
12 of his head cause Isaiah, because it was Isaiah’s fault, he felt like Isaiah should have came and  
13 got him out and Isaiah didn’t. And Isaiah act like he didn’t care that Julius was in jail so that,  
14 you know, he just quit hanging around Isaiah. So...

15 Pfeiffer: This is the same Isaiah that I guess he and Julius are having some problems?

16 Presley Yeah.

17 Pfeiffer: Ok. Do you know if his name is Isaiah Smith?

18 Presley (inaudible)

19 Pfeiffer: And who was the girl that was talking about the white Honda to you at work?

20 Presley Goes by name Chalitta

21 Pfeiffer: Chalitta? How would you spell that?

22 Presley C H A L I T T A

23 Pfeiffer: And this is at work where?

24 Presley In Taco Bell. This was like a while ago though. I don’t think she still work  
25 there.

26 Pfeiffer: Ok. Which Taco Bell is that?

27 Presley 122<sup>nd</sup> and Penn.

28 Pfeiffer: And she worked there and you worked there?

29 Presley Uh-huh (affirmative)

1 Pfeiffer: How long did you work there?

2 Presley I worked there for 2 years.

3 Pfeiffer: In when, or when to when?

4 Presley From '97, from February '97 to February '99.

5 Pfeiffer: Ok. So I guess Julius on this white Honda had given you several different  
6 stories.

7 Presley Uh, yeah.

8 Pfeiffer: Ok. And you said, last time we spoke, that Julius had started talking about a guy  
9 named Day Day?

10 Presley Uh-huh (affirmative)

11 Pfeiffer: Tell me about that.

12 Presley Out, he was, well he was hanging around Westside and so, if he wasn't with me  
13 he was with Westside. Or if he wasn't with Westside he was at his mom's house asleep. That's  
14 how, so hmm, one, I just have to believe he's gonna talk about his homeboy Day Day, they  
15 bought this car from Day Day and, and he's cool and I'm gonna meet him one day, you know.  
16 It's like ok.

17 Pfeiffer: You were gonna meet him one day?

18 Presley Yeah.

19 Pfeiffer: Ok. What else did he say about Day Day?

20 Presley Uh, that, I don't even remember that he's like 20 something years old and I think  
21 he was suppose to be a blood. And that he was...I guess somebody, they had gone to school  
22 with or something like that. I don't remember but he was just, a, a cool friend.

23 Pfeiffer: Did he say anything about Day Day getting him some rims?

24 Presley I don't know if he, I think so, either some rims, no he sold him the Cutlass. And  
25 I think later on he's suppose to get some rims from him or something like that.

26 Pfeiffer: Ok.

27 Schindler: Far reaching implications here.

28 Pfeiffer: My little checks so I know where I'm at. You said that if Julius wasn't with you  
29 or Westside he was home asleep. At his mom's house.

1 Presley Uh-huh (affirmative)

2 Pfeiffer: Did Julius work anywhere?

3 Presley Uh, no. Not recently.

4 Pfeiffer: Had he ever worked anywhere to your knowledge?

5 Presley Uh-huh (affirmative)

6 Pfeiffer: Where did he work?

7 Presley He worked at Taco Bell in Norman.

8 Pfeiffer: How long?

9 Presley I don't know. Maybe a couple months.

10 Pfeiffer: Ok.

11 Presley And he worked at a Telemarketing job.

12 Pfeiffer: How long did he work there?

13 Presley I'd say a couple months. If that long.

14 Pfeiffer: Do you remember telling us last time that it was, you thought he worked there 2

15 days?

16 Presley I only know of him going in 2 days (inaudible).

17 Pfeiffer: Oh...ok.

18 (Laughing)

19 Pfeiffer: Ok, so he was on the books but he just wasn't working. Ok. Now we have that

20 straight. And you said that he would give you money and he'd given you money 30 to 50

21 times.

22 Presley (inaudible)

23 Pfeiffer: Do you remember telling, telling us that? Ok. Was that yes?

24 Presley Yes.

25 Pfeiffer: Ok. Uh and you said, "he always has money."

26 Presley Yeah he usually, well, he didn't always have money. Cause times when he ask

27 me for some money.

28 Pfeiffer: Ok.

29 Presley So...majority of the time he had money.



1 Pfeiffer: You know how he got his money?  
2 Presley Huh-uh (negative) Never ask him.  
3 Pfeiffer: Ok. Did his parents give him money?  
4 Presley I don't know.  
5 Pfeiffer: Ok. He told you he was gonna get the Honda flipped. That white Honda he had  
6 been driving. And you, you explained to both Detective Fike and I what flipped means. Can  
7 you explain that again?  
8 Presley Flipped...  
9 Schindler: Good, cause this is a new learning experience for me.  
10 Presley Flipped is uh, take it to like a chop shop and have them put different parts on it.  
11 Pfeiffer: To disguise where it came from perhaps?  
12 Presley I guess.  
13 Pfeiffer: But just take it to a chop shop...  
14 Presley Uh-huh (affirmative)  
15 Pfeiffer: Put different parts on it.  
16 Presley (inaudible)  
17 Pfeiffer: Ok. Ok.  
18 Schindler: Flipped.  
19 Pfeiffer: Flipped. Can you excuse me for just one second? Would you like any coffee or  
20 anything?  
21 Schindler: I'd love a cup of coffee.  
22 Pfeiffer: Anything in it?  
23 Schindler: No, just your finger while you're carrying it.  
24 Pfeiffer: Ok.  
25 Schindler: See that mirror window over there? We know there's somebody else watching.  
26 Presley Yeah.  
27 Schindler: Anytime, well you've been honest and up front with 'em. Which is all we can  
28 ask. This is uh, got quite a, people involved in it. And maybe, maybe he didn't do, maybe he's  
29 telling the truth.

1 Presley I hope so. He keeps telling me that.  
2 (End of Side A)  
3  
4 (Beginning of Side B)  
5 Pfeiffer: (inaudible) either so, you're in luck. Sometimes that coffee gets a little thick  
6 back there. Just don't know how long it's been sitting there.  
7 Schindler: It is warm.  
8 Pfeiffer: Kills all germs, even if I had stuck my finger in there.  
9 (Laughing)  
10 Schindler: They will not survive.  
11 Pfeiffer: That's right. Ok. Ok, when we were talking before you said something and I  
12 highlighted it here because I didn't quite understand it. And...you can explain it to me. You  
13 said, that when you went back to the apartment Myesha Moore, it says you went back to the  
14 apartment, she was talking on the phone. Did you go ask, when we talked about this earlier, did  
15 you call Myesha? Was that what I was writing down here? That you had called her?  
16 Presley Uh-huh (affirmative)  
17 Pfeiffer: From the apartment?  
18 Presley From my brother's or...  
19 Pfeiffer: She wasn't..  
20 Presley My brother's or...  
21 Pfeiffer: Where ever? I don't know...  
22 Presley Myesha's apartment I think we were calling trying to find her.  
23 Pfeiffer: Ok, but she wasn't at the apartment?  
24 Presley Huh-uh (negative) .  
25 Pfeiffer: Ok. Thank you for clearing that up for me. Uh...you said something about  
26 Corey King.  
27 Presley Uh-huh (affirmative)  
28 Pfeiffer: Ok. Tell me about that.  
29

1 Presley Torey was a friend, or a friend of mine. She had talked to this one guy, that she  
2 had met at the club.

3 Pfeiffer: This is which club?

4 Presley Mickey's.

5 Pfeiffer: Mickey's? Where's this club at?

6 Presley: On 10<sup>th</sup> and MacArthur.

7 Pfeiffer: 10<sup>th</sup> and MacArthur? North side? Ok. And...

8 Schindler: What in...you guys get around. Just amazing.

9 Pfeiffer: A lot of driving.

10 Schindler: (Inaudible)

11 Pfeiffer: You know unless it's in like a 10 block radius I'm not driving there. (laughing)

12 Schindler: I don't, but I've got a 19 and 21 year old daughters that if they come home with  
13 any gas at all, it's by mistake.

14 Pfeiffer: I understand. Kids like to drive these days. Go ahead.

15 Presley Uh, she had met him and he's says something about uh, he had talked to  
16 Dorsheta...

17 Pfeiffer: And Dorsheta is?

18 Presley Dorsheta's suppose to be pregnant by Julius.

19 Pfeiffer: Julius Jones?

20 Presley Yes.

21 Pfeiffer: Carrying his baby?

22 Presley Yes.

23 Pfeiffer: Ok.

24 Presley And so he said that apparently Julius had called her and told her uh, that it was an  
25 accident.

26 Pfeiffer: So Julius had called Dorsheta...

27 Presley Uh-huh (affirmative)

28 Pfeiffer: Ok. Do we know her last name?

29 Presley I think it was Freeman.

1 Pfeiffer: Freeman?

2 Presley I think somebody told me it was Freeman or something.

3 Pfeiffer: Ok. And...that...Julius had called her from jail?

4 Presley I guess. I think yeah, cause when I talked to him I ask him and he said, "Yeah, I  
5 called her when I got here."

6 Pfeiffer: So Julius told you that he called Dorsheta from jail?

7 Presley Uh-huh (affirmative)

8 Pfeiffer: Ok. So did you ask him about the comment? Or did you just, just ask him about  
9 calling Dorsheta?

10 Presley No, I just ask why he called Dorsheta.

11 Pfeiffer: And then what'd he say?

12 Presley He was like, "Man, I, who else, you running around and you always out," he was  
13 like, "I, want to find somebody, I'm here myself." So he was like, "I called her, she," I won't  
14 call, you know, some other girls that I don't like, so...he got (inaudible). Why? He was like,  
15 man, he's like so bored, there was no way (inaudible) in here. I just wanted to talk to somebody  
16 out there. So, ok, then I was like, uh...so the baby's, no, he was like, "the baby is suppose to be  
17 mine." He came out and told me and I was like, "yeah, I heard." And he was like, "Yeah, I just  
18 found out too," and I was like, "Uh, ok, so," that was, that was it.

19 Pfeiffer: Ok. So did he make any statements to you about the shooting being an accident?

20 Presley (inaudible). Yeah, I mean they weren't even there.

21 Pfeiffer: Ok. But this comment was attributed to Julius by this unknown black guy that  
22 Tory King had spoken to, that said, Dorsheta told him that.

23 Presley Uh-huh (affirmative)

24 Pfeiffer: I think I got that right. That, that was a long way around but I think I got that  
25 right. Ok.

26 Schindler: Boy, there'll be no hearsay problems will there?

27 Pfeiffer: Oh no. Not any whatsoever. So did you every ask Tory who that black guy  
28 was?

29 Presley Yeah.

1 Pfeiffer: And what'd she tell you?  
2 Presley (inaudible) Tim or Ted, something like that.  
3 Pfeiffer: And how did she know him or see him or talk to him?  
4 Presley She uh, met him at the club and he got her pager number.  
5 Pfeiffer: Ted or Tim?  
6 Presley Yeah.  
7 Pfeiffer: And does she know him any other way?  
8 Presley Huh-uh (negative)  
9 Pfeiffer: Ok. How long have you been dating Julius?  
10 Presley Since September.  
11 Pfeiffer: Of?  
12 Presley Of last year.  
13 Pfeiffer: '98?  
14 Schindler: '98.  
15 Pfeiffer: Ok. Gone over everything except when we made contact with you that early  
16 Saturday morning. Ok, we found you where?  
17 Presley At Talesha's.  
18 Pfeiffer: At Talesha Watson's apartment?  
19 Presley Uh-huh (affirmative)  
20 Pfeiffer: North side?  
21 Presley Uh-huh (affirmative)  
22 Pfeiffer: What apartments are those?  
23 Presley Hed- uh, Heritage, Heritage Apartments.  
24 Pfeiffer: Ok. About 122<sup>nd</sup> and Penn?  
25 Presley Uh-huh (affirmative)  
26 Pfeiffer: Ok. Uh...I did not go into the apartment that night, I was there, but I did not see  
27 you initially. Some detectives came to your door and tell me what happened?  
28 Presley They just came in and ask, "Where is he?" And I was like, "He's not here." And  
29 they were like, they just came in, they, they (inaudible) went through the house and everything or

1 went through her apartment. And I just sat down on the couch and they ask me, “Well where’s  
2 he at?” I don’t know, I don’t know and they were like, “if you’re lying on this you’re gonna go  
3 to jail for 3 years and there’s a, there’s a reward for his arrest. Don’t you know that? It’s like  
4 \$33,000.00 and if you tell us where you think, you can get this money and you can buy your  
5 brother and that sweet little girl we just saw, you can buy her a house and get them out that  
6 apartment.” And I was like, “I don’t know where he’s at though.” And they was like, they were  
7 sitting in there like, “do you realize how serious this is? We need to find him.” I was like,  
8 “Yeah, but I don’t know where he’s at.”

9 Pfeiffer: Ok, then those officers left and then there was 2 officers left at the apartment  
10 talking with you.

11 Presley Uh-huh (affirmative)

12 Pfeiffer: And then you finally told them something else.

13 Presley Oh well I did meet, they ask if I had saw him. And I said, I said, “Well yeah, I  
14 did see him and I told them where and so about that time they were like, “Ok, well you all put  
15 your shoes on cause you are coming with us you know, You’re gonna show us where the  
16 apartment is.” And I was like, “Ok, fine.” So we put our shoes on and she locked the door and  
17 then we followed them out to like the outside of the apartment. By the time I got out there,  
18 there’s, I think I saw you out there.

19 Pfeiffer: That’s where I was.

20 Presley And they were just waiting around. They said that they couldn’t find, they said  
21 they were having, they were already there. That the...

22 Pfeiffer: The other officers?

23 Presley Yeah. But they didn’t know which apartment it was. So I just gave ‘em the same  
24 directions that Julius had given me and so uh, they, they went on, went in there I guess and found  
25 him there.

26 Pfeiffer: Ok. Can you think of anything else that I haven’t ask you that you think might  
27 be important?

28 Presley I don’t know.

29 Pfeiffer: Has Julius called you since we talked to you? On the 5<sup>th</sup>.

1 Presley: Huh-uh (negative)  
2 Pfeiffer: Did he stop calling you from jail?  
3 Presley Well I think he called last night, but, or not last night, but Saturday night. But I  
4 wasn't there so....  
5 Pfeiffer: Did anyone answer the phone? Or was it just on the Caller I.D.?  
6 Presley On Caller I.D.  
7 Pfeiffer: How does it come up on the Caller I.D.?  
8 Presley Uh, well it was his sister's, sister's phone number. Oh from his mother's house.  
9 Schindler: Julius has come up with a idea to circumvent the system, so...  
10 Pfeiffer: Is it the 3-way calling?  
11 Schindler: Yeah. That doesn't uh, happen.  
12 Pfeiffer: I see, ok so he calls somebody and then they 3-way to somebody else?  
13 Presley So somebody have to pay for the collect call.  
14 Pfeiffer: Ok. How much are those collect calls these days?  
15 Presley I don't know.  
16 Schindler: I can tell you what they are from the Davis Correctional Center or the Granite...  
17 Pfeiffer: How much are they?  
18 Schindler: Davis Correctional Center are \$6.98 for 5 minutes.  
19 Pfeiffer: Wow.  
20 Schindler: Yeah.  
21 Pfeiffer: That's kind of pricey.  
22 Schindler: Home away from home, bill America.  
23 Pfeiffer: Ok. Well that's all I have. Chuck, do you have anything?  
24 Schindler: No. Just that uh, the misunderstanding about possible misinformation Alisha,  
25 Alish thought...he was leaving. That Julius...  
26 Pfeiffer: Had left where he was.  
27 Schindler: Was going. As in, Dallas or out of state. Get the hell out of here. Because he  
28 was hot. But nobody ask, have you seen him today but he said, where is he? Until later.  
29

1 Pfeiffer: And, and I do not know if that's exactly how it transpired because I was not there  
2 initially. From my understanding, from what was related to me, they had ask both girls if they  
3 had seen him that day. And the answer had been no. Talitia Watson, when she came in, said,  
4 yeah she was afraid and she didn't want to get involved and she didn't want his homies coming,  
5 shooting at her for saying that she had seen him.

6 Schindler: Now we have a little bit of trouble on that thing, maybe you need to relay to her  
7 about uh,...

8 Pfeiffer: Just along those lines, they had said that they had ask both girls that.  
9 Go ahead.

10 Presley Uh, like ok, well that Friday...

11 Pfeiffer: Ok, which Friday?

12 Presley That Friday when I went to go see him. He had ask me (inaudible), he ask me if  
13 I'd go get his car out of the shop. He had...

14 Pfeiffer: Which car?

15 Presley I don't know, I think it was the black Honda he has.

16 Pfeiffer: A black Honda?

17 Presley Uh-huh (affirmative)

18 Pfeiffer: You think...

19 Presley I don't know...

20 Pfeiffer: It's an older car, newer car?

21 Presley Like maybe a '93 or something like that. I don't know. But uh, he had this car in  
22 the shop and he, he was always telling me, "you ought to go look at my car (inaudible)." And  
23 you know then I'll have, I'll go ahead and resale it or something like that or I don't know. He  
24 was gonna have this extra car. And so I could use it if I ever needed to.

25 Pfeiffer: Ok.

26 Presley And so apparently my name was on a list or something where I could get his car  
27 out if I needed to. So uh, he had ask me Friday, "are you sure your gonna go to my car in the  
28 morning?" And I was like, "No. I don't know, I don't plan on trying to get your car out." He  
29 was like, "Oh ok." So...



1 Schindler: Where was the car at?  
2 Presley Some, some shop at, on the South Side of town. I don't know..  
3 Pfeiffer: What kind of shop?  
4 Presley I don't know.  
5 Pfeiffer: Did he say where it was?  
6 Presley It was getting fixed on.  
7 Pfeiffer: Did he tell you where it was and you forgotten?  
8 Presley He had never told me where it was, he just said on the South Side.  
9 Pfeiffer: So he was just asking you, "Are you gonna go get it?"  
10 Presley Yeah. (inaudible)  
11 Pfeiffer: (inaudible)  
12 Presley He was aiming to go get it and get it for him I guess.  
13 Pfeiffer: How would he take you to go get it?  
14 Presley I don't know how he expected me to get it. But he had ask me to go get it.  
15 Pfeiffer: Ok.  
16 Presley Help him out. And before....like....whenever, cause what happened, I guess it  
17 was in the shop, and his dad was suppose to be using some money from uh, an accident he was  
18 in, so his dad was gonna give him the money to go get the car out the shop. So he was waiting  
19 on the money so he go get it. And so whenever he was suppose to go get it, I was suppose to go  
20 with him and I was suppose to, cause apparently he was gonna drive the Cutlass and so he would  
21 need me to drive that car, the Honda. So I would go with him whenever he wants to go get it but  
22 we never got around to it. And so, and then finally he started like calling to check on it and  
23 apparently it was uh, fixed and it was ready. And so that's how we were gonna go out of town  
24 that weekend. Because he was gonna go get it out the shop, that night after I got off of work I  
25 guess. And I guess we were gonna leave in that. But uh...Saturday I got a phone call from  
26 Laymon I guess it was Somebody paged me and they put in Julius' code. And so I was like, I  
27 was trying to figure out who this was and why they're paging me, why is his code on my pager,  
28 when I know he's in jail. So hmm, I was scared to call back and I wasn't, but then I was like,  
29

1 curious of who it was. So I had her drive me to a pay phone, went to the pay phone and I called  
2 back.

3 Pfeiffer: Who drove you to the pay phone?

4 Presley Talitia, cause I was still over at her house.

5 Pfeiffer: Ok.

6 Presley And so it was, I guess Laymon I guess. I can't, Westside's brother I think. And  
7 he said, "Did you go get the car yet?" And I was like, "No, cause I don't know where the car is  
8 at." And he was like, "Oh well Julius uh, left your pager number said that you would go get the  
9 car." And i was like, "Well I don't know where it's at, and so if you want to find out where it's  
10 at I guess I'll go get it." And then they were like, "Ok." And then he said, well uh, or he was  
11 like, "Ok well just keep in touch with me, and, and let me know if everything is ok." And I was  
12 like, "Ok, fine." So he was like real cool about everything. And the next day, Sunday, I got  
13 another page, but like 3 or 4 pages from this number and...

14 Pfeiffer: What number was that?

15 Presley Laymon's number, I don't know it.

16 Pfeiffer: But it was a number you recognized coming up on your Caller I.D. as Laymon's  
17 number?

18 Presley Uh-huh (affirmative)

19 Pfeiffer: From where Julius had called you that night?

20 Presley Yeah.

21 Pfeiffer: Ok.

22 Presley So uh, so, because I thought everything was fine, Talitia didn't want to make a  
23 call from her house. Because she didn't know, she doesn't like Westside. And she doesn't trust  
24 him and I don't either so...I don't know what his family is capable of doing or anything, so she  
25 didn't want me to. But because he sounded like everything was ok Saturday I went ahead and  
26 called form her apartment. So I called back....this guy was on one phone and one was, like I  
27 said they were on two phones, and they were both listening to me. One was on one phone and  
28 the other one I guess was maybe on a speaker phone in the other room. And so, he was like,  
29 "hello." He was like, sound like like he was like....he was in a hurry to do something.. He needs

1 to hurry up and get his car. He was like, uh...Pocohontas I really need you to look at this car.  
2 Uh, there's something in the car that's gonna help Westside and Julius, get them out of jail. We  
3 really need to get this car. And I was like, "I don't know where his car is at." And he was like,  
4 "yes, you do Julius," and he started like raising his voice and getting upset with him.

5 Pfeiffer: What day is this?

6 Presley This is Sunday.

7 Pfeiffer: Ok.

8 Presley And so he was like, "Yes you do know where the car is at. Julius told me you  
9 know where the car is and Julius said you would go get the car." And I was like, "Well I don't  
10 know where the car is at, I don't know why he told you that." I was like, "I don't know, all I kn  
11 ow is it's at a car shop on the South Side of town. And so uh, he, just was getting real upset.  
12 And so he started calling me a bitches and, "I think this bitch got the car and I think she's driving  
13 it, and she just doesn't want to tell us. She doesn't realize how important it is for us to get this  
14 quiet."

15 Pfeiffer: So one voice you identified as Laymon.

16 Presley Uh-huh (affirmative)

17 Pfeiffer: Who said he was Laymon the day before.

18 Presley Yeah.

19 Pfeiffer: And the other voice...

20 Presley Was his, I guess his cousin. That's who he said he was.

21 Schindler: Which was that cousin's name?

22 Presley I don't know.

23 Schindler: I thought this would be important but I thought, almost be confusing as hell and  
24 just add to the list, to the things...

25 Pfeiffer: There you go.

26 Presley I don't know his name, well he said it, but I really wasn't, I didn't remember it.  
27 And so, uh....he was, we were like on the hpne and it was...

28 Schindler: Help her a little bit on, do you have any idea on what type of car it was?

29 Presley It's a black Honda.

1 Schindler: About a '93 black Honda?  
2 Presley Yeah.  
3 Pfeiffer: And why do you think it was that?  
4 Presley Because he had, well he...he usually have like a, a tan Honda, but he sold it and he  
5 got this black Honda. But he had sold it, this black Honda to somebody else and I guess bought  
6 it back from them. So I'm assuming that's the same black Honda.  
7 Pfeiffer: But you never saw the car?  
8 Presley Huh-uh (negative)  
9 Pfeiffer: Ok.  
10 Presley I never saw it. So he just (inaudible).  
11 Pfeiffer: And was that Laymon or the cousin?  
12 Presley The cousin. Cause Laymon said, he was like, "Man, she says she doesn't know  
13 where the car is at." So he was like, "Tell, get on the phone and say what Julius told you," so  
14 Laymon gets on the phone," He was like, "Julius told me that you know where the car is at and  
15 you're suppose to go get it." So now he's got an attitude and I was like, "You know, I don't  
16 have time for either one of y'all," I mean, I said, "I don't know where your car is at and if you  
17 want it you're gonna have to find without me." I was like, "But I don't have time," and they  
18 kept on calling me (inaudible) and I was like, "Alright," and I just hung up the phone. And so  
19 they kept paging me, I think they paged me like twice. after that (inaudible). I didn't call 'em

2 he's scared of them but he was like... "If you see Westside and his family, they got me messed  
3 up and all and they can't be doing you like that."

4 Pfeiffer: Did he ever tell you where the car was?

5 Presley Huh-uh (negative) He just told me it was at a shop on the South Side.

6 Pfeiffer: I mean when you were talking to him on Monday.

7 Presley Oh...Huh-uh (negative) All he said, "Don't worry about it." And he was like, he  
8 started laughing. He was like, "Oh, don't worry about it man. (inaudible)" And so I was like,  
9 "You know you need to find out and let them know that, cause I don't want them finding me and  
10 trying to mess with me every five minutes." So that was basically about it. So...but...

11 Pfeiffer: Have you other problems?

12 Presley Huh-uh (negative) not since then. So, they were kinda scary, cause they were  
13 like, "Well we're gonna come and get you." Cause they first off, "Well I don't have any  
14 transportation (inaudible) out of town anyway." And they were like, "We'll come and get you."  
15 And I was like, "Well that doesn't, that doesn't mean anything if you come and get me I still  
16 don't know where his... (inaudible), so what we gonna do drive around the South Side of town  
17 and go...and so friends of mine were like "Well maybe they were gonna make you get in the car  
18 with them and think maybe, they were like, "We just need to talk to you in person." And I was  
19 like, "No, you can talk to me over the phone. I don't want to talk to your person." And they

25 they just started tripping, "Do you know where the car is at?" (inaudible) and I just hung up...

26 Pfeiffer: When you say "tripping" what do you mean by that?

27 Presley Like cussing at me and raising their voices and I don't know them and so,  
28 disrespecting me, calling me bitches and everything.

29

1 Pfeiffer: That reminds me of something. Talitia said that you had told her that Julius has  
2 been “tripping” on you.

3 Presley Well no, he was just, he didn’t like me going out so much. He wanted me to be  
4 with him. Spend time with him and you know just...not go out with my friends that much. And  
5 so I was like...I don’t know, cause I,I just graduated I’m trying to...have fun and he was like,  
6 “Well no, you need to settle down and, and there’s nothing out there for you. And I love you,”  
7 and he wants, to start a family and wants to move in together and I...and so I was like, “No way.”  
8 So...

9 Pfeiffer: I can understand that. Did she...warn you about him?

10 Presley She was like, “He might be crazy, you might need to leave him alone.” Cause...

11 Pfeiffer: And this is because of the incident you described with him throwing things  
12 around in the car?

13 Presley Uh, yeah he threw something in the car, yeah. Cause he got upset. Cause I  
14 wanted to leave from...at the club. So he just, “Hey man you know I love you, why are you  
15 doing this to me, it’s my birthday and I just want to kick it with you on my birthday.” And I was  
16 like, “Well if you supposedly calling your ex-girlfriend, trying to talk to them go call them and

18 Pfeiffer: And his ex-girlfriend?

19 Presley His ex-girlfriend is Robin.

20 Pfeiffer: Robin?

21 Presley Thompson.

22 Pfeiffer: Is this the one from High School?

23 Presley Uh-huh (affirmative) Yes. And uh, he’s (inaudible), “Man you know I love you,  
24 you, I don’t know why you’re doing this.” I think...

25 Pfeiffer: And when was this?

26 Presley I don’t know when. Like the weekend before the 30<sup>th</sup>, like the 23<sup>rd</sup> or something  
27 like that.

28 Pfeiffer: Of July?

29 Presley Uh-huh (affirmative)

1 Pfeiffer: Ok. Anything else?  
2 Presley No.  
3 Pfeiffer: Ok. I appreciate you coming in. I really do. See it was pretty painless.  
4 Presley Yeah.  
5 (inaudible)  
6 Pfeiffer: I didn't mean for it to. Thanks guys, I do appreciate it.  
7 Schindler: No problem.  
8 Pfeiffer: I hope you find your way out through the maze.

4 Pfeiffer: And if you want you can call him Day Day so it doesn't confuse you, is that what  
5 you call him?

6 Owens: Yeah, Day Day, that's what I, when I first met, I never heard anything else but...

7 Pfeiffer: But Day Day. Ok. And that's fine. Ok. So Vickson is Day Day's girlfriend?

8 Owens: Right.

9 Pfeiffer: And they live in apartment...

10 Owens: I don't even know the number. But it's below and hers is 408.

11 Pfeiffer: Below Maria's?

12 Owens: Right.

13 Pfeiffer: And Maria is your girlfriend?

14 Owens: Right.

15 Pfeiffer: Ok. And she lives there with you at your sister's apartment?

16 Owens: No, she lives...

17 Pfeiffer: Oh...

18 Owens: She lives with her father. At, at the uh, at 408. I, I live with my sister.

19 Pfeiffer: Oh I'm sorry. I misunderstood, I apologize. Ok, go ahead and start with  
20 uh...Wednesday and that would have been July the 28<sup>th</sup> of 1999.

21 Owens: Alright.

22 Pfeiffer: That was the day a man in Edmond was murdered and his suburban was stolen.

23 Owens: Right.

24 Pfeiffer: And we talked about that. You said you saw Julius Jones and a black male  
25 known to you as Westside?

26 Owens: Right.

27 Pfeiffer: And that would have been...on that Wednesday, which was July the 28<sup>th</sup>, and you  
28 saw them at 2 P.M.

29 Owens: Yeah, between about 2 and 3. Right.

1 Pfeiffer: Ok. Tell me what you saw.

2 Owens: Ok. I saw...when they uh...let me see...about 2 on Wednesday...uh...trying to  
3 remember...there was something else I wanted to tell you. Uh, it slipped my mind while I was  
4 listening to you. Uh...It will come back to me. Uh...

5 Pfeiffer: I don't feel so bad that I do that now. (Laughs)

6 Owens: Oh man I can...I can be looking at something and set it down and then forget all  
7 about it. Uh...Oh I know what it was. Uh... he said that uh, Dell, Day Day said that  
8 uh...uh...that they were trying to sell the truck.

9 Pfeiffer: And who's they?

10 Owens: That uh, Julius and I guess Westside, he just, that's what he came told me, they  
11 was trying to sell it. And he wanted to know if I knew anybody that wanted to buy a suburban  
12 and I was like...you know...so he...

13 Pfeiffer: So you told him no?

14 Owens: And I was like, "No, I don't know nobody." So I mean, I don't, I not even really  
15 from here it's been a year since I been here. So I don't know anybody and see at the time we  
16 didn't know the truck was stolen.

17 Pfeiffer: And what day was that he ask you that?

18 Owens: That was uh...the same night, no, it was Thursday. That's what I remembered  
19 about Thursday, that's when I saw him, cause I was leaving to go visit Mom and he said, "Man,  
20 they uh, they had a (inaudible) suburban man," (inaudible) I looked out, I mean I didn't really  
21 check it out of nothing, but i saw it sitting out there. He said now, "Man, he's trying to sell  
22 it.man uh, you know anybody that wanna buy a suburban man?" You know, "let me k now or  
23 leave a message." And I was like, "Ok."

24 Pfeiffer: And that was Thursday about what time?

25 Owens: Uh, it was about 2:30 cause i was on my way to see my Uncle, He's, he's there at  
26 3.

27 Pfeiffer: In the afternoon, 2;30 in the afternoon?

28 Owens: Afternoon.

29 Pfeiffer: Ok.

1 Owens: Right.

2 Pfeiffer: And going back to Wednesday, ok, you said, between 2 and 3.

3 Owens: Uh-huh (affirmative) Then we were uh...they were standing outside.

4 Pfeiffer: And who's they?

5 Owens: There was Julius, Westside and Day Day. And they were laughing and talking.

6 Ok, uh...Lets see what else is they, there's something else. What I remember them doing was,

7 they was laughing and talking. Westside, I mean Julius...got Day Day's car and left. Ok, when

8 Julius, I mean Westside and Day Day, they went into the house...ok, and I guess a little while

9 later I, I left and went out back and went to my sister's house. So, and then like I say, uh, after

10 that I don't even know whatever you know, what happened. Uh, then I came back and they

11 were, they was talking to me about a movie.

12 Pfeiffer: Now who's they?

13 Owens: That's Vickson and Maria.

14 Pfeiffer: And Vickson is Day Day's girlfriend?

15 Owens: Right.

16 Pfeiffer: And Maria is yours?

17 Owens: Right. And Day Day was in the house.

18 Pfeiffer: And about what time was that on Wednesday?

19 Owens: It was, it was about...uh...at that right, that was about 8:30 or 9.

20 Pfeiffer: Ok.

21 Owens: Ok, cause and umm, so I went on back to my sister's house and...and uh...got uh,

22 what'd I get? Oh I got, I put my tools back up. Cause I had used on someone's car. Uh,

23 anyway i come back, uh...went back, went to Maria's sit around for a little while and...Vickson

24 and his girlfriend then went and got a movie, two movies. And when they came

25 back...uh...before we went all down, me and Maria and the baby went down, we sat around just

26 watching the movie.

27 Pfeiffer: You went down to Day Day's apartment?

28 Owens: We went down there and watched the movie.

29 Pfeiffer: And what time do you think that was?

1 Owens: Uh...I guess about 10:30, 11. Somewhere around in there. Uh...

2 Pfeiffer: And who was in the apartment besides Vickson?

3 Owens: Uh....me, Maria, Day Day, the two girls and then my son.

4 Pfeiffer: And Vickson ?

5 Owens: And Vickson.

6 Pfeiffer: Ok. And the 2 girls are Day Day's children?

7 Owens: Uh, yeah I guess, I think so.

8 Pfeiffer: Ok. And so you said you talked about have, doing a movie about 8:30 or 9..

9 Owens: Uh-huh (affirmative) Well, well they told me that they were gonna get...

10 Pfeiffer: Ok.

11 Owens: A couple movies. "Ya'll welcome to come down if ya'll want, you know."

12 Pfeiffer: Ok. So approximately uh...what time did you go start the movie?

13 Owens: Uh, it's about...between 10 and 11. I guess about 10 or 10:30.

14 Pfeiffer: Ok.

15 Owens: And we watched the movie, uh...I guess, I guess about 2 hours, the movie was

16 about 1 ½, 2 hours long. We uh...just when the movie was ending...I came, went upstairs.

17 Pfeiffer: You went upstairs?

18 Owens: I went upstairs with the baby. Changed his pamper and got me a little something

19 to nick nack on and uh...we was laying on the bed and I had the baby up like this playing with

20 him on the bed. And that's when I heard the engine noise. And I happened to look out and

21 suburban was parked.

22 Pfeiffer: You're looking out into the parking lot of the apartments? And did you see the

23 suburban just parked or did you see the suburban...

24 Owens: I saw it pulling in, backing in.

25 Pfeiffer: Backing into what?

26 Owens: In, into the uh parking lot, well this little space you know. Close to uh...our

27 apartments.

28 Pfeiffer: Ok.

29

1 Owens: And uh...so I just kept (inaudible) I just kept playing with the baby and kept  
2 playing with the baby so...and then I heard Day Day and Julius out, standing out laughing and  
3 talking. They was talking about it uh...whatever they was talking about.

4 Pfeiffer: Did you hear what they were talking about?

5 Owens: No, I had the TV on and windows closed so I opened it up, up the window and I  
6 was gonna say something. And then I closed it back and I got up to go to the front or something,  
7 I don't know what it was, but so I come back and just laid back down, said I'll just let him have  
8 his company. And then I talked to him uh...(inaudible) and uh, well they stayed out there for I  
9 guess, I don't know, 15, 20 minutes. Uh...

10 Pfeiffer: Was that the only two people you saw were Day Day and Julius?

11 Owens: At that time.

12 Pfeiffer: Ok and where were they standing at proximity to the suburban?

13 Owens: Next to it.

14 Pfeiffer: Right next to it?

15 Owens: R ight next to the suburban.

16 Pfeiffer: Like at the front or the back?

17 Owens: Closer to, closer to the back.

18 Pfeiffer: Closer to the back.

19 Owens: Right.

20 Pfeiffer: Ok. And you remember what Julius was wearing?

21 Owens: No, I don't even remember. I remember his, I know his face when I see it, I don't  
22 remember, I knew it was him. Uh...I can't remember what he, what he had on.

23 Pfeiffer: Did you see anybody else standing out there?

24 Owens: No.

25 Pfeiffer: Ok.

26 Owens: I didn't see nobody else.

27 Pfeiffer: And so they talked for 15 to 20 minutes and then what?

28 Owens: And then uh, I went back to playing with the baby and then after a little, after a  
29 little while then uh, I heard the engine noise again, I looked out and the truck was gone. And

1 uh...about that time, that's when...uh, Maria came into the room. I, I don't know how long she  
2 had been in the apartment. Or if she had just came in or what, but when she came into the  
3 bedroom and, and I just, we just laid on down and watched TV. And went on to sleep.

4 Pfeiffer: Did she say why you guys weren't gonna watch that second movie?

5 Owens: No, she didn't.

6 Pfeiffer: Cause you talked about you were gonna go up to your apartment and get  
7 something to snack on...

8 Owens: Right and I was coming down....

9 Pfeiffer: Go back down and watch the second movie.

10 Owens: I was gonna go back down and...like I said I guess uh...they got tired of waiting  
11 on him I guess, I don't know.

12 Pfeiffer: Waiting on?

13 Owens: On Day Day get finished with his confident or whatever and then so, I guess it  
14 began, (inaudible) pretty late so I guess they were gonna postpone until the next day or whatever,  
15 I don't know. But Maria came in uh...laid down and went on to sleep. And then I saw him,  
16 remember seeing him the next morning you know getting in his car, leaving I guess, going to  
17 work.

18 Pfeiffer: And that's Day Day?

19 Owens: Right.

20 Pfeiffer: And his car's a what?

21 Owens: His has a red Firebird.

22 Pfeiffer: Ok. Uh... so you saw the suburban being back in, you didn't see who was driving  
23 the suburban?

24 Owens: I had never saw who was driving.

25 Pfeiffer: Uh, you hear Day Day and Julius voice, you look out and you see both of them...

26 Owens: Right.

27 Pfeiffer: Standing towards the back in, right next to this suburban, do you remember what  
28 color the suburban was?

29 Owens: No, it was dark, so I couldn't...I couldn't begin to tell you what color it was.

1 Pfeiffer: Ok, was it a newer suburban or an older one?

2 Owens: Uh...I can't remember...as I, it wasn't no old one. It wasn't an old one. Uh, I say  
3 uh, I guess like...I may be wrong '91, '92. 90 model, something like that, but I don't know.

4 Pfeiffer: Did it look nice though? I mean was it a nice looking suburban?

5 Owens: Oh, it looked, it looked pretty good. Nice from what I saw.

6 Pfeiffer: Uh-huh (affirmative)

7 Owens: It was ok.

8 Pfeiffer: Ok, so you hear them talking for about 20 minutes, you hear what you believe is  
9 the suburban starting back up because what? Sounded the same?

10 Owens: Right. Same, sound like the same engine to me.

11 Pfeiffer: And how long is it before you look out the window at them?

12 Owens: Uh, I wait about, I guess...minute and a half, two minutes. Uh...and I just happen  
13 to look up uh...but I, you know, I got it, like I say I got in bed looking up and down, you know  
14 how, how that the cars because my car was stolen from out there not too long ago. My, in fact it  
15 was on the 5<sup>th</sup> of July. And...he stripped it down and stuff and...but then, so I got it...

16 Pfeiffer: So you kind of watch.

17 Owens: Yeah. Right.

18 Pfeiffer: Ok.

19 Owens: I kinda...

20 Pfeiffer: Ok, when you heard the voices uh, of Julius and Day Day, in the parking lot, you  
21 saw them standing next to this suburban...were they fighting voices?

22 Owens: No.

23 Pfeiffer: What were they doing/

24 Owens: Just talking. Just like a regular conversation, it didn't have no...anger, no, it was  
25 just like a old buddy, buddy talk, you know.

26 Pfeiffer: Were they laughing or just talking?

27 Owens: Uh...it was just talking. At that time it was just talking. I didn't, I didn't...never  
28 heard no nobody talk loud or you know get loud with each other.

29 Pfeiffer: Were they looking at the suburban when they were talking?

1 Owens: At one time they were.

2 Pfeiffer: You saw them both looking at the suburban?

3 Owens: At one time.

4 Pfeiffer: Or one of 'em looking, which was it?

5 Owens: Well both...were looking at it (inaudible) at one time.

6 Pfeiffer: Ok. One at a time as you looked out?

7 Owens: Right.

8 Pfeiffer: Ok.

9 Owens: And after that they was just, you know, laughing and talking and looking around  
10 period. You know just...looking around talking, you know...and that's, that's all I saw and went  
11 on and laid down and kept playing with the baby.

12 Pfeiffer: Ok. Uh...I don't remember if we covered this so we'll go back because you were  
13 trying to remember those sayings and every time we started that we got off on some of those  
14 other things, so just to make sure...

15 Owens: Alright.

16 Pfeiffer: Uh...on Wednesday, this is before you heard the voices..

17 Owens: Uh-huh (affirmative)

18 Pfeiffer: And you know that night in the parking lot and say Day Day and Julius by the  
19 suburban.

20 Owens: Right.

21 Pfeiffer: You said between 2 and 3 you saw Julius and a person known to you as Westside.

22 Owens: Right.

23 Pfeiffer: Talking with Day Day, in the parking lot?

24 Owens: In the parking lot.

25 Pfeiffer: Ok. And that Julius drove away in Day Day's...

26 Owens: In Day Day's uh red Firebird.

27 Pfeiffer: Ok. And you think that was between 2 and 3?

28 Owens: Right.

29 Pfeiffer: And you never saw Julius bring it back?



1 Owens: Never. I never saw him bring it back.

2 Pfeiffer: But...you said...when we spoke earlier you said that, that night then the car was  
3 there.

4 Owens: Yeah. And another thing I remember uh...it took him a long time uh...for him to  
5 get his car back too because he kept paging Julius. I remember him complaining about, "Man,  
6 this dude, uh, won't answer my pages, man, he got in my car." And I was like, "Shouldn't have  
7 let him," you know, "in the first place."

8 Pfeiffer: About what time is this when he's taken his car?

9 Owens: I guess this was about...uh, 5, 6 o'clock.

10 Pfeiffer: He say, did he say where he was taking it or why he needed to borrow it or...

11 Owens: No, he never said. But I remember him complaining. Matter-a-fact reason why  
12 uh...he was telling me this because I was suppose to uh, look at it, his engine. Because it had, a,  
13 a slight miss in it.

14 Pfeiffer: Look at Day Day's Firebird's engine?

15 Owens: Right. I was, uh, had a slight miss in it like uh, maybe could have been a spark  
16 plug wire or a bad spark plug so...he was like, "Man, this dude, I been paging this dude, man, he  
17 ain't, he won't even call me back so I don't know what he's doing with it or whatever." So it  
18 took him a while to get his car back.

19 Pfeiffer: Do you know when the car got back?

20 Owens: No.

21 Pfeiffer: Did you see it..

22 Owens: Never, that's why I never seen it come back or never, I don't know, I don't know  
23 if he went to get it or what, but he brought it back some how, I'm not sure.

24 Pfeiffer: Ok. You said that you met Day Day, tell me when you met Day Day.

25 Owens: Uh, I guess about February.

26 Pfeiffer: Of 1999?

27 Owens: 1999.

28 Pfeiffer: And you met Julius and Westside?

29 Owens: About 3, maybe 3 ½ weeks ago.

1 Pfeiffer: Ok. And you told me how you came to met them was...uh, that...

2 Owens: They were having car, car trouble.

3 Pfeiffer: And the car trouble was with which car?

4 Owens: Uh, well both, both cars. Cause uh, Julius his was the black Buick Regal and then

5 it, it had transmission problems. His trans- real bad transmission leak and the, either the front

6 rear seal, I mean the front seal or it was the pump where uh...the front pump uh...then the other

7 car had alternator problems.

8 Pfeiffer: And the other car being?

9 Owens: Being the uh...Cutlass, the gold colored Cutlass.

10 Pfeiffer: And that was Westside's car?

11 Owens: Right.

12 Pfeiffer: Ok. And so you were working on or looking at both of those cars and that's how

13 you came to meet them and Day Day had introduced you?

14 Owens: Right.

15 Pfeiffer: Cause Day Day thought you could help them with the cars.

16 Owens: Help them with the cars.

17 Pfeiffer: And that was about how long ago?

18 Owens: Two or 3 weeks ago, somewhere around in there.

19 Pfeiffer: Ok.

20 Owens: But I hadn't known 'em very long and I really haven't seen 'em but maybe about

21 4 or 5 times.

22 Pfeiffer: Ok. You said you remembered something that happened on Thursday before you

23 went to your Uncle's?

24 Owens: Uh-huh (affirmative)

25 Pfeiffer: And we discussed that. What was that?

26 Owens: Uh...let me think again. Uh...

27 Pfeiffer: Was that when Day Day ask you about the selling of the suburban?

28 Owens: Right.

29 Pfeiffer: Is that it?

1 Owens: That's, yeah, that's it.

2 Pfeiffer: Ok.

3 Owens: Yeah, cause uh....uh...he s'pose to be goin' to the East side uh, and relaying a  
4 message. And...

5 Pfeiffer: Who?

6 Owens: Day Day. He s'pose to, he said, "well I'll just, when I go to the East side,"and  
7 you know uh, uh, cause he say he's gonna go by my Uncle's house or whatever and he was,  
8 while he was over there he was going, you know, "Let a couple other people know and see  
9 what," you know, see if he can find somebody that wanna buy a car, a suburban. I was like,  
10 "Well I don't know." Uh, I don't know too many people around here but, you know if I hear  
11 anybody ask for one, you know, like I said we didn't know it was stolen. But, you know, if I  
12 hear somebody mention uh, something about his truck I would bring that up, you know.

13 Pfeiffer: Ok.

14 Owens: That was it.

15 Pfeiffer: So Friday... you told me, when we talked previously that about 10 A.M. Vickson  
16 came to your apartment.

17 Owens: Right.

18 Pfeiffer: Ok, tell me what happened then.

19 Owens: And she was just using the phone repeatedly. Just using it over and over and  
20 over. I couldn't figure out what the deal was. "What's wrong, what's wrong?" "Police come  
21 over to the house asking me a bunch of questions about Julius and them." I was like, "What?"  
22 You know, "what they, what done happened, what'd they do so bad?" "They done killed  
23 somebody or something." I said, "What?!" (inaudible) suburban. I said, "That one that came,  
24 that was here (inaudible)." "Yep, that's the very one." I said, "Oh man," you know, it was just  
25 like...I didn't believe it (inaudible) they acted as if it was...you know, nothing to it, you know.  
26 And so uh, she was like, "Well I'm trying to get in con- contact with Day Day because that's  
27 who they want, you know, they want to ask him a bunch of questions, you know, whatever," they  
28 was trying to catch up with him. I was like, "Oh, ok, well," I give her the phone and went on  
29 about my business. And uh...and next thing I know they were everywhere. (Laughs)

1 Pfeiffer: Who's they were everywhere?

2 Owens: Police (inaudible).

3 Pfeiffer: What, what time was that?

4 Owens: Uh the police was everywhere. Oh I guess about one.

5 Pfeiffer: At your apartment?

6 Owens: Uh, well out in the hallway. They was going down at Vickson's apartment. And

7 uh, they never said anything to me, you know, I just went on out and got in my car and left. And

8 when I came back, I had went to the store and came back and they, she was leaving with them.

9 Pfeiffer: Vickson?

10 Owens: Right. And she said that uh...well I know, I remember her last phone call she was

11 trying to get him, she said he, she wanted him to come home. Because they were uh, wanting to

12 talk to him. And he said that, you know, he'll come to them and it was like, "well they said

13 they'll come get you." "Well no, I'll come to them." So he came home and that's when they

14 picked him up. And uh, by the time he got there she was already gone so...

15 Pfeiffer: You said that, on Friday, while you were at your apartment, uh, this was when we

16 spoke previously, that Julius and Westside came running up?

17 Owens: Right. I mean it was...like, you know, (laughs)

18 Pfeiffer: Were they scared? Were they breathing hard or?

19 Owens: Yeah, where's Day Day?

20 Pfeiffer: They were asking where's Day Day?

21 Owens: Yeah, right. And I was like, "Hey...uh...I don't know, he's, the police got him."

22 Uh...uh, I know what it was, that's when they, by that time Vickson had run in the house cause

23 she saw 'em come in. Coming up, cause she didn't know what was gonna happen.

24 Pfeiffer: She saw who coming up?

25 Owens: She saw them.

26 Pfeiffer: Them is?

27 Owens: Uh...Julius and Westside. That's when she ran into the apartment. And when

28 they came in, "Where's Day Day at man?" And I was like, "Well the police, he's with the police

29 they came and picked him up." He said, "Oh, they already come?" They go, "Where's his old

1 lady at?" I'm like, "Man, she's gone." Cause that's, that's where we (inaudible), I don't  
2 remember that part, I didn't say it a while ago, but I remember it now. Like, "She's not here  
3 man, she's gone."

4 Pfeiffer: Did she tell you to tell them that she wasn't in?

5 Owens: No, Uh-huh (affirmative), no I was like, cause I didn't know what was going  
6 down so, it was like, "Oh, uh, she's not here, I think she, she went, gone went looking for Day  
7 Day, I don't know." "Oh man, the police came over my house man."

8 Pfeiffer: And who's talking?

9 Owens: Uh, Julius. And he said that uh, well when, when uh, the police came, y'all want  
10 to be, he was on his way home or he went out the back or what, but he said, uh, "When I saw  
11 him I (inaudible) all out in front of my apart- house, apartment or whatever that's when I ran  
12 over here and all, so..." I was like, well, so apparently what happened was when, while he was  
13 on his way over the other guy which is Westside, they ran into each other some kind of way.  
14 While he was on his way over to, looking for Day Day. And then he's, he got in the car with  
15 him and that's when he came on over. Cause he left running.

16 Pfeiffer: Who left running?

17 Owens: Julius. Way he was talking he left his house running. Uh, you all ran over there  
18 so and in other words, or he may have went to Westside's. Uh, where he was at and they both  
19 came over.

20 Pfeiffer: Were they in a vehicle?

21 Owens: They were in uh, the gold Cutlass.

22 Pfeiffer: And that's Westside's car?

23 Owens: Right. And then uh, so by that time uh...when they was getting ready to...go on  
24 out the door she went on and came out the apartment. And that's when he was asking her uh,  
25 uh, her uh, had she talked to him. "Have you talked to Day Day?" And she was like uh, "No, I  
26 been trying to find him uh, they said that the police picked him up or something. What's goin'  
27 on?" Like that you know, "I don't know. But they just left my house. Police was all at my  
28 house and stuff, I ran over here." And so they went on said, "Alright, ok," and they went on out  
29 the door. That's when they left.

1 Pfeiffer: Did you see them leave in the car?  
2 Owens: No.  
3 Pfeiffer: Did you hear 'em?  
4 Owens: No, I heard, I heard the car doors. That was it, we went on back to the  
5 (inaudible).  
6 Pfeiffer: You went, I'm sorry, I didn't understand you.  
7 Owens: Went on back to talking, me and Maria...  
8 Pfeiffer: Still standing kind of in the breezeway area?  
9 Owens: (inaudible)  
10 Pfeiffer: Still standing kind of in the breezeway area?  
11 Owens: On in the, on the inside?  
12 Pfeiffer: Right.  
13 Owens: Right. In the hallway, right.  
14 Pfeiffer: Ok  
15 Owens: And we was sitting on the, me and Maria was sitting on the steps and Vickson  
16 was standing up close to her apartment door. So and we was just sitting there and you know  
17 talking whatever. You know, by that time we was all trying to figure out what was going on.  
18 (Laughs) So, uh, that's what was going on at the time, but they, so they went on and left.  
19 Pfeiffer: And so about what time does this that their there?  
20 Owens: Uh, I don't know, about 3 or 4 I guess, I don't know.  
21 Pfeiffer: Ok.  
22 Owens: (inaudible)  
23 Pfeiffer: So they, you hear 'em leave?  
24 Owens: Yeah.  
25 Pfeiffer: And what's Vickson saying to you?  
26 Owens: Uh, she's just, well actually she was like, "I don't know what he come over here  
27 looking for uh, Day Day, I don't know why they come over here looking for him." "Uh, well  
28 we don't need no mess around here, you know you know, all that." And (inaudible) that's all  
29

1 that ever said after that and then, so we went on back to laughing and talking. So she went to,  
2 she went on to use the phone again.

3 Pfeiffer: In your apartment?

4 Owens: Right. She called her parents or whatever. No, she called Day Day's Uncle,  
5 that's who she called. And uh, I don't know what was said, but i remember her saying that she  
6 was, she's needing a pager. And she wanted him to call her back or something. So she used the  
7 phone again. And after that, uh, that was it you know, as far as Friday.

8 Pfeiffer: Did you ever see any of the people we were talking about coming back to the  
9 apartment later?

10 Owens: (inaudible)

11 Pfeiffer: Ok. And you said after all this went down you did talk to Day Day later about  
12 this?

13 Owens: Well yeah. And he was telling me about uh...they were asking him, you know,  
14 about the suburban, about uh, he said that, some, somebody...supposedly said that he was, he was  
15 trying to sell it. And I was like, "What?" Don't make any sense, I mean and relaying a  
16 message, you know, it's, I guess you know. If that's the case they could have got me too.  
17 (laughs) Cause you know, I...had mentioned it to somebody else about it, a suburban being, you  
18 know, trying to be sold, I don't know. I was like, I don't know anything about it, all I know  
19 is...if you interested then I'll tell Day Day and he'll, he'll get in touch with his nephew or  
20 whatever. That's who got the truck so, that's all I know. But that's what he was talking to me  
21 about that somebody uh, gave out information stating that he was trying to sell the truck so.

22 Pfeiffer: Ok. Uh...you said you had seen uh, between 2 and 3, Julius and Westside talking  
23 to Day Day in the parking lot. Julius leaves in Day Day's car, Day Day is then trying to get a  
24 hold of Julius by paging him around 5 or 6? Do I have that correct?

25 Owens: Right.

26 Pfeiffer: Ok.

27 Owens: Ok, he was, like I say I was gonna check it out. And he was like, "Man, I'm  
28 trying to catch up with this dude, man."  
29

1 Pfeiffer: Did he see Day Day from like...6 to whenever? I mean when do you see him  
2 again? About what time?

3 Owens: Uh...about...8:30.

4 Pfeiffer: And that's when you guys started talking about movies or...

5 Owens: Right.

6 Pfeiffer: Vickson does or who brings that up?

7 Owens: Well, ok, I, the next time I saw him it was about 8:30. It was 8 or 8:30, he was  
8 standing outside the parking lot, by himself. Uh...when I came, decide to come on out the  
9 apartment...

10 Pfeiffer: I'm sorry?

11 Owens: When I finally come out the, out, well what I did was came from my sister's  
12 house, that's when I saw him standing out in the parking. I mean out in the parking lot. I went  
13 on into the apartment and uh...

14 Pfeiffer: Which apartment?

15 Owens: Uh, Maria's.

16 Pfeiffer: Ok.

17 Owens: Uh...

18 Pfeiffer: Apartment 112?

19 Owens: Uh, no that's my sister's.

20 Pfeiffer: Ok.

21 Owens: 408 or like 408.

22 Pfeiffer: 408? That's Maria's apartment.

23 Owens: Uh-huh (affirmative) Ok and I watched TV for a minute or two and uh, I guess  
24 about 20 or 30 minutes, I go, when I went back out...that's when, they was, Vickson was talking  
25 about getting a movie.

26 Pfeiffer: Was Day Day there then?

27 Owens: Well she said he was in the house, house laying down on the couch. So...

28 Pfeiffer: Ok. And that was about 8:30?

29 Owens: Well then, by that time, his car was back.



1 Pfeiffer: His car was back?  
2 Owens: He had his car back.  
3 Pfeiffer: Ok.  
4 Owens: About that time. So...  
5 Pfeiffer: Ok, and so...she goes and gets the movies?  
6 Owens: Uh-huh (affirmative)  
7 Pfeiffer: Brings 'em back. Does she call ya, or knock on the door or what's she do?  
8 Owens: I don't know, oh well, I don't know I think uh...she knocked on the door and her  
9 and Maria talked about it. So Maria came and told me you know, "they got the movies," so we  
10 went on down and watched the movie.  
11 Pfeiffer: Ok. And about what time was that?  
12 Owens: Uh, about 10:30, 11. Somewhere around in there.  
13 Pfeiffer: Can you think of anything else?  
14 Owens: Nah, that's about it. Knowing me I get out the door and (laughs) (inaudible).  
15 Pfeiffer: Well if you do then call back.  
16 Owens: Ok.  
17 Pfeiffer: Feel free to call back. No problem. Uh...I can't think of anything either. Ok,  
18 well I do appreciate you coming in. I really do.

TP: E?

JA: Elizabeth.

TP: Elizabeth. Ok. What's your date of birth?

JA: 8-30-79.

TP: And what's your home address?

TP: You know the zip?

TP: Ok. Ok.

TF: What's the other address?

JA: This is where I just got a house. But I haven't moved in yet. I've moved some of my furniture and stuff but...

TP: Is that the one that Laymon helped, helped you to get?

JA: He thinks. (Laughs)

TP: Ok. I understand. What is today?

TF: 28<sup>th</sup>. Happy Birthday, or almost birthday.

JA: Thanks.

TP: Almost. Ok. How do you know Laymon Jordan?

JA: I have 2 kids by him.

TP: Ok. How long you known him?

JA: Oh gosh, we met in High School...

TP: Which High School was that?

JA: Santa Fe. Well...lets see our daughter was born in ninety, February '97, so I've known him since '96. Beginning of '96. Well see...yeah, so, beginning of '96.

TP: Ok.

JA: I mean we were acquaintances in school, I mean walked by and we see each other but from where we like actually spoke to each other it was beginning of '96.

TP: Ok. When'd you graduate?

JA: Ah...did not graduate. I was 5 months from graduating and they dropped me.

TP: Well that's not good.

JA: No. Well it's close got my nursing degree now.

TP: That's wonderful.

JA: Getting there.

TP: Did you get a G.E.D.?

JA: Ah, I don't have to take my G.E.D. until October when I take my registrar exam, so...

TP: Oh ok.

JA: I should have it before then.

TP: Ok. Laymon told us that you were at his home, and do we have that calendar in here still? Since I'm going to be pressing you to go back and think about this.

JA: Ok.

TP: You know the time frame...he told us that, and I don't want this to be by his memory, I want your memory of it.

JA: Ok.

TP: Ok? So if it's somewhat different...

JA: I'll let you know.

TP: I need to know what you know. Ok. Ok, he said that, this is July, we're in August right now. And on the 28<sup>th</sup> we had the shooting, the murder, of the man that was killed and his suburban was taken. I'm sure you heard something about that?

JA: Right.

TP: Ok. Laymon told me that ah...Chris, his brother, Chris Jordan and Julius Jones called him this night, ok, oh I can't remember it was like one or something like that in the morning and ask if they could come over, and they did come over. Ok. The wee morning hours of the 20, actually be the 29<sup>th</sup>, wee morning hours, if it's 1:00 in the morning, the night, from the night of the 28<sup>th</sup> of July. So he said that

they came over ah...talked to him then in the morning he got you up early and then got...and then got them up. Do you remember them being there that night?

JA: I, that, that night of the 28<sup>th</sup> I picked Laymon up at school around 9, 9:30 and we went to Walmart on, that new Walmart Super Center they just built down there off Reno.

TP: Oh yeah, Uh-huh (affirmative).

JA: Ok we were buying paint (inaudible) cause he was suppose to help me decorate my house and do stuff with it. And ah, we bought the paint supplies, well I had to do laundry. The laundry mat at my friend's house was like 75 cents a washing (inaudible) cents to dry, I didn't have my washer and dryer hooked up yet. And at Laymon's apartment it's on 75 cents to wash and a quarter to dry. So my plan was to go to his apartment and do my laundry. So I got there that night, after we went and got the paint (inaudible) we dropped him off at my house and went out to his house. And I was doing laundry and ironing I remember his brother calling....ah...Laymon turned to me and said, you know, "My brother's coming over." And I was like, "Ok," it was late I had to get up early in the morning. I was asleep when they came over, but in the morning I was ironing my clothes, I, in the dining room. And I saw his brother, asleep on the couch, and I guess who was Julius Jones was asleep on the love seat.

TP: Had you ever met Julius Jones before?

JA: Never before.

TP: Never? Had you ever heard Laymon talk about him before?

JA: No.

TP: Ok

JA: I barely knew Laymon's brother.

TP: Chris?

JA: Yeah.

TP: Did they not have a lot of contact?

JA: I mean, no, not really, I mean, he always said, you know, him and his brother were suppose to be close, but Laymon would drive to his parents house when he was what 16, 17. And he stayed with a friend and, I mean I've (inaudible) past year, I've seen Chris, I saw him like 4<sup>th</sup> of July weekend when we

went to a family barbeque. And then I saw him that morning, his brother told, Laymon told me to woke 'em up on my way out the door. So I mean...

TP: Who'd you wake up on your way out the door?

JA: I said, "Chris, Laymon says you have to get up."

TP: Did you get a good look at this person that was on the love seat?

JA: I didn't get a real good look at him he, they both had blankets ah...I'm assuming it was Julius, that's who...Laymon said it was.

TP: Ok, did he tell you that morning that's who it was or did he tell you later?

JA: No, he told me later on after we heard about this whole thing. He was like, "I don't know how they could come over to my house and sleep." So...

TP: Ok. So you do remember them being there that night. Were they, did you go back over to his apartment, and when you say, Laymon's apartment, which apartments are you talking about?

JA: The ones on the southside.

TP: Do you have, do you remember where they were?

JA: Yeah, they're on 74<sup>th</sup> and May.

TP: Ok. So did you go over any other nights?

JA: Uh-huh (affirmative)

TP: Ok, show me.

JA: Ok, the night of the 30<sup>th</sup>.

TP: Ok.

JA: After work I went and picked up Laymon.

TP: Ok where did you pick him up and what time did you get off work?

JA: Oh gosh. Probably got off work around...5:30, 5, 5:30, got off work, picked Laymon up 6 or so.

And we left to go to Sight and Sound.

TP: And where'd you pick him up at?

JA: His apartment.

TP: Ok.

JA: And we left and went to...we didn't go to Sight and Sound right off where did we go?  
Oh...(inaudible). No, I don't think we went to Sight and Sound right off, I don't remember where we went. Well his friend Chris was at the house. Laymon's friend, Chris...was at the house and he was the only one there, we told him we were going, cause we were suppose to go buy beds for my new house.. And that's where I was getting them from was Sight and Sound. And we left and I don't, I'm trying, I'm thinking we went somewhere before we went to Sight and Sound, but I'm not really sure. But when we got to Sight and Sound ah, we had walked around we'd been in there maybe 5 minutes and we were looking at beds and a lady behind the counter said ah, "Somebody just called for y'all and said it was an emergency." And I just kind of looked at him and ah, Laymon said, "That must have been Chris or something,," somebody calling from his house I mean cause we knew it wasn't the kids cause my kids went to Ohio with my parents on July 18<sup>th</sup>, so we knew it wasn't about the kids or anything like that sort of like an emergency. So ah, Laymon called his house...and while I was standing by the lady or actually a guy was totaling up my stuff and how much it was gonna cost...and then ah, Laymon came back around to the counter and never said anything about the phone conversation. And after I paid a portion of the beds we left and we had planned, plans to go to Stephanie's but we said, we had to go back to his house and I was like, "Why?" And he said, "Well cause my brother just went to jail." And he didn't tell me why his brother went to jail or nothing he just went to jail. So got back to Laymon's house and...Chris was there and we were...

TP: Ok, if you, if he'd just gone to jail...

TF: Another Chris...

JA: Not, there's another Chris, Laymon's...

TP: Ok.

JA: Friends ah...what is his last name? They call him Style, I don't know if remember his...

TP: Style? He did refer to him.

JA: Ok.

TP: And he's a white guy, right?

JA: Yeah.

TP: Ok.

JA: Style's there and we got back to the house and I mean it was all over the TV. Last we saw them arresting Chris on TV and taking him into the jail and stuff. So, and then...

TP: About what time was this when you got back to the apartment?

JA: Probably like 7:30. About...

TP: Ok, when you pulled up to the apartments...

JA: Uh-huh (affirmative)

TP: Did you see anybody, when you pulled in?

JA: Did I see anybody when I pulled into the apartments like was anybody standing outside?

TP: Yeah. You didn't another car that was kind of maybe in the roadway or something like that?

JA: Not that I noticed I mean there's cars all over the place down there. Nothing that sticks out in my memory as a car sitting out.

TP: Did you see anybody standing outside of the apartments and talking to anybody?

JA: Well when I was walking in the apartment Laymon was sitting on the stairs talking to Style.

TP: Ok.

JA: And I was walking up...

TP: Yeah but you think this was about 7:30?

JA: Around 7:30, 8, I mean I don't the exact time, I didn't know I was gonna go through this and know the exact time that I did everything.

TP: We understand.

JA: So, I mean I don't...no I don't, I can not guarantee you that is the exact time. Like I said I get of work about 5, 5:30, I mean it just depends on the day. And then by the time I drove down and picked up Layon, I mean through traffic and stuff I'm guessing I got to his house about 6 and we weren't at Sight and Sound that long.

TP: Ok.

JA: So, yes we did, I know where we went, went to Beautyco before we went to Sight and Sound.

TP: Ok.

JA: And I got a new hair dryer. So, I knew I went somewhere before this, went to Beautyco and then we went out to Sight and Sound.



TP: Ok.

JA: So many it was 8. I don't think it was, no it couldn't have been 8.

TP: Was it still light outside?

JA: Yeah, it was still light outside. And we got back to Laymon's house and me and Laymon had all these plans to...get stuff done with my house and stuff and I was really mad so I was like, "Forget it, well then if you're just gonna sit here and not do anything," cause he called his mom, "so if you're just gonna sit here you know and...call your mom and stuff like that went to talk to a lawyer," then I said, you know,, "I'm not gonna get any of my stuff done and this was my plans." So then he got mad at me cause I supposedly wasn't there for him. And I left and went to Walmart and bought a new microwave and just some stuff that I needed for the house.

TP: Ok.

JA: And then I came back and when I got back I was telling you know, "its about time for you to go home," you know he's still not doing anything, he was just sitting around.

TP: What kind of car do you drive?

JA: A Pontiac Bonneville.

TP: And what color is it?

JA: Black.

TP: How many doors does it have?

JA: Four.

TP: And what year is it?

JA: '87.

TP: Ok. Ah...so when you pulled in to take him back, approximately 7:30, back to the apartment...

JA: Uh-huh (affirmative)

TP: Where did you park?

JA: Oh...well there's the entrance off of May...there's the entrance off of 74<sup>th</sup>, so I believe I parked over here by the entrance off of...you see what, the apartments are straight...

TP: I see now.

JA: Uh-huh (affirmative)

TP: Like this is, like this is May over here ah...I did that wrong, there's that way...

JA: This is, if this goes...

TF: (inaudible)

JA: And thi is (inaudible).

TP: Hopefully, I'm just gonna keep turning around in a circle.

JA: Lets just say it was a square here and this was 74<sup>th</sup> here.

TP: Uh-huh (affirmative)

JA: His ah, (inaudible) apartment's back here on the corner.

TP: It's right on the corner, right.

JA: Right.

TP: And it still goes by it.

JA: I was over on this side.

TP: So you parked up here?

JA: Yeah, I think so.

TF: On the east side.

JA: Ok.

TP: Yeah, (inaudible) east side. Ok, so you parked about right here?

JA: Uh-huh (affirmative) Well I mean...I was up against the apartments, yeah you walk around this way and up the stairs.

TP: Ok. So...did Laymon get out first?

JA: Yes.

TP: Ok. And you, you get out and you said when you walked up to the stairs he was sitting there talking to Style?

JA: Uh-huh (affirmative). He was, him and Style were out on the stairs talking.

TP: Ok. Do you know what they were talking about?

JA: No, I just walked past 'em.

TP: Ok. So Laymon was watching this on the news for a while?

JA: Uh-huh (affirmative)

TP: All this stuff going down. Did he say anything about...

JA: Well he was, I mean, I was just sitting there watching it on the news and he was back in his bedroom on the phone, I don't know if he was, who he was talking to, if he was talking to his mom or what. And I went back there and you know I was like, that's when I told him you know, I'm just gonna go to Walmart and get my stuff done if you're not gonna come with me.

TP: And which Walmart did you go to then?

JA: The one on...ah...down by his house off, I think it's Penn.

TP: Ok. And how long were you there? Do you...

JA: Oh Lord like an hour. Maybe two hours.

TF: Who all was there with Laymon when you all got back?

JA: When we got back to the apartment there was...think it was, was Melvin there? Oh gosh...Stle was there...me and Laymon came back...

TP: And which time period are we talking about? The 7:30 time period?

TF: Yeah.

JA: Yeah about then.

TP: Ok.

JA: And Laymon was there, Style, I'm not sure if Melvin and Powder were off work yet.

TP: And Powder's his girlfriend?

JA: Yeah. I think her real name's Lauren.

TP: It is.

JA: Ok. Everybody calls her Powder. (laughs)

TF: What is your nickname?

JA: I don't have one. (laughs)

TP: Well...

JA: Well sorry...sometimes they call me Jenny, but I mean that's short for Jennifer.

TP: Sure.

JA: And...

TP: But you don't know for sure if they were there then?

JA: Huh-uh (negative)

TP: Do you remember Laymon and Melvin having any conversations about this deal?

JA: Huh-uh (negative)

TP: Ok. Is there anybody else there?

JA: I'm not...when we came back from buying the beds, I'm trying to think if...that guy was there when we came back from buying the beds or if he was there when we came back.

TF: What guy?

JA: This...supposed Julius guy .

TF: Ok. Did you see him there?

JA: Yeah, when I was...he had to have been there when we came back at 7:30. Because...I was sitting there, that's when I was watching the news and saw everything on TV and he was sitting on the couch across from me.

JA: So you got a good look at him? I mean that time.

JA: Yeah. And that's when, when I went home that night...to my friend Angel's house, that's when we saw pictures of 'em on the TV. And that's, was it, no it was the following night, I'm sorry. It was the following night, and that night the following night, I had met Laymon at Style's house because he needed money.

TP: And this, which day are we talking about here? Show me on the calendar.

JA: Saturday.

TP: The 31<sup>st</sup> of July?

JA: Uh-huh (affirmative). That was Saturday night, cause i hadn't seen him since Friday night after I took Style home, Saturday I hadn't talked to Laymon basically all day and I finally got a hold of him at Style's house and he was arguing with tme, "you're not there for me. You know I'm not gonna stick around and waste my time talking to you. Meanwhile I have two kids by this man and...so the 31<sup>st</sup>, that Saturday night...I want to say, it was like 9:30, yeah cause I, cause me and my friend Angel were suppose to go out and do something and I had agreed to be back in 45 minutes. But 10:15, course I didn't make it. Ok, it was like 9:30, about there when I left. And I went and met Laymon over at Style's house. You know where a that is (inaudible).

TP: No, where is that?

JA: That's on, off Brittain...

TP: Brittain and...

JA: Oh...what's the name of that street? Andover. It's like ah the Village area.

TP: (inaudible) almost in the Village then.

JA: And I gave him a \$120.00 that night that he was suppose to be putting towards the use, to give to this lawyer, cause this lawyer wanted so much money or something.

TF: For who?

JA: For his brother...

TF: Brother?

JA: To help his brother. So...I gave him that money and me and Linda sat and talked for a little bit...well they had talked about ah Laymon's brother being on the front page of the Saturday newspaper.

TP: Uh-huh (affirmative)

JA: So I went to get the Saturday newspaper, but it was like 11:00 and they already had the Sunday newspapers out. So I ended up getting a Sunday newspaper and that's when I saw the picture of Julius in there, seeing that he had bee arrested and Laymon's apartments. But it didn't say in the newspaper that he had been arrested in Laymon's apartment. And I had no idea, so..I'm thinking ok, he just got arrested in the apartment, he was over in that area. Well then I see the picture and I was like, ok, well that was...I guess Chris' friend that supposedly did this with him and then...I can...did I confront Laymon about it? I don't remember if I confronted Laymon about it or Melvin. I either confronted Laymon or Melvin about...I think it was Melvin, cause I think I called the house Saturday night after I got back and I talked to Melvin. I'm not for sure though. But I talked to Melvin to find out, you know, what happened, why, who was this guy in the house and yada, yada, yada, and he was like, "Well yeah they came over to the house till 5:00 in the morning or something like that, with flashlights and arrested some guy." And I was like, "Well...why didn't Laymon bother to tell me that?" Meanwhile he's yelling at me all day, Saturday, or Saturday night when I had to him, that I'm not there for him and yada, yada, yada, meanwhile some guy's getting arrested in his house and I've got 2 kids to take care of and he's telling me I'm not there for him. And I was pissed because Laymon never, had I not read that newspaper article and

known that this guy had been arrested in Laymon's house I never would have known it. Had I not picked up the newspaper article. And that was the Sunday newspaper that I read.

TP: On Saturday?

JA: (inaudible) Yeah, late Saturday night.

TP: Ok, did you ever talk to Laymon about this?

JA: About...the...

TP: Julius being arrested out of his apartment.

JA: No, I can't say for sure that I've ever...

TP: Ever? You mean after that sometime?

JA: I don't know, I know I talked to Melvin about it.

TP: What did Melvin say?

JA: Ah...

TP: Was this on the phone or in person?

JA: No, it's in person.

TP: Ok. What did he, what did he say?

JA: He'd just said that...yeah, he'd been arrested and police came in the apartment with flashlights and it was crazy and...ah...what'd he say? Melvin said he, he said something like, he didn't even know anything about it, but I don't know...what did Melvin say? He said that the cops took them out to the cars and questioned 'em and then told them not to go anywhere or something like that. That that'd be back to question 'em. I don't know. I think that's what he said. That the cops told him not to leave. Cause they'd be back to question 'em. So...I don't know.

TP: Did you ever talk to Laymon after that?

JA: (inaudible). About the guy actually being arrested in his apartment. I can't say for sure I did, I'm sure I've said something to him about it, like why didn't you bother, I think I've said to him you know like, "Couldn't you bother to tell me?" So and so and he's says because I get too paranoid or something like that.

TP: You get too paranoid?

JA: Yes. Well...I'm sorry I've never been, I have never been questioned, you can check my record, I have 2 kids. I do my best to take care of them. And all this stuff goes on and I'm getting dragged into this and I knew nothing about it. And it's just driving me crazy. I can't believe this.

TP: You're not in trouble Jennifer. We just need to corroborate something's that we've been told, not only by Laymon, but by other people. And so the reason we're talking to you is not because you're in trouble. It's just because we have, if you were there, we want to know, who was there when you were there.

JA: Right.

TP: What was said, and so you're not in any trouble. And I hope that we haven't given, given you that impression.

JA: No, I'm just...

TF: (inaudible)

JA: (inaudible) yes.

TF: Ok.

TP: I wouldn't even ask you...

JA: But I feel like I've been dragged into something that I, you know, I'm trying to get a house, get on my feet. My 2 kids are living with my parents now in Ohio because I'm only making so much money and I've picked up a second job so I can get additional stuff for my house. So my kids do come back next month I have stuff for them.

TP: Right.

JA: You know? And it's like...I don't know, I try so hard to be perfect and...

TP: Well believe me Jennifer nobody's perfect. I can attest to that.

JA: I know, but I mean...I'm sitting in a police department being questioned...

TP: But it's Saturday, nobody's here except Tony and I. (laughs) So don't worry about it. Just take a deep breathe, just, just settle down cause I don't want you to think you're in trouble, you're not. We just can't take...

JA: (inaudible)

TP: We just can't take one person's...

JA: Oh I understand.

TP: For what went on...and because we don't believe you're involved in this, we believe you'll, you'll tell us what you saw, when you saw it, and what was going on. So that's the only reason. I mean there's some other people we're gonna be talking to too. It's just, it's like talking to witnesses that saw car accidents for example. Well their certainly not in trouble for the car accident, they just happened to see, to be at the wrong place at the right time or something. Ok?

JA: I just, I don't know, I, I just can't believe I know somebody that had something to do with something like this.

TP: Well...

TF: I can't find a Kleenex in the house.

TP: I think Ricky ran out of them.

TF: Yeah, first, first place I went ah, Sharon.

JA: You don't question that many people that have been crying.

TP: No, no, no, no, no. Ok. Did you ever talk to Style about this?

JA: Have you ever tried to talk to Style?

TP: Not yet.

JA: (Laughs)

TF: What is he like?

JA: Try to get something out of Style, he's a...a brick, I mean a brick wall.

TP: How old is he?

JA: Oh Style's like...24, 25. I'm guessing. I'm, he's around there somewhere.

TP: What's he look like?

JA: He has blonde hair, sometimes it's really long and when he gets tired of it eventually he'll cut it off. He works, I think, doesn't he, I think he still works at Target.

TP: On, at Quail Springs?

JA: Uh-huh (affirmative) On Memorial.

TP: Ok.

TF: Why doesn't he talk?



JA: He's, he's just, I don't know he was, I don't know maybe it was just the way he was raised. But he's just, he's real stuck in his ways, he's...I just don't know how to explain it. He's ah, I don't know, he thinks he's always right and...he's really hard to talk to, me and Style really ever talk.

TP: So did you have any conversation with him about...

JA: About this? I don't think so. No, cause I mean you try to talk to Style, if I said something to him. I took him home that night. That Friday night from Laymon's house.

TP: Uh-huh (affirmative). About what time was that?

JA: Probably about 9 or so.

TP: Ok.

JA: Maybe 10. Took him home from Laymon's house...to his house. I mean I told him, you know, I can't believe Laymon's brother's involved in something like this and...you know, yada, yada, yada, but he never really said anything back. He always, what he always said, "Well, our goal is to get his brother out of jail," you know and yada, yada, yada. "That's all we need to concentrate on right now," and they were mad at me because I went to Walmart and bought a microwave and stuff and they think I should have given them out of my pay check to help get his brother out of jail. And I'm trying to explain to them, "your brother did a murder, he ain't gettin' out."

TF: Right.

JA: You know and...you know but I'm suppose to you know, fork over my money because I got paid that Friday. I'm suppose to fork over my money to them.

TP: You gave them a \$120.00 didn't ya?

JA: Well I know but if you're stupid. Very stupid. That was Saturday though that I gave them \$120.00, Saturday night. But I mean it was just like, I don't know, I guess I tried to buy 'em off so...I don't know.

TF: So what?

JA: So he would just, I don't know, I'm just, I've had, he's always walked in and out of my life. And I just wanted to be there for the kids, so it's like, you know, I give him some money maybe he'll stick around just a little longer, you know...I don't know. I really, I mean I care about him, but... he's, huh-uh (negative), just things aren't right. Things aren't right. So...

TP: Did you ever talk to Laymon about what he talked to his brother about, since his brother's been in jail?

JA: I have not spoken to Laymon...since Monday, August 2<sup>nd</sup>. Was that that night? Yeah, Monday, August 2<sup>nd</sup>. And all he told me was, "I went and saw my brother in jail today." And that was about the extent of our conversation. And he basically told me that I'm not there for him and he doesn't need me around and I'm just gonna be holding him back from doing the stuff that he needs to do, so...

TF: What is his big plan that he's gotta do?

JA: He's,...you got me. I haven't talked to him in a month. He's, Laymon always got some plan you know to make himself come up and be better, but yet he can't keep a job and take care of his kids. I just ask him...oh gosh, well I didn't ask him, I ask Kristi...you know who Kristi is? Blue.

TP: Kristi (inaudible)

JA: Karaira (inaudible) or something?

TK: Yeah.

TP: Something like that.

JA: Ah, me and her have kept in, kind of in touch. I mean she just, you know, she'll call me every now in then let me know, "Hey, how are you doin'?" you know and all that, you know, she'll be like, hey, we never...have really gotten along, we're not buddy, buddy friends, we've never gone out and done anything. But I did ah...when did I talk to her? Oh goodness...I talked to her on and off. But she had my Pike Pass to my car...so I went over there to get it the other night...Tuesday night maybe...to get my Pike Pass and...ah...Laymon just walked (inaudible) he got, cause they were just getting back from picking up Melvin at work when I got there. And I saw Laymon, but he just walked right past me. He handed me my Pike Pass and kept on walking, he didn't want to speak to me. He's supposedly trying to work things out with Kristi now and their suppose to be, have a relationship or something and Kristi say's, "No, I'm not doing anything with you, I'm," she says she's getting her life back together and moving back to South Dakota so, where her parents are. And she's gonna go to school. And she was telling me that he thinks he's gonna go with her and I don't know.

TP: Can you tell me...I'm gonna go back just a little bit.

JA: Ok.

TP: Style's house, does he live there by himself?

JA: Does he live by, he's 25 years old and he still lives with his momma.

TP: What's his mom name?

JA: Sue.

TP: You know what his mom does?

JA: Ah, works at Walgreens.

TP: Which Walgreens?

JA: That one they just built there on ah, Penn and Brittain.

TP: Ok. The dad doesn't live there?

JA: I've never met Style's dad. He doesn't live there, they've been raised by their mom.

TP: Ok. Does, you, does he have siblings that live there?

JA: Yeah, he has a brother and a sister.

TP: They both still live at home? Are they younger or older?

JA: Umm, he has a sister that's a freshman in high school this year and then he has a brother that's like 22 maybe.

TP: Ok. And go back a little bit further. When you talked, when you saw Julius, at the apartment, when you got back there at 7:30 and you stayed for a while...

JA: Uh-huh (affirmative)

TP: Did Julius say anything?

JA: Just sat on the couch. Watched the TV.

TP: Watching the news about...

JA: About his brother, Laymon's brother, getting arrested and they were standing outside somebody's house. Some white house the cops were...on TV that night there was the cops standing outside a white house.

TP: Did Julius say anything about that?

JA: Nope, just sat there and watched.

TP: How long do you think you were at the apartment?

JA: I don't know...

TP: Before you left and went to Walmart.

JA: Probably 30 minutes at the most.

TP: Ok. And he didn't say anything the time you were there?

JA: Huh-uh (negative). He just sat on the couch.

TP: Ok. I'm gonna go back just a little bit further and I promise I won't go back (inaudible). The 28<sup>th</sup> of July.

JA: Uh-huh (affirmative)

TP: When you guys had been out...you have been with Laymon, is that correct?

JA: Uh-huh (affirmative), he was with me.

TP: Can you recount for me, the best you can...your day that day, starting maybe around 6 P.M.

JA: Well I would have been off work by 6, 6:30.

TP: And this work is at Baptist?

JA: Uh-huh (affirmative)

TP: Ok.

JA: And...gosh...sometimes after work I'll...go to the store or something (inaudible). I want to say I want back to my friend Angel's house. We ate dinner...yeah we ate dinner there because, me and Angel were talking, she wanted me to go somewhere. We were gonna go grocery shopping or, I don't know, we were gonna do something, but I told her I couldn't go because I had to pick up Laymon from school. Picked up Laymon from school, 9, 9:30.

TP: What school is this?

JA: Platt College on Reno and Ann Arbor.

TP: So you picked him up at 9 or 9:30 that night?

JA: Uh-huh (affirmative)

TP: Ok.

JA: And after I picked him up we went to Walmart. And I probably even have the receipt. Well maybe not I have my (inaudible) receipts from the paint supplies...that we bought that night and that could give you more of an exact time of when...

TF: That's on Wednesday?

TP: That's on Wednesday the 28<sup>th</sup>.

JA: (inaudible). No, I don't have it. But we were there, and we were at Walmart...oh...

TP: I'll check it in just a second. Go ahead.

JA: We were at Walmart ah...we were at Walmart at least an hour. Walked around didn't, we were matching paints to the bedroom sets that I picked out for mine and the kids rooms and stuff. And then they guy had to mix the paint so...we weren't there any short amount of time.

TP: Could you hold on just one second? I'll be right back. Tony could I see just for a second.

Ok. I'm sure you understand, but we're trying to verify where everybody was at a certain time on certain days, so we can kind of pin everything down. And that's what we're doing. So on the 28<sup>th</sup> you picked him up from Platt College.

JA: Uh-huh (affirmative)

TP: Do you do roll there, at Platt College, so they would know if you were there or not? Ok. Ok and then you went to Walmart?

JA: Uh-huh (affirmative)

TP: And you did the paint thing.

JA: Uh-huh (affirmative) and we left Walmart and went by my house on McKinley and 33<sup>rd</sup>. And dropped off the paint, we just carried it in the house and then we left. And then we drove to his house from there. Try to think who was there when we got home, if anybody was there. Umm...so many people that always went in and out of there, I mean you never...

TP: Why was that?

JA: I don't know, he was just...single guys living together, ah...oh, I'm trying to think if anybody was there that night when we got home. I think...Slip was there, I don't know his real name.

TP: Slip?

JA: Uh-huh (affirmative), he was the other roommate.

TF: Slip, Style and (inaudible).

TP: So Slip, he's a black guy?

JA: Uh-huh (affirmative)

TP: Ok.

JA: He might have been there.

TP: And do you know where he worked?

JA: Umm...he told me once. I don't remember though. I know he dresses nice though when he goes to work.

TP: Ok.

JA: He doesn't wear, yeah he doesn't wear like a uniform. Like (inaudible) slacks and a button shirt. I think he might have even wore a tie.

TP: Umm, interesting. Ok and that's Slip. Do you know how long Slip had known Laymon?

JA: Huh-uh (negative), I know he had just moved in a couple nights prior, maybe a month or so prior.

TP: How many roommates did Laymon have?

JA: He was, Laymon had a room and Slip had a room and Melvin had a room and then sometimes Powder stayed over there.

TP: Ok. Was that a 3 bedroom apartment?

JA: Uh-huh (affirmative)

TP: Ok. Ok, so about what time do you think you got back to the apartment?

JA: That night?

TP: Uh-huh (affirmative).

JA: After Platt?

TP: After going to Walmart and doing the paint thing.

JA: Probably 10:30, 11.

TP: Ok. And from that time, I guess you said something earlier about doing laundry?

JA: Uh-huh (affirmative)

TP: Is there a washer and dryer in the house?

JA: No, we had, I had to go down to laundry mat and then come back up and all that stuff.

TP: Ok.

JA: And...in fact we even stopped at ah...Taco Bell on the way home. After I, we dropped the stuff off at my house, we stopped at Taco Bell. Cause after I dropped a load of laundry and I ate some tacos. And Slip and Melvin were there...when I was eating a taco, so I know they were there when I was home.

TP: And so about what time do you think the call came from, Laymon said, ah, his brother Chris...

JA: Uh-huh (affirmative)

TP: Was he there about 10:30 or 11? Is that right?

JA: Yeah. I want to say the call probably came by midnight.

TP: Ok. And when he got off the phone he told you that it was his brother, is that...

JA: Yeah, he said his brother was coming over and that was it.

TP: Ok. When you said you were going to Walmart to match the paint...did you already looked at the beds?

JA: Yeah, I went to ah...I picked out the comforters like prior, like a month prior and picked up the comforters and stuff and put those in lay-a-way at Walmart.

TP: Ok.

JA: So I was jut trying to match the colors to put the paint...

TP: Oh I see. Ok. Anything else?

TF: Huh-uh (negative)

JA: Did I answer all your questions?

TP: All the ones I have now...

JA: Sorry about...

TP: No, your fine, don't worry about it. Don't worry about it. You know if we do have any more questions I don't want you to be upset if we call you because...

JA: Well you know where to reach me, I'm not quitting any of my jobs or running from anybody so..

TP: We didn't think you would. You work too hard to do all that. What do you do at Baptist?

JA: I, well I haven't taken (inaudible) but my RMA, I work for Doctor Murray.

TP: What kind of doctor is he?

JA: Ah, gastronologist, he's a specialist.

TP: Gastroenterologist, I could never say that real well, it's a long...

JA: (inaudible)

TP: It's a long word.

JA: Big long word, have to look at it every time I have to go spell it for something. (inaudible)

TF: You're an RMA?

JA: Uh-huh (affirmative), Registered Medical Assistant and Phlebotomist. He has those people in the doctor's office that you always thinks that is nurses or call you back and take ...

TF: Draw your blood?

JA: Blood pressure and draw, draw your blood and take temperature and stuff...

TF: You're a Phlebotomist?

JA: Yeah. That's us.

TP: And your number there is 945...

JA: 4415, extention 2, 242.

TP: And that rings right into his office?

JA: No, that's my phone.

TP: Oh is that?

JA: My phone.

TP: This is your phone ?

JA: Well all phone, all phone calls are screened. We have designated people that answer the phoe. So that person answers the phone and then will determine who it is and then they'll call me and let me know so and so's on the phone for you.

TP: Ok. What ah, suite is this doctor in?

JA: 400.

TP: Is that in the middle of the tower?

JA: Ah, Physician's Building D.

TP: Ok. Ah...

JA: Is Laymon in trouble, I mean cause my kids come back next month and...I don't want, I want to know if he's in trouble, I mean...

TP: What do you think he could be in trouble for?

JA: Well I don't know but, you all are asking all these questions and wanted to know where he was and stuff ...

TP: And you've answered all my questions...



JA: I was just wondering if...I mean I know he was with me that night and I know that he idn't go anywhere, so I'm just saying...

TP: And that's kind of what we needed to know.

JA: Ok.

TP: So ah...if we think of anything else we might give you a call, so don't be upset if we do. Might just be something that Tony and I are gonna think about...

JA: Ok.

TP: To task you at the time. I figure that happens, so don't worry about it. Ok?

JA: Alright.

TP: Uh...

JA: (inaudible)

TP: That's really all I need. Well this is technically our day off.

JA: Oh I'm sorry.

TP: No, that's alright. It's alright, we wanted to make sure that ..

JA: (inaudible) (laughing)

TP: Doesn't sound like you do. Done?

TF: Done

TP: Ok. Thanks Jennifer from coming.

JA: Yeah.

TP: We'll help you get back out.

4 Pfeiffer: We don't want you to pass out.

5 Watson: Oh ok.

6 Pfeiffer: Ok. Talitia spell your first name for me.

7 Watson: T A L I T I A

8 Pfeiffer: T A L I T I A

9 Watson: Yeah.

10 Pfeiffer: It's Watson?

11 Watson: Uh-huh (affirmative)

12 Pfeiffer: W A T S O N?

13 Watson: Yeah.

14 Pfeiffer: And your date of birth?

15 Watson: 4/12/80.

16 Pfeiffer: Ok, social security number.

17 Watson:

18 Pfeiffer: Ok, today's August the 12<sup>th</sup>, '99. Ok...we want to talk to you about July 28<sup>th</sup>, '99  
19 and we saw you guys on the morning of the 31<sup>st</sup> eventually. What I'd like to know is if you had  
20 been with uh, Analiese, I guess it's Julius Jone's girlfriend, or one of his girlfriends.

21 Watson: Uh-huh (affirmative)

22 Pfeiffer: If you had been with her on...

23 Watson: (inaudible)

24 Pfeiffer: On Wednesday, that Wednesday before the Saturday that we saw you you guys at  
25 your apartment.

26 Watson: I wasn't with her Wednesday.

27 Pfeiffer: Were you with her Thursday?

28 Watson: No. I didn't, I didn't see Anna till Friday night. Friday.

29 Pfeiffer: You didn't see who?

1 Watson: Anna.

2 Pfeiffer: Oh you call her Anna?

3 Watson: Yeah.

4 Pfeiffer: Ok.

5 Watson: I didn't see Anna till Friday when I got off of work.

6 Pfeiffer: Ok. And tel me about your day that day.

7 Watson: Friday...when I got off of work?

8 Pfeiffer: What time was that?

9 Watson: I got off at 5 and then I probably went home. When I got to my house (inaudible)

10 was watching the news and I saw, I, caught in the end of it, so I thought they had said it was a

11 shooting. So I called Anna and I was like, "Ann, did you see the news?" And she said uh, she

12 was like, "What?" I said, "There was a shoot out on 122<sup>nd</sup> and uh, Greystone. And shen said,

13 "No, what do you know," like, "have you talked to Julius?" I said, "that's what the news said."

14 So she was like, "No," She said, "Yeah I talked to Julius earlier," and so then she was like, "but

15 that ain't him," so she turned on the news and she watched it and then she was fine. "That ain't

16 the (inaudible) we kind of argue back and forth. And then she was being uh...I was watching it,

17 continued watching it and uh...I found out it wasn't a shooting, so I said, "Well I'm getting ready

18 to go," and we was suppose to be going out to eat that day. Me an Anna was going to Ted's, to

19 go eat, and so I was like, "Well I'm just gonna drop my brother off and go by my Daddy's house

20 and then I'll be on my way to pick you up." So I went home and then, oh I went to my Daddy's

21 house, and dropped my brother off and from there I went to pick Anna up. And uh, when I got

22 over to her house and I walked in I was like, "Are you ready?" And she was like, "No." And she

23 said, "I haven't even got my stuff ready yet because Julius," (inaudible) the thing on the news

24 was about his, you know, his house, they was looking for him. And I'm like, "Are you

25 thrilled?" And she was like, "Yeah." So we was sitting on the couch and uh, he kept calling

26 over and over again and she was talking to him and stuff and I was like, "Did he really do it?"

27 You know trying to find if he had really did and everything. And so she starts saying, he was

28 trying to tell her to come over. He wanted her to come see him because he said he was gonna

29 leave. And I said, I was like, "I'm gonna take you over there, because..."

1 Fike: Over where?  
2 Watson: Over to where you found him at, at that apartment complex.  
3 Pfeiffer: Is this on the South Side?  
4 Watson: Uh-huh (affirmative)  
5 Pfeiffer: Do you know the name of it?  
6 Watson: The uh...one, was it...Warwick Apartments?  
7 Pfeiffer: Do you remember what street you drove on to take her there?  
8 Watson: (inaudible) when we went over there it was the apartments on the...it was across  
9 from the highway, I forgot, I want to say the Warwick Apartments. Uh, I guess its by, right  
10 across from the Highway Patrol...  
11 Pfeiffer: Could it have been the Pickwick Apartments?  
12 Watson: Yeah, Pickwick, yeah.  
13 Pfeiffer: Ok.  
14 Watson: That's what it was.  
15 Pfeiffer: Ok. But she said he'd been calling, or you were there when he was calling.  
16 Watson: Yeah, he had been calling the whole time we were there.  
17 Pfeiffer: Ok, just like, would she talk to him for a few minutes, hang up and then he'd call  
18 back?  
19 Watson: Yeah.  
20 Pfeiffer: Or...  
21 Watson: He would, she was on the phone with him, the line beeped and she would click  
22 over and it was him and then she would talk for him for a few minutes and then she would get  
23 off the phone and he would call back. And then he, and he just like, he constant, he called back  
24 3, I'd say about 3 or 4 times. So I was on the phone talking to her to my friends and he had  
25 called.  
26 Pfeiffer: At her house?  
27 Watson: Yeah, at her brother's house. And he had tripped, her brother's apartment, yeah.  
28 And he had called and I had clicked over and I, and it was him on the phone and he kept saying,  
29 "Man, you're not gonna bring her over here? You're not gonna bring her over here?" I was like,

1 “I, I do not want to get caught up in this.” I didn’t want to get in the middle of it. That’s when  
2 she kept begging me and she was like, “Talitia, just take me to see him, just, you know, before he  
3 leaves, moves to, whatever.” So...

4 Pfeiffer: When he says he’s leaving what?

5 Watson: He kept saying he was leaving...

6 Pfeiffer: Like leaving where? The state?

7 Watson: Yeah. That’s what he said he was gonna leave the state.

8 Pfeiffer: Ok. Did he say why?

9 Watson: And he said why he was gonna leave, Huh-uh (negative) he didn’t say why, he  
10 just said, he was gonna leave because the whole time he kept telling her he didn’t have anything  
11 to do with it. The whole time on the, whole phone conversation. Whenever they would talk  
12 throughout the day, that day, he kept telling her he didn’t have nothing to do with it. He didn’t  
13 even mention it to her until uh, after I told her it had been on the news, cause she had talked to  
14 him earlier that day at work, and he had never mentioned it. And so, uh, when I took her over  
15 there to see him...

16 Pfeiffer: About what time was that?

17 Watson: I would say around, I would say around 7. Cause I, I (inaudible) between 7 and  
18 7:30.

19 Pfeiffer: At night?

20 Watson: Uh-huh (affirmative)

21 Pfeiffer: And this would have been on Friday the 30<sup>th</sup> of July?

22 Watson: Yeah. Is there, yeah. It was Friday the...and so uh...we went over there she just  
23 come, he was just walking to the car and he saying he wanted her to call him if he, you know, if  
24 he pages her. And she was like “I can’t call you if you page me.” So then he gave her some  
25 money and then he kissed her and he left. And then we left. And this other dude, another guy  
26 came up while we were pulling off. And they were over there talking and he was like saying, he  
27 sees, the other guy was like, “well we gotta move.” And he said, “Well where we gonna go?”  
28 And then they looked at us like, he said, “Well where are they going?” But they was gonna try  
29

1 to get this, get us to take them somewhere. But I didn't turn around to look at them, I just kept  
2 driving. And we left.

3 Pfeiffer: What's this guy look like that walked up and was talking to 'em?

4 Watson: He was uh...he was probably about maybe a shade or 2 shades darker than me.

5 Pfeiffer: So it was a black male?

6 Watson: Uh-huh (affirmative) He was kinda tall. He was skinny, not real skinny, but he  
7 wasn't, he was slender, (inaudible) he was pretty skinny, probably like ah....I don't know,  
8 medium size. Probably about the size of that guy that came in here with you and me. He would  
9 have been about his size.

10 Pfeiffer: Ok.

11 Watson: But he wasn't that tall. I don't think he was as tall as h im.

12 Pfeiffer: Ok. Uh...what was he wearing?

13 Watson: It was, it was, it was another guy out there too. So it was 2 guys and Julius. So it  
14 was 3 guys.

15 Pfeiffer: Describe the other guy for me.

16 Watson: Other guy was uh, he was a white male, he was...he was kind of short. He was  
17 kinda short, mabe about probably about 5'9. And he had short hair. Short blonde hair. I want  
18 to say, I want to say he had on a cap when we saw him.

19 Pfeiffer: The white guy?

20 Watson: Uh-huh (affirmative)

21 Pfeiffer: About how old do you think he was?

22 Watson: I;d say about 22.

23 Pfeiffer: 22?

24 Watson: I might have been 21 or 22.

25 Pfeiffer: Ok, how about the black guy?

26 Watson: The black guy basically he looked like he could have been about 22 or 23.

27 Pfeiffer: And you've never seen them before? Did you know any of Julius' friends?

28 Watson: I only, the only person that remember was uh, was Westside, but I didn't really k  
29 now him that good. He had came over, he'd been over to my house I think twice. And I had...

1 Fike: Go ahead.

2 Watson: And I had seen him, like uh, when Anna picked him from work one day and took  
3 him home. But after doing that I didn't really hang around with or nothing...

4 Pfeiffer: Where did Westside work?

5 Watson: Whataburger.

6 Pfeiffer: Ok. And when did she pick him up and take him home?

7 Watson: From work? Oh this was probably like...uh...probably the weekend end of June.  
8 Wait no, the middle, either the middle of June or the beginning of July. It was 11 though,...

9 Pfeiffer: And she picked him up?

10 Watson: Uh-huh (affirmative)

11 Pfeiffer: What was she driving?

12 Watson: She was driving, well see Julius and Little Westside had went in half on the car.

13 Pfeiffer: What car?

14 Watson: The claimed they went half on the car. It was uh, uh, brown, it was a old brown  
15 Cutlass. And so they were sharing the car and Julius (inaudible) I guess he didn't have a  
16 driver's license or I don't know what the deal was. So Anna would drive the car and she'd drop  
17 Julius off at home and then she would go pick up Little Westside from work and take Little  
18 Westside home.

19 Pfeiffer: Does Anna have a car?

20 Watson: Huh-uh (negative)

21 Pfeiffer: Does she have access to a car?

22 Watson: Sometimes her brother let, let, if her brother's at home, then sometimes he'll let  
23 her drive his car.

24 Pfeiffer: What kind of car does he have?

25 Watson: A Mazda 626.

26 Pfeiffer: Is it an old one or a new one?

27 Watson: It's probably a '95.

28 Pfeiffer: Ok. What color is it?

29 Watson: Burgundy.

1 Pfeiffer: Ok. So you met Westside that one time?

2 Watson: It (inaudible) the last time I met him. I don't think, ok, yeah the first time I met  
3 him was when he worked at Whataburger. And we picked him up from work and we took him  
4 home and then later on that night he called back and he wanted uh...Julius, it was probably about  
5 11. He wanted me to...Julius to come back and pick him up and give him the car so he could go  
6 somewhere. And so Anna went back and picked up Julius and took Julius back over to  
7 Westside's house and then they dropped Anna back off and Julius and Westside left.

8 Pfeiffer: Was Anna with you at your apartment?

9 Watson: Uh-huh (affirmative) Cause first, Anna stayed with me basically all of May  
10 and...probably about 2 or 3 weeks of June, she lived with me.

11 Pfeiffer: Why was she living with you?

12 Watson: Well cause uh...she moved out of her father's house, he didn't, he didn't really  
13 like, her father's real...me and Anna grew up together. Her father is real, real strict. And he  
14 kind of, he comes from a abusive family, so sometimes he tends to trip a lot with her. And  
15 (inaudible).

16 Fike: He tends to what?

17 Pfeiffer: Trip a lot.

18 Fike: Trip a lot?

19 Watson: Ok, I'm sorry, you might be...

20 Pfeiffer: Yeah, I got it, I got it.

21 Watson: Ok.

22 Fike (inaudible)

23 Watson: Uh?

24 Fike: Throws a fit?

25 Watson: Yeah. He does and we'll be...he doesn't like her uh, hanging around me because  
26 he said I was grown because I had other (inaudible) and I had a job.

27 Pfeiffer: What's her dad's name?

28 Watson: Gossie, Gossie.

29 Pfeiffer: (inaudible)



1 Fike: That's his first name?

2 Watson: Uh-huh (affirmative)

3 Pfeiffer: A G?

4 Watson: O S S I E .

5 Pfeiffer: Gossie (inaudible), where's he live at?

6 Watson: He lives on 115<sup>th</sup>.

7 Pfeiffer: In Oklahoma City?

8 Watson: Uh-huh (affirmative)

9 Pfeiffer: North or South?

10 Watson: Northwest.

11 Pfeiffer: What's he do for a living?

12 Watson: He works in Metro Tech.

13 Pfeiffer: That is...

14 Watson: (inaudible) so he didn't really, he didn't really know anything about Anna and  
15 Julius. And I think she and Julius just kind of were off and on dating for like 2 years. And then  
16 moved in with me, that's when, like probably about 3 or 4 months before she moved in with me  
17 was when she started, they kinda like seeing him every once in a while. Then after she moved  
18 in me she just like, you know, had her own freedom so then she saw him almost everyday. Came  
19 over everyday.

20 Fike: He did?

21 Watson: Oh yeah.

22 Pfeiffer: And what, what time frame are we looking at that she lived with you?

23 Watson: Between, the beginning of May till the middle of June.

24 Pfeiffer: And when you said oh yeah, was there a problem with Julius coming over there?

25 Watson: I don't really like having a lot of company, so I didn't really like the idea that he  
26 came over everyday and spent the night all the time. And she would like, and he would like  
27 sometimes I would go to work and I would go to work and she wouldn't go to work so then  
28 she'd be there with him all day. And she was, to me I feel like he was coming in the way of her  
29 working, cause you know she had to make money to help pay bills too.

1 Pfeiffer: Ok.

2 Fike: Does Trey live there with you?

3 Watson: Uh, well he's been staying with Pee Wee for the past week. He just started  
4 staying there.

5 Pfeiffer: He's not inviting a lot of people over is he?

6 Watson: Huh-uh (negative) Oh no, my brother doesn't really have a lot of company. He's  
7 just uh...

8 Fike: He works all the time doesn't he?

9 Watson: Yeah basically. He works a lot. He's hardly ever there. Unless it's late at night  
10 and he comes from like, if he goes (inaudible) he spends a lot of time at (inaudible) house or  
11 working or with his friends so...I don't really deal with him a lot.

12 Pfeiffer: Going back to the day that you're at Anna's apartment...

13 Watson: Yeah.

14 Pfeiffer: Analise Presley's apartment and she's getting at least 3 or 4 phone calls from  
15 Julius. And when you were on the phone once...

16 Watson: Uh-huh (affirmative)

17 Pfeiffer: He also beeped in and he was asking you to bring her over there.

18 Watson: Uh-huh (affirmative)

19 Pfeiffer: And you drove, about between 7 and 7:30 P.M., you drove over to the Pickwick  
20 Apartments, right?

21 Watson: Yeah.

22 Pfeiffer: And you...she talked to him, he gave her some money, he kissed her and as you're  
23 pulling off, two guys come up one's a white guy, one's a black guy...

24 Watson: When we pulled up to the apartment, we were driving by and we were looking, I  
25 don't even know where he was at. And the light guy was sitting on the uh...like the heater or  
26 whatever it is (inaudible). And he said uh, he hollered, "Hey come back." and so you know we  
27 were first, he said, "Are you all looking for somebody?" and it was like Julius? And it was like,  
28 "yeah," so we parked and he called 'em, he called like upstairs, he called 'em on the cell phone.  
29 And then Julius came down stairs. So while Julius, after, right after he walked off this car pulled

1 up behind me and I was like, “ Am I in his space,” you know I didn’t know if I was (inaudible),  
2 and I was like, “Oh don’t worry about them, they ain’t gotta you know, uh, assigned parking  
3 here.” And so then I (inaudible) I pulled back a little bit so I could get out and then the guy  
4 stepped out of her car.

5 Pfeiffer: Ok, what kind of car was this?

6 Watson: It was a silver or gray uh, Oldsmobile like the 4 door Oldsmobiles.

7 Pfeiffer: Ok, older, newer?

8 Watson: It was older, probably uh...I would say maybe a ‘88, or ’89.

9 Pfeiffer: Ok. And so and a while female was driving it?

10 Watson: Uh-huh (affirmative) She (inaudible).

11 Pfeiffer: Ok. Was there anybody else in the car with her?

12 Watson: Just them two (inaudible).

13 Pfeiffer: Ok. And this guy gets out and then what does he do?

14 Watson: He just, he just gets out, he closes the door, he gets out, and Julius had already  
15 walked off so he walks over toward Julius and the other guy standing and they started talking.  
16 But when he’s walking up, he walks past my door and I had my window rolled down so I  
17 (inaudible) and he was like, “We need to move,” and he said, “Well we gonna go.” And then he  
18 was like, “Well where are they going?” And that’s all we heard cause after that I drove off. She,  
19 I didn’t even know he said a word, they going, when I drove off she said, “You know what they  
20 was gonna try to do?” I said, “What?” She was like, (inaudible). I said, “Huh-uh (negative)  
21 I’m not gonna (inaudible) with them in my car.” And she said, “Well, uh,” I said, “I think, I  
22 didn’t even hear ‘em say that. I just heard ‘em say uh, you know, we need to move.” It’s like  
23 “where we gonna go that’s all I heard ‘em say.”

24 Pfeiffer: Where did the black guy come from?

25 Watson: Which one?

26 Fike: The other car, right?

27 Watson: Uh-huh (affirmative)

28 (inaudible)

29 Watson: The black guy came up...

1 Pfeiffer: (inaudible)

2 Watson: The black guy came out the car.

3 Fike: With the blonde headed girl?

4 Watson: Yeah. And the other guy was sittin' on the uh...

5 Pfeiffer: So he was already there?

6 Watson: Yeah.

7 Pfeiffer: Ok. Ok. So then you pull off, do you hear Julius again?

8 Watson: Huh-uh (negative) I don't (inaudible) I didn't hear nothing else from Julius that  
9 night.

10 Pfeiffer: Ok. So where do you guys go when you leave there?

11 Watson: When we leave there we went to the gas station, from the gas station we went  
12 back to my house, from the gas station we went back to my house and then after we got my  
13 house we was trying to debate on if we wanted to go to a football game or not. And so we  
14 decided we'll go to the football game.

15 Pfeiffer: And where's the football game?

16 Watson: It was at UCO.

17 Pfeiffer: Ok.

18 Watson: And so we went to eat at Ted's, the Mexican Restuarant, and then after that we  
19 went to my father's house and I went and got the, the blow dryer from my daddy's house and  
20 then I went home. We went home.

21 Pfeiffer: Ok.

22 Watson: And (inaudible) ready by to the movies. And while we was getting ready to go to  
23 the movies he paged her, but he didn't put a phone number in, he just put "I Love You" in. And  
24 then after that (inaudible).

25 Pfeiffer: About what time was that do you think?

26 Watson: That he paged her?

27 Pfeiffer: Uh-huh (affirmative)

28 Watson: Let's see it was probably around...11. Because we went to the movies at 12 so it  
29 would be between 11 and 12. Somewhere in between there.

1 Pfeiffer: Ok. Did you go to the movies just you two?

2 Watson: Uh-huh (affirmative)

3 Pfeiffer: What'd you see?

4 Watson: Uh-huh (affirmative) We went to see "The Haunting".

5 Pfeiffer: Was it scary?

6 Watson: Not really (laughs). This one uh...(inaudible) I don't think it scares you right  
7 then but maybe one day you're home by yourself if you hear something you might think about  
8 the movie.

9 Pfeiffer: Ok. Did she talk about Julius at all?

10 Watson: Huh-uh (negative) She didn't talk about it, I kept asking her, you know, how  
11 was she, how did she feel about the whole situation, you know, and she was just like...I don't  
12 know, she just kept saying, "I don't know." She don't want to talk about it. I was like, "You  
13 don't feel sad or anything? Don't you feel bad for him anything?" She just like, she was like,  
14 "No." She didn't say nothing else about him. But every, black people kept calling asking this  
15 and this, cause everybody knew that was her boyfriend, so people was calling and asking and  
16 stuff and I was like, "I don't know nothing.

17 Pfeiffer: They were calling you at your apartment?

18 Watson: Yeah, they were calling at my apartment. And I was like, I was on the other end  
19 of the you know, him telling us that he didn't do it. That's all I knew. You know, I didn't know  
20 nothing else about Julius.

21 Pfeiffer: Ok.

22 Watson: And I was like asking her because for a while, before they had been, for that  
23 whole week, he was with her after she stayed with her brother he would go over there and see her  
24 at her brother's house every night. And so I kept thinking, I was like, "So have you been seeing  
25 him (inaudible)." She was like, "No, I didn't see him," it's like she said, talked to him  
26 Wednesday. But she saw him when we went by.

27 Pfeiffer: What time did she talk to him?

28 Watson: She, it had to been after 9, cause it would have had to have been after uh...after  
29 she got up to church, so I think she said it was like, oh about 9:30.

1 Pfeiffer: She talked to him about 9:30?

2 Watson: Yeah. I want to say 9:30 but...I know it had to be after 9:00 cause she went to...I  
3 know she went to church, she said she didn't talk to him till afterwards.

4 Pfeiffer: Ok. What time does she go to church?

5 Watson: From 7:15 to 9:30.

6 Pfeiffer: Ok and what church does she go to?

7 Watson: The King (inaudible) Jehovah Witness.

8 Pfeiffer: Say that one more time.

9 Watson: The Kingdom Hall, so she's a Jehovah Witness.

10 Pfeiffer: Kingdom Hall?

11 Watson: Yeah.

12 Pfeiffer: Ok is that around... where she lives?

13 Watson: Huh-uh (negative) the one she went to is on uh, the north, the east side of town.  
14 (inaudible)

15 Pfeiffer: And who's she go with?

16 Watson: She went by herself that night, I think she went by herself or with her mother.

17 Pfeiffer: You think her mother? Who's her mother?

18 Watson: Cornel Presley.

19 Pfeiffer: Cornel, does she live with her dad?

20 Watson: Uh-huh (affirmative)

21 Pfeiffer: So their still married?

22 Watson: Uh-huh (affirmative)

23 Pfeiffer: Ok. So they go over there and she says she did talk to him after she got back  
24 from church?

25 Watson: She said he paged her and so she talked to him after she got out of church.

26 Fike: What day is this?

27 Pfeiffer: Wednesday.

28 Watson: Wednesday.

29 Fike: Wednesday night, the 28<sup>th</sup>?

1 Pfeiffer: Uh-huh (affirmative)

2 Fike: What time was that?

3 Pfeiffer: Well would have to been after 9:00. That's... Uh...so did she say he said anything  
4 that night when she talked to him?

5 Watson: He didn't mention it, she said she ask him what all he was doing and he said him  
6 and some of his friends was getting drunk. And she ask him who he was with and he told her he  
7 was with Little Westside and uh...Little Westside's brother, Laymon, I think, yeah. He was with  
8 them.

9 Pfeiffer: That's what he said?

10 Watson: Uh-huh (affirmative)

11 Pfeiffer: Ok. Did she ever tell you that she saw him with a gun before?

12 Watson: Huh-uh (negative) She didn't tell me until I...

13 Fike; Sure?

14 Watson: Asked her. After all that has happened...

15 Fike: She did tell you after it happened?

16 Watson: After all of this happened I was like uh...probably was talking about the, you  
17 know everything goin' on and stuff, and I said uh... "Did Julius even pack a gun?" And she said,  
18 we, she said, "Well yeah I've seen him with a gun before." Cause see she had told me, cause  
19 right before that uh it had been like the weekend, right before all this happened. She, we had all  
20 went out one night and uh...

21 Pfeiffer: Who's all?

22 Watson: Well me, her, it was me, and another, my friend, Wyesha and this girl named  
23 Kiesha, we had (inaudible) at the club. And Julius had pulled up and I wandered what, why all  
24 this was happening but she was telling me like the next day he was really tripping with her, he  
25 wanted her to be with him and she wouldn't get in the car with him. So he had like slammed the  
26 door and drove off. And he was you know, throwing stuff around in the car. And I was like, I  
27 said, "Anna, you need to leave him alone." And I said, "Because he's acting like this over you,  
28 how do you think he's gonna act if he sees you with somebody else?" You know, I said,  
29 "There's no telling what he ca n do. I and, that's to say I never was, think Julius would really

1 kill somebody, you know, but i kept saying, “You never know what he would do.” I said,  
2 “There’s cases all the time you know, guys, you know, in love with this woman or whatever they  
3 claim being, (inaudible) kill the other guys, I say, “you need to be careful because he might get  
4 mad at you and he might hurt you and hurt him.” And she kept saying, “No, I don’t think he  
5 would do that.” I don’t think he would do that.” And she was telling me how he was just you  
6 know, really trippin’ (inaudible). But she wouldn’t leave him alone. And I couldn’t make her  
7 leave him a lone. But she never mentioned, she never mentioned a gun to me.

8 Pfeiffer: But when you ask her about it what’d she say about the gun?

9 Watson: When I ask her about it then she said she had saw it beofre.

10 Pfeiffer: This is after the murder?

11 Watson: Uh-huh (affirmative). This was after he had got arrested. After everything  
12 happened. Cause I’m, you know I was trying to find their little bank. So I was asking her like  
13 probably with the end of last week, or week and a half, is when I ask her about it, (inaudible) if  
14 she has seen it before.

15 Pfeiffer: And did she tell you what kind of gun it was?

16 Watson: Huh-uh (negative) I didn’t ask her. I just ask her had she seen her with a gun  
17 or...

18 Pfeiffer: And what’s she say?

19 Watson: She said she had filed before.

20 Pfeiffer: Did she say where she was when she saw him with the gun?

21 Watson: It think they, I want to say they were in the car when she saw it

22 Pfeiffer: Is that what you remember her saying?

23 Watson: That’s what I’m thinking, she, I’m trying to remember, it seems like she said they  
24 were in the car and when...

25 Pfeiffer: Did she ever talk to you about...uh, him stealing other cars?

26 Watson: No. She told me that they were suppose to, that weekend before he got arrested,  
27 she come telling me they were suppose to go to Dallas, but she never would would tell me why.  
28 And I was like, “Why you all going down?” I was like, “You all didn’t invite me.” And she  
29 said, “Well we’re just,” she said “He just wants to spend some time , you know, and get a way



1 or whatever, you know, just you know... And then later on, after all of this, after he got  
2 arrested, well not...I think it was, lets see what was it? Before he got arrested (inaudible) and we  
3 was talking and she said that they were suppose to go to Dallas that weekend and she was  
4 suppose to drive his car and he was gonin' t drive another car down there. And the other car he  
5 was suppose to dirve down there, he was suppose (inaudible) in Dallas. But she never had told  
6 me anything about him stealing any of it, any cars.

7 Fike: Did he say what kind of car he was going to sell?

8 Watson: She told me a Lexis.

9 Pfeiffer: Did she say what color it was?

10 Watson: Huh-uh (negative) she just said it was a Lexus .

11 Pfeiffer: Did she say where he got it?

12 Watson: She didn't say where he, she didn't tell me where he, she didn't tell me where  
13 he she got it or nothing. She just said, it's suppose to be that uh, he was suppose to be taking it  
14 to a chop shop, they were suppose to be doing something different to it and then uh, he was  
15 suppose to drive it to Dallas. But she said, she said he was only suppose to be the uh...whatever  
16 you call the person that just use the vehicle, drives, takes it where it's suppose to go, get the  
17 money and that's it. Whatever that is. So I didn't know nothing about it. That's all I know.

18 Pfeiffer: Did, and when did she tell you this?

19 Watson: Friday.

20 Pfeiffer: This last Friday?

21 Watson: No, the Friday before he got arrested.

22 Pfeiffer: So that would have been the 30<sup>th</sup>?

23 Watson: Yeah.

24 Fike: The day before he got arrested?

25 Watson: Yeah, like today, the day I came over...

26 Fike: That night?

27 Watson: That night. She had told me.

28 Pfeiffer: So Saturday night? Or Friday night? Was it before you saw us?

29 Watson: Like Friday night, Saturday morning I think.

1 Pfeiffer: Was it before you saw us though, cause you saw us Saturday...

2 Watson: No, it was before I saw you all.

3 Pfeiffer: Ok, so Friday she told you this and this was after the police were looking for him  
4 and all this stuff?

5 Watson: Yeah.

6 Pfeiffer: Ok. Uh...did she saw anything about or did she say he had said anything about  
7 doing any other cars? Or being the delivery person for any other cars?

8 Watson: Huh-uh (negative) Nuh uh, other than the Lexus, that's the only one I know  
9 about.

10 Pfeiffer: Did...Julius work anywhere?

11 Watson: He was 'pose to be working at uh, Dial America.

12 Pfeiffer: Dial America?

13 Watson: Uh-huh (affirmative), he told me he was working at Dial America.

14 Pfeiffer: Did he, when did he tell you that?

15 Watson: Uh...I think it was like, you know, it was like, (inaudible).

16 Pfeiffer: Ok. Did she say anything to you about another woman that he supposedly...uh  
17 was having relations with named Dorsheitha?

18 Watson: She didn't tell me nothing about that until...last week when we was talking and  
19 she said that uh, he's suppose to have a baby on the way. By Dorsheitha. It's the first time I  
20 heard anything about Dorshitha having a baby. Or him and Dorsheitha even messing around.

21 Pfeiffer: Do you know who Dorshitha is?

22 Watson: I don't know Dorshitha I just know....I've heard her name around a lot by  
23 different people but I don't really know Dorshitha. I just, I've seen her before but...

24 Pfeiffer: You have seen her before?

25 Watson: Uh-huh (affirmative)

26 Pfeiffer: How did you know it was her?

27 Watson: Because my cousin told me. She usually stay over there behind uh...I don't know  
28 she'd just over there where my father stays. And my cousin had told me who Dorshitha was,  
29 because my cousin was going with this one guy and Dorshitha was talking to his cousin. But

1 my cousin and Dorshitha had got into it. So she had shown me who Dorshitha was when I saw  
2 her on the street.

3 Pfeiffer: Who's your cousin?

4 Watson: Her name is Taria Wright.

5 Pfeiffer: Ok. No, it's ok. Yeah. Uh...Did she tell you not to say anything to the police  
6 when we got there that night? Would have been Saturday morning the 31<sup>st</sup>? Did she say, don't  
7 say anything?

8 Watson: We didn't...(inaudible)nah uh, cause when y'all came we all were asleep. And I  
9 had actually forgotten that the police was still coming over. And so then when we heard ya at  
10 the door she just, she went in there and answered the door. I had totally forgot y'all were  
11 coming. So we didn't even talk. We went to sleep right after she got off the phone. I don't  
12 even remember if she got off the phone. I just remember giving out the address and that they  
13 said they were on their way. And then I went, I laid back in the bed and went to sleep and she  
14 went to sleep.

15 Fike: Ok, when I came in and talked to you...

16 Watson: Uh-huh (affirmative)

17 Fike: And ask you if you'd seen Julius that day.

18 Watson: Uh-huh (affirmative)

19 Fike: You said no. You were lying right?

20 Watson: Yeah.

21 Fike: Why did you lie?

22 Watson: Because I, I really didn't want to get caught up in this mess. I really didn't want  
23 to get caught up in it, that's why I was...plus I'm, I'm scared of retaliation and I didn't want nobody  
24 to know, cause I figured only way their gonna know if they find him it's because we say  
25 something and I don't want nobody coming up to me and so I, that's the only reason why.

26 Fike: Ok. And you were present when, when Analliese was lying to me about it too,  
27 right? Why did you all finally decide to tell the truth? Or...just kept talking about it?

1 Watson: Yeah. And I know it would ah been on my conscience if I didn't, if I didn't say  
2 anything. I figured, you know, it would, it would bother me and I would feel like I should have  
3 been more honest.

4 Pfeiffer: Did Analiese tell you anything a conversation she's had with Julius since he's  
5 been incarcerated about uh...he believes he was seen on a security camera dropping off the stolen  
6 suburban?

7 Watson: Huh-uh (negative) I ask her and when she told me she'd spoken with him and I  
8 like ask her, we was at Taco Bell, and she said, "Oh nothing he just, uh, I ask him about  
9 Dorshitha and he was like, (inaudible) (End of Side A of tape.)  
10 (Beginning of Side B of tape)

11 Watson: And she was saying he said that it was an accident, he didn't mean to do it.  
12 Something else, but I've heard a lot things about Dorshitha and all and I don't know how  
13 trustworthy she really is.

14 Fike: You said that Dorshitha was talking to Julius, Julius was telling that he did it, shot  
15 him by accident and she would switch over to another line and tell somebody else on that other  
16 line, right then but Julius told her that he did it. That's the guy that was over at your apartment  
17 telling Analiese that.

18 Watson: That's what he was saying.

19 Pfeiffer: And who's the guy?

20 Watson: I don't know his name. He was just, it was one of Anna's friend's friends. Like  
21 when their, our friend's Tory, it was her friend. Some guy she had just met or something.

22 Pfeiffer: So he's telling you about this?

23 Watson: I walked in right in the middle of the story I had just got off of work. I work at  
24 the mall too some and I came home from the mall he was the phone. I mean Anna was on the  
25 phone and he was telling Anna and Tory and I was in a hurry cause I was leaving to go over to  
26 my grandma's house and I had to drop everybody (inaudible) I was trying to get all my clothes  
27 together and so...

28 Fike: He wasn't there or he was there?

29 Watson: Who? The guy?

1 Fike: The guy?

2 Watson: Yeah, he was there...

3 Fike: He was there and he was on the phone too?

4 Watson: No, Anna was on the phone.

5 Fike: Ok.

6 Watson: And Tory was sitting on the couch and he was at the end of the couch and he was  
7 telling Tory and I don't know if Anna was really paying attention since she was on the phone,  
8 but I think she might have been. And he was just saying how Julius was uh, on the phone telling  
9 Dorshitha, you know, that he didn't mean to do it, it was an accident and he was, and at the same  
10 time while he was telling her she was clicking over on the other line and telling somebody else  
11 the same thing that he was saying.

12 Pfeiffer: How would this guy know that?

13 Fike: Did Dorshitha tell him that?

14 Watson: No.

15 Fike: She didn't, Dorshitha didn't tell this guy...

16 Watson: No, I guess the guy who, whoever Dorshitha was telling must have, must have  
17 told him or must have told somebody else so it just kind of got around, it's just ah... you know,  
18 cause I don't think she was telling him on the phone.

19 Pfeiffer: And when was this conversation taking place?

20 Watson: Umm....about, not this past Saturday, the Saturday before that.

21 Pfeiffer: Ok.

22 Fike: After he was in jail?

23 Watson: Uh-huh (affirmative) It was after he was in jail.

24 Pfeiffer: Ok. Uh....Let me go back over my stuff here....and see if I have everything.

25 Fike: Have you ever met Laymon Jordan?

26 Watson: Huh-uh (negative)

27 Fike: That's Westside's brother. That guy you saw with the blonde headed lady, that  
28 stepped out of the car...

29 Watson: Uh-huh (affirmative)

1 Fike: Did he look anything like Westside?  
2 Watson: I don't know.  
3 Pfeiffer: If you saw 'em again do you think you could, would be able to identify 'em if you  
4 saw 'em again?  
5 Watson: I might be able to.  
6 Pfeiffer: Ok I'm just gonna hit a couple of the points on here, make sure I have this  
7 written down correctly. Uh...the night of July the 31<sup>st</sup> of '99, uh, you got off work, you got off  
8 work at what time?  
9 Watson: Five.  
10 Pfeiffer: Five o'clock? Then went to your apartment or drove straight to Analiese's  
11 apartment?  
12 Watson: I went to my apartment.  
13 Pfeiffer: So you went to Analiese's apartment, and which apartment is this?  
14 Watson: Where Anna stays?  
15 Pfeiffer: Uh-huh (affirmative)  
16 Fike: Said she went to her apartment.  
17 Pfeiffer: You went to your apartment first?  
18 Watson: Yeah. I went to my apartment first.  
19 Pfeiffer: Then you drove to Analiese's apartment.  
20 Watson: I went to my daddy's house after I left my apartment, then I went to Anna's.  
21 Pfeiffer: Ok and where is her apartment at?  
22 Watson: What is the name of those apartments? The one's on 59<sup>th</sup>.  
23 Fike: Pickwick?  
24 Watson: No, the one's (inaudible) brother stays in?  
25 Pfeiffer: Yeah, Hillcrest?  
26 Watson: Yeah.  
27 Pfeiffer: Ok. And then what happened?  
28 Watson: That's when we got there and she wasn't ready to go, so she was uh...that's when  
29 later on Julius had kept calling, the same day.

1 Pfeiffer: You're watching, she's the watching the news?  
2 Watson: Anna, we were watching the news.  
3 Pfeiffer: You guys already discussed this on the phone, right?  
4 Watson: Huh-uh (negative) We, well we had just talked about what happened on the  
5 news, but I hadn't, I didn't know Julius really had anything to do with it until I got over to her  
6 house.  
7 Pfeiffer: Alright. And then he calls 3 or 4 times while you were both there, you talked to  
8 him once.  
9 Watson: Uh-huh (affirmative)  
10 Pfeiffer: You end up driving her over there. Then you see all these people, you hear the  
11 things you heard and then you left.  
12 Watson: Uh-huh (affirmative)  
13 Pfeiffer: Then what'd she do?  
14 Watson: Well I left there?  
15 Pfeiffer: Uh-huh (affirmative)  
16 Watson: We went back to my apartment and the after, we went and got some gas and then  
17 went back to my apartment. Then after we went to my apartment we left and we went to my  
18 apartment and went out to eat. And then after we got, after eat went over to my daddy's house.  
19 Pfeiffer: Ok, where's your daddy live?  
20 Watson: Over on NE 38<sup>th</sup>.  
21 Pfeiffer: Ok. And then what happened?  
22 Watson: Then we go back home. And then I washed, I washed my hair and blow dried it  
23 and she was on the phone. Talking to one of her friends.  
24 Pfeiffer: Do you know who she was talking to?  
25 Watson: Christina.  
26 Pfeiffer: Who's Christina?  
27 Watson: Anna's friend Christina uh...  
28 Pfeiffer: Who's friend?  
29 Watson: Anna's.

1 Pfeiffer: Anna's friend?

2 Watson: Yeah. Christina uh, what's her last, I think her name is, her last name is

3 Warwick?

4 Pfeiffer: Warwick? Were they talking about this situation with Julius?

5 Watson: Yeah, cause she didn't, she was trying to see if Anna knew anything, so she could

6 find out some stuff.

7 Pfeiffer: Ok. And then what happens?

8 Watson: We, I think she's kind of off and on talking to other people at the same time. I

9 think she talked to Tory too. But...

10 Pfeiffer: Tory King?

11 Watson: Uh-huh (affirmative) during that time I was just uh, I was curling my hair so we

12 could go to the movies.

13 Pfeiffer: Ok. Then what?

14 Watson: Then after I got through with my hair we left going to the movies to see "The

15 Haunting."

16 Pfeiffer: What time was that?

17 Watson: The mov- that was around 12. I think the movie started like 12:10 or 12:15.

18 Pfeiffer: That's like midnight?

19 Watson: Uh-huh (affirmative)

20 Pfeiffer: Ok. What time did you get out of there?

21 Watson: What time we get to the movie? Probably about 2.

22 Pfeiffer: Ok. Did you know...that that was Westside's brother's place over there when you

23 drove over there? No?

24 Watson: I didn't even know, actually I had saw the number on the caller ID but I didn't

25 know who it was. I mean, Laymon Jordan. I didn't know who's number it was. I usually

26 sometimes, well sometimes I call the number back, but it had been an hour and a half so I didn't

27 even call it to see who it was. I didn't pay attention until after, after you all had came over.

28 Pfeiffer: Uh-huh (affirmative)

29



1 Watson: And y'all had left. And I was like uh, we was trying to find out, it was like, have  
2 they left? And they kept saying, yeah they matched up a number on her caller ID that was on my  
3 caller ID. And I didn't remember what number was on my caller ID until she told me that the  
4 number was. The number that he was calling from.

5 Pfeiffer: Oh ok. Ok. Ok...then we get with you that morning then...right?

6 Watson: Uh-huh (affirmative)

7 Pfeiffer: Ok. Uh you said you have had, have had conversations with her...I guess  
8 recently after Julius has been incarcerated that she had seen him with a gun?

9 Watson: Uh-huh (affirmative)

10 Pfeiffer: Ok. And you talked about that she said that was it the weekend before the murder  
11 that they were suppose to go to Dallas?

12 Watson: No, it was same weekend.

13 Pfeiffer: It was the same weekend they were suppose to go to Dallas?

14 Watson: Uh-huh (affirmative)

15 Pfeiffer: And so would have been the weekend before the murder or the weekend after the  
16 murder.

17 Watson: After.

18 Pfeiffer: And they were suppose to go to Dallas the weekend after the murders? And she  
19 said...tell me again what she said. Why that...

20 Watson: That they were, she was driving his car down there and he was gonna drive  
21 another car down there and he was gonna take it to the uh, he was suppose to take it to the chop  
22 shop and sell it in Dallas.

23 Pfeiffer: Ok. And she said it was what kind of a car?

24 Watson: A Lexis.

25 Pfeiffer: A Lexis?

26 Watson: Uh-huh (affirmative)

27 Pfeiffer: Ok. Do you know somebody names Erica?

28 Watson: Erica Rabon?

29 Pfeiffer: Uh, Erica's ex-boyfriend who wanted to beat Julius up?

1 Watson: Erica's ex...does she work at Walmart? I had heard about some girl who worked  
2 at Walmart that he was uh, suppose to be messing with.

3 Pfeiffer: And what was her last name?

4 Watson: This is a different Erica I was thinking about.

5 Pfeiffer: Oh ok.

6 Watson: The Erica, it was ah, some girl that (inaudible) at Walmart that Julius had been  
7 messing with. Anna said he told her, one thing he told her was that uh, she would be giving him  
8 money or something like that, she would give him money and then maybe letting him drive her  
9 car and stuff. Let me see. And right before, the weekend before all of that happened, he had  
10 called one of his ex-girlfriends, I can't remember what she said the girl's name was, but she was  
11 trying to figure out you know, if that was her boyfriend or what's he doing calling his ex-  
12 girlfriend. But I can't remember what her name was.

13 Pfeiffer: Ok. Then you said on Wednesday, this is when the murder occurred.

14 Watson: Uh-huh (affirmative)

15 Pfeiffer: That she had gone to church, and tell me that name again, the church.

16 Watson: Kingdom Hall.

17 Pfeiffer: Kingdom Hall, that's on the East side?

18 Watson: Uh-huh (affirmative)

19 Pfeiffer: Ok, and she went from South side, she went from South side at her brother's  
20 apartment where she was staying.

21 Watson: To the East Side.

22 Pfeiffer: To the East Side and they get out around 9?

23 Watson: Uh-huh (affirmative)

24 Pfeiffer: And she said that after 9 sometime, after she had gotten home that Julius Jones  
25 paged her?

26 Watson: Uh-huh (affirmative)

27 Pfeiffer: Did she say where he was when he paged her?

28 Watson: At uh, Jordan's, with Westside's brother's apartment. It was at Jordan's  
29 apartment.

1 Pfeiffer: Ok. That's where she said he was?

2 Watson: Uh-huh (affirmative) Well she said he was with ah....Little Westside and what's  
3 his brother's name? Chris or Laymon.

4 Pfeiffer: Chris is Westside.

5 Watson: Ok, so it was Laymon. Ok, yeah, he was at Laymon's.

6 Pfeiffer: Ok she, tell me, think about this for a second, I want to know exactly what she  
7 told you when he paged her, after 9 Wednesday.

8 Watson: Uh-huh (affirmative)

9 Pfeiffer: She says he said what?

10 Watson: She ask him where he was at...no, she ask him what he was doing first. And he  
11 said he was getting drunk with Little Westside and his brother, Little Westside's brother.

12 Pfeiffer: Ok.

13 Watson: And I assumed they were at Little Westside's brother's apartment. Because  
14 Julius can't go to the home and get drunk and he can get drunk at Little Westside's. I figured  
15 that's where they was at.

16 Pfeiffer: You just assumed that, but you don't know that?

17 Watson: Yeah.

18 Pfeiffer: Ok.

19 Watson: I want to say for sure because I don't know for sure that that's where they were at.

20 Pfeiffer: I understand. Ah...and you had said that that week or maybe the week before in  
21 that week that he had been going over to her apartment, where she stayed with her brother every  
22 night.

23 Watson: Yeah.

24 Pfeiffer: Kind of like he was doing at your apartment.

25 Watson: Yeah.

26 Pfeiffer: And so he would go on over there every night.

27 Watson: Even though I think that whole week, the week of the murder, I don't think he  
28 went over there that much that week.

29 Pfeiffer: You know why?

1 Watson: Huh-uh (negative) I just know they kept, they kept getting into it a lot, they kept  
2 having a lot of arguments.

3 Pfeiffer: What were they arguing about?

4 Watson: He was real jealous.

5 Fike: So they were tripping?

6 Watson: Yeah, they were, he was tripping.

7 Pfeiffer: Ok. Ah...

8 Fike: We talked about....they were with you and they were...

9 Watson: Yeah.

10 Pfeiffer: We're just confirming, don't pay any attention to us Talitia. Ah...ah...can you  
11 think of anything else?

12 Watson: No.

13 Pfeiffer: Can't think of anything else? And you never met Westside's brother, correct?

14 Watson: Huh-uh (negative) I never met him.

15 Pfeiffer: Ok. Did...

16 Watson: Westside, I didn't even know Westside had a brother until you know, Anna  
17 mentioned it.

18 Pfeiffer: So Anna knew that Westside had a brother?

19 Watson: Yeah.

20 (inaudible)

21 Watson: But I didn't know he had one.

22 Pfeiffer: Ok. Ah...and you don't know Demond Coleman?

23 Watson: I mean because when those guys followed Julius over there, we came over, Little  
24 Westside had, you know Little Westside would drop 'em off.

25 Pfeiffer: So they went there a lot?

26 Watson: I don't know... yeah, they just went to, yeah. After...I would say...after he got his,  
27 after they got a car. Which I wanna say was...be, around the beginning of June. He started  
28 spending a lot more time with Little Westside.

29 Pfeiffer: Julius did? Ok.

1 Watson: Yeah. Cause from what Anna tells me him and Little Westside weren't really  
2 that close, like best friends or anything until they just started hanging, he had just started hanging  
3 around with 'em. I don't know what they was doin' when they was together, but they, evidently  
4 they was doin' something. Because Julius always had a (inaudible) money.

5 Pfeiffer: Julius always had money?

6 Watson: Yeah, he always had money.

7 Pfeiffer: Like some, a lot of money?

8 Watson: Like, I know he'd always have, I mean to me for somebody that claimed to have a  
9 job who I don't see really working a lot, he always had at least, probably over \$60.00. Cause he  
10 was always giving Anna money.

11 Pfeiffer: Oh he always gave Anna money? Why did he give her money?

12 Watson: I guess just cause as a girlfriend. I don't know.

13 Pfeiffer: Ok

14 Fike: Did he ever flash big wads of money or anything?

15 Watson: Huh-uh (negative) I never really, I only saw him probably like a couple of times  
16 but I never saw like big wads of money.

17 Pfeiffer: If she told us he gave her money 30 or 40 times would that surprise you?

18 Watson: Huh-uh (negative)

19 Pfeiffer: So you wouldn't find that unusual?

20 Watson: Huh-uh (negative)

21 Fike: Do you know if him making any other trips to Dallas? Her talking about him  
22 saying he was going or them making trips to Dallas?

23 Watson: Huh-uh (negative) that's the only trip I had heard about, them going to Dallas.  
24 (inaudible). I mean (inaudible) out of town or anything.

25 Pfeiffer: Did she ever talk to you about him a getting arrested in a stolen Honda in  
26 Norman?

27 Watson: A long time ago?

28 Pfeiffer: March.  
29

1 Watson: She told me about it. She said that what happened was he had ah...he was in the  
2 mall, he was at the mall and he found a set of keys and he ah...like I guess walked around the  
3 whole parking lot, you know, doing this the little alarm to see which car it was. And when he  
4 found it he took it. And ah, got it fixed up and got some other stuff done to it and kept it.

5 Pfeiffer: When you said "got it fixed up" with what?

6 Watson: I guess he just got it, I guess he just got, what you say, he got a new motor put in  
7 it, a different kind of motor put in it, put some rims on it and a stereo system. He didn't do  
8 anything like a paint job, but he put different tag on it. At this time I wasn't, when she told me  
9 all of this I wasn't living here. I was living in Dallas. So she had just told me that when I came  
10 look, like on the weekends.

11 Pfeiffer: So you were living in Dallas when?

12 Watson: I stayed in Dallas until the middle of February.

13 Pfeiffer: And what were you doing in Dallas?

14 Watson: I was working at a mortgage company.

15 Pfeiffer: Oh in Dallas?

16 Watson: Uh-huh (affirmative)

17 Pfeiffer: Ah...so when'd you move down here?

18 Watson: Back in the middle of February. Probably around the 17<sup>th</sup> of February.

19 Pfeiffer: Of February?

20 Watson: Uh-huh (affirmative)

21 Pfeiffer: Did she say anything about him being in this stolen Honda, like, well actually I  
22 guess she told you he said he stole it.

23 Watson: Yeah.

24 Pfeiffer: Ok Did she have any problem with that?

25 Watson: She didn't say anything else about it, that was just it. She didn't say whether  
26 she'd be, I mean she's claimed she didn't like the idea that he was ah...he was going about his  
27 stuff that he was doing. But she didn't say anything about the car.

28 Fike: What was the lot of stuff that he was doing?  
29

1 Watson: I guess like just stealing little things and ah...I don't, I mean he had got in some  
2 trouble in the past and she was just...didn't really go into detail about all the trouble but she kind  
3 of just put it all up in what it is he had hustled. I mean you know she didn't like him hustling  
4 like he was. Trying to make money quick you know...like that.

5 Pfeiffer: Did she say what the other things, little things were that he'd done?

6 Watson: I think one, I wanna say one of 'em is buy drugs. But I'm not sure if he did like  
7 selling weed or something but I wanna say one of 'em was (inaudible).

8 Pfeiffer: Ok. Well that's all I have. Do you have anything?

9 Fike: No, can't think of anything, we've already covered all the stuff the night we were  
10 there at her apartment.

11 Pfeiffer: Ok. Umm....I can't think of anything else, we really appreciate you coming in  
12 and taking your time to come in and talk with us, we really do. Really, really. Ah...we'll give  
13 you one of our cards if anything comes up...

14 Watson: Uh-huh (affirmative)

15 Pfeiffer: Please give us a call if there is anything else you remember we'd also like to hear  
16 from you. Ok?

17 Fike: Or if something else, you hear in, information.

18 Watson: Ok.

19 Pfeiffer: Yeah, we'd like to know about it. Ok? Thanks Talitia.

5 Detective Turner, present is uh, Sergeant Thompson, uh, Demonde Coleman and his attorney,  
6 Mr. Rouse.

7 Is that, did I pronounce that correctly?

8 CR Charles Rouse, yes sir.

9 JT Ok. Ok, before we begin...is it Demondee?

10 DC Yeah, Demonde.

11 JT Coleman, right?

12 DC Uh-huh (affirmative)

13 JT (Inaudible). C O L

14 DC E

15 JT M A N?

16 DC D E M O N D E

17 JT D E , your date of birth please.

18 DC 3/6/77

19 JT Ok, I know your attorney is present, however I'm gonna go ahead and, and read your  
20 Miranda Warning. You have the right to remain silent. Anything you say can and will be used  
21 against you in a court of law. You have the right to talk with a lawyer and have him present with  
22 you while you're being questioned. If you can not afford to hire a lawyer one will be appointed

2 JT Just sign that you acknowledge the rights and that the answers that you gave me up here  
3 are true and correct.

4 CR Witness, right?

5 JT Yes sir. We're just gonna kind of have this open ended discussion basically and that is  
6 starting with uh, I'm gonna ask you a few general questions uh and then I want you to just  
7 explain what happened the day, from about the beginning when you first...uh, probably starting  
8 around 4:00 in the afternoon until you met with us that night. Kind of give us an overall of what  
9 happened. But I'd like to get some general stuff cleared up. Uh, how long have you known  
10 Julius?

11 DC I've known him for a little while. I mean, cause he use to stay on my street a long time  
12 ago when we were growing up.

13 JT What street was that?

14 DC Florida.

15 JT Florida Street in Oklahoma City? Do you still live on Florida Street?

16 DC Uh-huh (affirmative)

17 JT Do your folks live there now, or...

18 DC My father does.

19 JT Ok. Uh, what was the address on Florida?

20 DC 10917.

21 JT Ok. (inaudible). Uh, can you tell me how, about how long ago was that, when you lived,  
22 when you all were neighbors?

23 DC I'm not quite sure because uh, when he left, when he left there, when they moved, they  
24 moved to Camelot, so, we were young then. Real young, before...before high school.

25 JT So we're talking, how long have you been out of high school?

26 DC 4 years.

27 JT So we're talking 10 years ago?

28 DC Yeah at least.

29 JT At least 10 years ago. Have you associated with him quite frequently up from...

1 DC I mean if I see him out, I mean we'll speak like at a store and just like normal.

2 JT Ok. But you don't, you're not, you're not, not on occasion to normally go out together  
3 and socialize and that sort of thing on a regular basis... or how would you?

4 DC Nah, just when I see him we speak. Go to a store you speak with him.

5 JT Right. Uh, starting that afternoon...you know, before you saw Julius. What, or right  
6 about the time you saw Julius, tell me what you were doing and then kind of go ahead and tell  
7 me what happened after that.

8 DC I was just at home. And that was my day off. I was just sitting home relaxing.

9 JT Where do you normally work at?

10 DC At Swisher.

11 JT What's that?

12 DC It's a towel, I mean, it's, we clean, we're like a maintenance, we clean bathrooms, we fill  
13 towel dispensers.

14 JT Ok.

15 DC Like if you go into any public bathroom...

16 JT Sure

17 DC You'll see the towels which has Swisher on them.

18 JT Ok.

19 DC We don't have a lot of stores but we're, it's growing.

20 JT So you were on a day off.

21 DC Uh-huh (affirmative)

22 JT And you were at home and what happened then?

23 DC He came by my house.

24 JT He came by? What, what was he driving?

25 DC He was driving the uh, what was it, like a '72 Cutlass or something like that.

26 JT Ok. The one that eventually was dumped in the parking lot at 7-Eleven?

27 DC Uh-huh (affirmative)

28 JT Ok, what did he tell you when he came to the door?

29

1 DC He didn't tell me anything cause I was outside talking with my father. And I just, rolled  
2 up. Said, "What's going on?" Spoke, starting speaking with him and had a little conversation.

3 JT Ok. Uh...he, ok, just had a conversation did you have, since you weren't real close to him  
4 do you think it was kind of odd that he would just show up on your front door?

5 DC Not really because the street that we stay on...I mean a lot of people that I've, I've seen,

18 DC I don't know, I think it's on the south side.

19 JT Ok, what did you say then?

20 DC I said, "It's not a problem. Need me to drive one of the cars for you, I mean I will."

21 JT Ok. Ok, so he was gonna take you to his, to see about his car at the shop and then.

22 DC Well he didn't go to the shop, we ended up going to uh, to the Texaco on 240 and May.

23 JT Ok. Then what happened?

24 DC What he said was, he needs to wait for a little while, you know said, before he can go  
25 pick up so he's out with his friend, the car he had. Cause I knew it wasn't his. He said he  
26 needed to get his car back so if I didn't mind could I drive it back to my house and he'll page  
27 him and let him know he can come pick it up.

28 JT Ok, so he just drove, he drove himself with you as a passenger to the Texaco?

29 DC Uh-huh (affirmative)

1 JT Station.

2 DC Cause I seen him, you know, we needed some gas for me to get back to my destination.

3 So I put some gas in it you know.

4 JT Ok

5 DC Then from there I got back on the highway and I just let him, let him go cause, like I said

6 it seemed, it did seem kind of weird. But I'm gonna, I don't really, cause he just doesn't casually

7 everyday just come by my house.

8 JT Right. Ok, when he dropped, he stopped the car, then what'd he say, "it's all, the car's

9 all yours, do whatever you want?"

10 DC Nah, he said, that's what I just told you, he said, go ahead and take it back because he

11 needed his, cause the dude may need his car. His friend needs his car so just take it back to him,

12 he'll page him, so he'll come by my house and pick it up.

13 JT Ok. Ok uh...did he, on the, during that, the trip, did you have a conversation among the

14 two of you about anything at all, I mean just...

15 DC Not really just, I just started talking about like old times or something. But other than

16 that we didn't really talk too much.

17 JT He never, he never made the comment that he was running from the police?

18 DC Huh-uh (negative)

19 JT He never said anything like that? Did you not know that?

20 DC I didn't know, I knew, I didn't know nothing about the situation, I didn't find out about it

21 until that night.

22 JT Uh-huh (affirmative)

23 DC And I seen everything on the news and stuff.

24 JT Ok. Ok, well...I'm gonna tell you I've already got a couple problems with what you told

25 me. Cause what you're telling me now is different from what you said the other night. First of

26 all you said that there was a bunch of police at his house and you needed...

27 DC I passed by there, I seen that after...I seen him.

1 JT Ok, well....in our conversation the other night uh, you said that he came to your house,  
2 this is the way I remember it, he came to your house said there's a bunch of police at my house,  
3 I need you to take me, I need you.

4 DC (inaudible).

5 JT And then at the time you said you, that you didn't want to go any further. And it  
6 was...I've got several witnesses that heard you say that.

7 DC I know I didn't say that.

8 JT Ok, that you were, that you wouldn't take him any further than I-40, you just dropped  
9 him off.

10 DC I-40?

11 JT I-240 and uh, May Avenue. You said you just dropped him off there and then you  
12 didn't know where he went from there.

13 DC Yeah that's why I left, I went back home.

14 JT Ok.

15 DC But I didn't make it home. The car broke down at uh, on May.

16 JT Yeah.

17 DC At the 7-Eleven.

18 JT Ok. Well I'm just trying to remember a way, you know, the way you said it and the  
19 way...

20 DC Yeah I was there, during the morning I mean...

21 JT Ok.

22 DC I just woke up. And you guys scared me pulling guns on me and I, I mean...

23 JT Yeah. Wrong place at the wrong time I guess.

24 DC I, I know that's, that's, that's my life story. But I didn't, I mean...I did not know about  
25 the, the whole thing.

26 JT Ok, You had no idea that uh, that you were, that you were taking him down to get away  
27 from his home area. You saw the, ok, how you...

28 DC I didn't see the police till, see when I, if I'm on 122<sup>nd</sup> at that 7-Eleven that's when I came  
29 down 122<sup>nd</sup> and I have to call for a ride when the car broke down. That's when I seen all the, all

1 the police and then I found out on the news later that that's why he was you know acting strange  
2 like that.

3 JT Who did you call for help? When you got to the 7-Eleven.

4 DC Uh, I think my uh, friend Bryan.

5 JT What's his last name?

6 DC Spade

7 JT Spell that for me would ya?

8 DC I don't know.

9 JT Spade, that's his real name?

10 DC No, his, yeah, Bryan Spade, yes, (inaudible).

11 JT Its Spade?

12 DC Spadey, Bryan Spadey.

13 JT Ok. And he came by to help you?

14 DC Yeah.

15 JT Ok. Uh...Did you know who's car that was that you were driving?

16 DC I knew it was his friend's. But I didn't know he owned, know him, know him like, like I  
17 wouldn't speak to him I just knew that wasn't, wasn't his car.

18 JT How were you gonna get back a hold of uh, Julius to tell him that...

19 DC I just said that he was gonna call him from where he was at and page him and let him  
20 know that I was back.

21 JT Well that was before, that's before the car broke down and everything.

22 DC Yeah, yeah.

23 JT So how were, I mean did he...

24 DC I mean that wasn't my problem, that's not my car.

25 JT Yeah. Well, ok.

26 DC If he finds it there, he finds it (inaudible) can't just, I can't dwell on, on that, I mean...

27 JT Yeah.

28 DC It wasn't nothing he was gonna be able to do, come pick it up it was broke, I mean, it was

1 JT Uh-huh (affirmative) Did you not uh, you know that this got a lot of media attention, do  
2 you have a television at home?

3 DC Do I?

4 JT Yeah.

5 DC Yeah.

6 JT Did you, did you, were you totally unaware of what was going on with, with Julius and...

7 DC Not really cause I don't watch TV that, that much. After, after Ii got home I left my  
8 father, I went to uh, we went and picked up some food, then we went to Edmond to uh, his  
9 friend's house to see if, if he was home. And, and his friend's name is Michael Richardson.

10 JT Ok, I'll be right back.

11 DC He's trying to catch me in some type of lie.

12 CR Just tell 'em the truth.

13 DC That's what I'm doing.

14 JT Mr. Rouse could we talk to you just for a second?

15 CR Sure.

16 CR Are we rolling?

17 TP We're rolling.

18 CR Ok.

19 TP Ok,

20 DC Uh...When, from when he picked me up, ok.

21 TP Right.

23 TP Ok, when you came in contact with Julius Jones and that would have been Friday.

24 DC Uh-huh (affirmative)

25 TP Today's Monday, so it would have been uh, few days ago, what did he say to you?

26 DC Well we, he first pulled up to my house, he didn't, he didn't let me know anything was

27 wrong, I mean...I mean the truth he didn't let me know anything was wrong. I ask him to take

28 me to the store where, it end up to me, end up me riding out to the South Side with him.

29 TP Ok. So he came to your house on Florida?



1 DC Uh-huh (affirmative)

2 TP Ok. And what did he say to you?

3 DC Well at that time he didn't tell me anything about what was going on. I heard about it,  
4 only time I hard about, he did, he did tell me that he thought the police were at his house. But  
5 they were in plain clothes. I mean plain cars. He said he seen some cars sitting out there.  
6 But I didn't think nothing of it because always, I, I see a lot of plain cars sitting on my street too  
7 so...I didn't even think of anything out of that. What he didn't want to go back, he wanted, he  
8 wanted to pick up his car, he said he had a car out there somewhere that he wanted to pick up.  
9 But when he told me that he knows, he thought that uh the police were sitting at his house, that's

16 TP Ok. When from point A, when he picked you up...to uh, I-40, 1-240 and May, is that  
17 right?

18 DC Yes ma'am.

19 TP Did he tell you about the police being at his house.

20 DC Oh we was already on the highway.

21 TP Ok. Is he driving or were you driving?

22 DC He was driving.

23 TP Ok, So what was the conversation after that?

24 DC Well, conversation was casual about the car. And then he went to what he's like, man I  
25 think it was some uh, some plain clothes police cars were in front of my house. I was like, oh  
26 really, I mean I wasn't too much you know trippin' on that, cause I didn't, I didn't, I didn't know  
27 he was in any trouble. So I didn't think of nothing of it. I just wanted to (inaudible) get back  
28 from the South Side.

29 TP So when you got to your destination.

1 DC Uh-huh (affirmative) I just dropped him off at the gas station. I put some gas in the car  
2 and got back on the highway. He came back to my side of town.

3 TP Did he say why he wouldn't just drive himself down there and have his friend come up  
4 and pick up his car?

5 DC No, he didn't say that because I'm thinking, well, his friend's gonna pick a car up from  
6 my house, he must be on my side of town. I never knew why, you know, his friend wasn't with  
7 him. I never ask him why his friend wasn't with him.

8 TP Ok. When we were standing there, and I was one of the officers standing there.

9 DC Yeah I kinda recognized the blonde hair.

10 TP Yeah, blonde, blonde hair there. Uh...you said, to the Oklahoma City officer, I don't  
11 know who that was, that...Julius had come to your house, said the police were all around your  
12 house and you needed a ride to the South Side and you gave him a ride to the South Side and  
13 dropped him off.

14 DC Yeah I know, but that's not what happened.

15 TP I mean essentially what happened but... what you told us out there, when we were talking  
16 to you, was just what I articulated to you. Ok, so...

17 DC Well when he came to my house he didn't, I mean, swear to God, he did not say he was  
18 like on the run or anything like that. He just stopped by my house. I conversated with him and  
19 before I know it I'm in the car with him and then that's when, that's when he said he was, there  
20 was police, the police were over at his. Cause they, they wasn't surrounded it, he said they  
21 wasn't no one, they wasn't all surrounded it his house then. He didn't tell me anything about  
22 that. He said the police were sitting out in the front of his house.

23 TP When you brought his car back to the North Side of town.

24 DC Uh-huh (affirmative)

25 TP Uh, where were you going?

26 DC I was trying to make it home. But I was going to uh, to the Texaco here, cause I had a  
27 girl that I know, I was gonna go there and see what was going on with her but I didn't make it. I  
28 broke down when I got off the highway.

29 TP Who was the girl at the Texaco?

1 DC Uh, is that a Texaco on May, I mean I'm not for sure with all the, all...

2 TP There is a Texaco over on May.

3 DC Ok. Ok. On my side of town, right?

4 TP Correct.

5 DC Ok. Her name was Michelle Williams.

6 TP And does she work there?

7 DC Yeah. It's a girlfriend that I know, that I've been in, seeing or something like that.

8 TP Something like that?

9 DC Yeah, I mean it's not my girlfriend, so I'm not gonna say it's my girlfriend because I

10 don't have one.

11 TP Ok. And what was your route you took back from the south side?

12 DC 240 uh...I guess to get off down there on 122nd and May the one that goes all the way

13 around.

14 TP Ok. And then you took the route back, I mean you got off on...

15 DC About 122<sup>nd</sup>.

16 TP 122<sup>nd</sup>. And so you're going down there and then what happens with the vehicle?

17 DC Starting to shake.

18 TP Ok.

19 DC That's why I pulled off in the 7-Eleven to see what was wrong with it. That's when the

20 wheel fell off when I backed up out of 7-Eleven.

21 TP Did the clerk come out and help you?

22 DC Uh-huh (affirmative)

23 TP Out of the 7-Eleven?

24 DC Uh-huh (affirmative)

25 TP Help you push the vehicle?

26 DC Uh-huh (affirmative)

27 TP Ok.

28 DC I called my, I called my friend, he, before uh, he was helping me at first until my friend

29 got there, then we were helping, trying to...

1 TP Who was your friend that got there that you called?  
2 DC Uh, Bryan Spadey.  
3 TP Bryan?  
4 DC Uh-huh (affirmative)  
5 TP Last name?  
6 DC Spadey.  
7 TP How do you spell that?  
8 DC I don't know. (Inaudible) I do not know.  
9 TP Ok. Well...and why did you call him to help?  
10 DC Uh, he's the only one I knew that I could get in contact with at the time that had a car. I  
11 was stranded, I wanted to go home without walking.  
12 TP Does he live on the South or on the North side?  
13 DC Uh, he lives pretty close. I just know how to get in touch with him.  
14 TP How'd you get in touch with him? What number did you call?  
15 DC Well I called (inaudible) cell phone number.  
16 TP Ok. So you had his cell phone number and you called his cell phone?  
17 DC Uh-huh (affirmative)  
18 TP And he came and helped you with the car?  
19 DC And took me home.  
20 TP So after you left the car there you just went straight home?  
21 DC Went straight home.  
22 TP Ok. When did you meet up with these girls?  
23 DC When they rung my door bell at two in the morning.  
24 TP Ok,. And they drove you over to their place?  
25 DC Uh-huh (affirmative). That's when we were just over there partying.  
26 TP What time did you meet up with Julius. What time did he get to your house?  
27 DC I'm not sure, I was standing outside with my father so...it could have been any time,  
28 cause my father gets off at 3:30, he doesn't get home till 4:15, anything between 4 and 5.  
29 TP And did you leave immediately?

1 DC When he got there?

2 TP Uh-huh (affirmative)

3 DC Yeah, pretty much. Probably talked for a couple of minutes and then we left.

4 TP And his exact words to you when he pulled up was...

5 DC He wanted me to ride with him somewhere. But I, when I told him take me, take me to

6 the store first, we...

7 TP What store did you go to?

8 DC I wanted to go to 7-Eleven on uh...on Hefner and Penn. That's the one I wanted to go to.

9 But he never, he didn't pull in.

10 TP Why'd you want to go to that one?

11 DC It's right down the street from the house.

12 TP Oh I see, ok. Uh, so you didn't go to the store?

13 DC Uh, he kept straight.

14 TP Ok. What is your pager number?

15 DC 991-8627. I just lost my pager.

16 TP Where'd it go?

17 DC Uh, I don't know, somewhere. If you lose it I don't know where it's at.

18 TP Ok. So he wasn't able to page you?

19 DC Huh-uh (negative)

20 TP Did you page anybody that evening?

21 DC My cousin.

22 TP And who's your cousin?

23 DC Ladell.

24 TP Ladell who?

25 DC King.

26 TP So why were you paging Ladell?

27 DC We work together he was suppose to take me to get my check.

28 TP Where do you guys work together at?

29 DC Swisher.

1 TP What's that?

2 DC Uh, it's like, everybody keeps saying that.

3 CR He's answered that question 4 times including to me.

4 DC It's a maintenance, it's like, we clean bathrooms, by keep, bath, I keep, I maintain  
5 bathrooms in fill in their uh, their paper dispensers and soap, dispensers and stuff like that.  
6 I keep those stocked. Once a week and like fast food places, restaurants and stuff like that.

7 TP Where is Swisher located?

8 DC Well they just came out of Tulsa. I mean I just got this job at the spur of the moment.

9 TP Do they have an office here in Oklahoma City?

10 DC No, they have is a warehouse on, on uh, where's it at, cause I, I just keep meeting the  
11 boss guy. He drops off my supplies and gives me my route to not run 'em. But it's some  
12 whereon the South Side too. I'm ot sure. It's on Walker or Western or something, I'm not sure  
13 what this, I'm not familiar with that side of town.

14 TP Did King get you this jjob?

15 DC Uh...we found out about it and we pretty much had the interview together with the  
16 uh...the top guys in Tulsa. They came down.

17 TP How long have you been working for 'em?

18 DC Probably week, week and a half. I only got one check.

19 TP Ok, and so you were calling King about...

20 DC We were off Friday we suppose to pick up our check, he was suppose to take me to get it.

21 TP And that would be at the warehouse?

22 DC Well we just, I don't know where. Just have to call the uh, call our boss, he's running  
23 around with our checks with him.

24 TP Who's your, who's your boss?

25 DC Oh what is his name, what is his name? I'm not real, I not real sure.

7 DC It was brown or something, I don't know.

8 TP Ok, and he says to you? What?

9 DC Oh he was like, "Can you go somewhere with me," I was like, "I could, but I want to go

28 DC In fact when you all ran up on me that night I had cinnamon rolls and sweet rolls in my  
29 hands.

1 TP Ok. Uh...So he doesn't stop at the store, you don't ask him why and then what happens?  
2 DC Uh, keep on driving. Come on down Broadway.  
3 TP And what is he saying to you then? What, What's he need to do?  
4 DC Uh, he was just talign about he needs, he just needs to pick up his car. Just needs to pick  
5 up his car, he's talking about some Champion somethin', transmission, his car is at, is at a  
6 transmission shop, that's all I knew.  
7 TP Ok.  
8 DC On the, on the South Side.

23 DC Jones. His older brother. That's how, that's how I know him. Me and him play football  
24 together quite a bit.  
25 TP Antonio?  
26 DC Uh-huh (affirmative)  
27 TP Ok.  
28 DC We graduated the same year. Played football in high school together.  
29 TP You didn't know Julius had 4 felony convictions?



1 DC Huh-uh (negative) If I'd a known that I'd of never been around him.  
2 TP Ok.  
3 DC Cause I'm on probation.  
4 TP For what?  
5 DC Trafficing.  
6 TP Ok, so you're driving that way he's telling you...  
7 DC He's driving.  
8 TP He's driving that way, thank you for correcting me. And he's telling you about the police  
9 he thinks are at his house. You get off that topic, as you said a moment ago. Then what  
10 happens?  
11 DC Uh, by the time, by the time we was talking about that we was already up there.  
12 TP Did he say where he was going?  
13 DC Huh-uh (negative) Well he, I just well, where you, you know where ever (inaudible)  
14 cause I need to get some gas, I see that uh, you know on E, so stop at this Texaco and he's like,  
15 "well that's where I need to go anyway."

4 DC Huh-uh (negative) It's two apartments, it's one on this side and we get off and there's  
5 one behind that grocery store, so I don't know which ones he might have been going to. He's  
6 kinda staying there for a second, so...

7 TP Ok.

8 DC But after that I went ahead and drove off.

9 TP Do you have anything? Ok, I appreciate uh, you talking with us. And uh...it is 5:35 on  
10 August the 2<sup>nd</sup>, 1999.

11 ?? Let me check these folks out and I'll be back to see you here in a second.

16 TP Phone?  
17 VM No phone.  
18 TP Ok. What's your date of birth?  
19 VM 12/27/71  
20 TP Social Security number  
21 VM Uh-huh  
22 TP Ok. Uh, you're the girlfriend of?  
23 VM Ladell.  
24 TP Ladell? What's Ladell's last name?  
25 VM King.  
26 TP That's right, Ladell King. Ok, this last Wednesday, today's Friday the 30<sup>th</sup> of July, last

23 park or whatever. The maintenance people they've all got different vehicle now. And so I

24 didn't think anything about it. At all.

25 TP Uh-huh (affirmative)

26 VM And then Thursday...we start, we...we were watching the news.

27 TP Thursday, this was the next day after this Wednesday?

28 VM Uh-huh (affirmative)

29 TP Ok

1 VM On Thursday we was watching the news and like I said we never watch the news.  
2 And...they were talking about the man and what had happened and...

3 VM No, the "Water Boy" was the last movie that we watched.

4 TP So you don't think they were there over 2 hours?

5 VM Huh-uh (negative)

6 TP No?

7 VM Huh-uh (negative)

8 TP Ok, uh....so Thursday morning the suburban was gone, uh, the news comes on Ladell  
9 voices his concern?

10 VM Yeah.

11 TP Ok.

12 VM And the suburban left that morning but like I said I didn't think anything of it because  
13 Kirk does, you know, cars come and go.

14 TP What did you think after he told you that?

15 VM After he told me that I was like, "What are you talking about?" And he, he just said,  
16 "That, that was that man's suburban. I know that that was that man's suburban." Cause he had  
17 saw Channel 53, he went, somebody's, he, he, someone had cable, I don't have cable but,  
18 Channel 53 they gave more information then the regular channels 5,4 and 9. And he said, "That

15 pulled their guns and it was like, "You need to get out of the car, who are you? Are you Toy  
16 Smith? Where do you live?"

17 TP Are we talking about the Detectives?

18 VM Yeah.

19 TP Ok

20 VM "Where do you live? What, what's your name?" And that's when I gave him my ID, I'm  
21 like, "I'm gonna reach in here into my portfolio and give you, this is nothing but portfolio. Give  
22 you my ID," cause guns, guns were drawn and my kids were sitting in the car. And they were  
23 petrified. And...

24 TP So you gave 'em the ID.

25 VM I gave them the ID. And he said, "Who are you?" I said, "On the ID. I'm Vickson." He  
26 said, "Well where's Toy, who's Toy Smith?" I said, "Toy Smith lived in this building, she  
27 moved."

28 TP And who is Toy Smith?

29 VM Toy is my best friend.

1 TP Ok. And how does she related to these other guys?

2 VM She's not.

3 TP Is she friends of these other guys?

4 VM Huh-uh (negative) She knew nothing about this.

5 TP So she's just your friend?

6 VM She's my friend.

7 TP Ok. So they get you out of the car I assume and you go upstairs?

8 VM No, their downstairs.

9 TP Oh, pardon me.

10 VM That's ok. Uh, went downstairs they uh, ask me where Ladell was I told them as far as I

11 knew Ladell was at work. Cause as far as I knew that's where he was. Are you sure he's not

12 here? "No sir, I got all the keys," and at the time I had his car keys and my house keys. I had

13 all the keys. Cause I was driving his car today so I could get to my interviews. I opened my

14 door, they moved me to the side, checked every room, guns drawn everything. They went into

15 Toy's apartment because apparently Ladell called from her phone. At some point. Checked

16 her apartment, guns drawn and everything, checked her phone got all the phone numbers off of

17 her phone. Then he goes into the questioning and, and what do I know about this person, what

18 do I know about that person. I was like, "All I know is that these 2 people know him, I don't

19 know them, I know one's name is Julius and I think the other one's name is Westlin, Westside.

20 West something, that's all I remember calling him."

21 TP Uh-huh (affirmative)

22 VM If you would simply let me page Ladell I will tell Ladell to come home, cause I don't

23 know what you want from me. I don't...

24 TP Did you finally page Ladell?

25 VM I did, he did allow me to page Ladell. And I paged Ladell, told Ladell that the police was

26 there. No, first I told him I said, "Would you please come home." And he's like, "What's

27 wrong?" Cause I was crying then cause I didn't know what was going on.

28 TP Uh-huh (affirmative)

29

1 VM He say's, "What's wrong? Why you crying?" I said, and I was looking at them, may I  
2 tell him so he can come home? He's like, "Yeah, ok, fine, tell him," I said, "The police are here,  
3 they want to talk to you about what happened Wednesday. You need to come home cause I got  
4 the girls and their talking about taking me to jail, taking the girls to the State. And I don't know  
5 what's going on" I just, "You just come home." And then, the man driving, what's his name?  
6 TP Detective Fike.  
7 VW Detective Fike, he say, "I know Day Day, let me talk to him." No problem I gave the  
8 phone to him, he told...  
9 TP Day Day is his nickname?  
10 VW Yeah.  
11 TP Ok.  
12 VM He told uh, Ladell, "I need to talk to you, where are you, we'll come pick you up."  
13 Ladell told him, "No, I'll come to you. I need to come home because she is petrified."  
14 TP Ok, so he comes home?  
15 VM He did. What happened was he told 'em, "I will come home." He did tell them that.  
16 They still put me in the truck. And had me take them to his Uncle's house, to Ladell's Uncle's  
17 house. He had already left, cause he told ;em, "I will come home. I will walk down there. I will  
18 come there, come to you all." Now I have a nervous condition. I have a very bad nervous  
19 condition. And so, you know, no problem, I'll come home.  
20 TP So he, they eventually...  
21 VM They, they, we crossed, was basically what happened.  
22 TP Ok  
23 VM We went to his Uncle's house, we got to the Uncle's house they saw him (inaudible)  
24 whatever, in the mean time...by the time we got to the Uncle's house, they got in, ask the, one of  
25 the kids over there where Ladell was, he said, "He's gone. He left walking." Then one of the  
26 other guys that was still at the apartment complex paged and said, "We've got Ladell, he's here."  
27 TP So they go back?  
28 VM He came up, so they came back. Dropped me back. And I thought that they were gonna  
29 bring me down here earlier for this statement but he said, "Thank you, stay here, uh, we've got,

1 we got Ladell. We'll take care of it and we'll get a statement from you later." Then...shortly  
2 after, not long, I can't say shortly I probably say 30 minutes, 30 to 45 minutes...

3 TP About what time was that today?

4 VM Oh what time you'd bring me back home? They had to bring me back home around  
5 about 4. Almost say, close to 4 o'clock. Because close to like 4:15, I was outside talking to uh,  
6 the neighbor's upstairs. I was in the hallway talking to his neighbor's. I was distraught I needed  
7 to calm down. And Julius and Westside pulled up. They just whipped up in the car.

8 TP What are they driving when they pulled up?

9 VM I, it's like a burnt orange Cutlass, you know the older model Cutlass.

10 TP Uh-huh (affirmative)

11 VM And he just looked up and I saw the car whip up, so and, after what detective, I'm sorry I  
12 can't think of his name.

13 TP Fike.

14 VM Fike, after, when he, when I, when he first came to me he, he said I need to ask you a  
15 question, "sir, can you tell me what this is regarding please? Can you, talk to me, tell me  
16 something. I'm a wreck here. Just tell me something." He's like, "It's about the homicide in  
17 Edmond. The man that was shot in the head and we think that either Ladell or these boys have  
18 something to do with it. And when he told me that, I just threw up a big ole guard so when they  
19 came whipping back into that drive area, I saw the front part of the car before they could see me.  
20 I spun around ran back in my door, locked the door and ran in my back room. And hid my kids  
21 underneath the bed. Cause I didn't know...what was going on.

22 TP Ok, then what happened?

23 VM Then Julius came in, he said, "Where is Day Day?" I said, "As far as I know Day Day's  
24 at work." He said, "Have you talked to him?" "No, cause he's at work." He said that the police,  
25 Day Day just called me and told me that he was on his way. I said, "Ok, and...what does that  
26 mean to me?" "You know, I, I want to know what is going on. Police had greeted me when I  
27 came to my door. I wasn't even out of the car good and police are here on me. You tell me  
28 what's going on" He said, "I don't know what's going on, all I know is that there's a cop car all  
29

1 around my house and I jumped out the window.” So, and when he came he came with  
2 Westside, Westside was driving.

3 TP How’d he hook up with Westside?

4 VM I don’t know. All he told me was he jumped out the window and he needed to talk to  
5 Day Day, because he didn’t know what was going on. I said, “Well I don’t know what’s going  
6 on either. All I know is they said, they is his car, and I was in the car, they questioned me, they  
7 took to his Uncle, brung me back and I still don’t know...what’s going on.

8 TP What’d they say?

9 VM He said, “Well ok, I guess I’ll go back over there.” That’s all he said, he said, “I’ll go  
10 back over there.” I don’t know if that was where we were, I don’t know where there was.

11 TP Did he leave?

12 VM Yes.

13 TP Did you see, did you see Westside with him?

14 VM Uh-huh (affirmative)

15 TP Did they both come up and talk to you?

16 VM Uh-huh (affirmative) they both came in, they both came right in the door.

17 TP So the one that’s talking to you though is Julius?

18 VM Is Julius. Uh-huh (affirmative) Julius was talking...

19 TP Did Westside say anything?

20 VM Westside didn’t say nothing. At that point. Then they left. And I was like, I do not  
21 believe this. This is unreal. And I still don’t know what’s going on. Five, I would have to say  
22 5:30, 4, 5:30, 5:35, I know the news, the 5 o’clock news had went off.

23 TP Ok.

24 VM Westside came back. And he was huffing and puffing so I couldn’t tell if he was running  
25 or if he was in car, I couldn’t tell, he just walked in my door, just like you would walk in and out  
26 the door. He just walked in. Didn’t knock or nothing. “Have you heard anything? Have you  
27 talked to Day Day? What’s goin’ on? Have you watched the news?” I said, “Watched the  
28 news what? No, I haven’t watched the news. I ain’t been too long got home.” “I need to watch  
29 the news, I need to sit here and watch the news.” So he sat there until the news came on. In the

1 mean time Ladell, Day Day had called. And he said, "What's wrong?" I said, "Where are  
2 you?" He says, "I'm in, I'm at the police station in Edmond. I'm fine. Don't worry about me,"  
3 cause he knows how I am. "Everything's cool I'm sitting her talking to the detectives, don't  
4 worry about it." And I started talking real funny. And he said, "What are you, what's going  
5 on?" I said, "Well Mom I paged you to see if you would come and get the kids." So he knew  
6 right off hand that something was wrong because my mother never comes to get my children. I  
7 always take them to her. And he said, "What's wrong, is somebody there?" I said, "Yeah," And  
8 uh, he said, "Who's there?" I said, "Well I don't know Momma, just name off some names and  
9 I'll see if I can remember the person that you're talking about." And so he started naming of  
10 people, he thought maybe visiting. And he ask if my friend Toy was there, I told him no. He  
11 ask if Julius was there, I said, "no." He said, "Well uh, is it, is it a dude there?" I say, "Yeah."  
12 And he said, "Is Westside there?" I said, "Yes he is." And at that point, whoever he was talking  
13 to here, he told 'em he said, "hey, the other dude is in my house. He's at my apartment with my  
14 girlfriend and my kids." And they got the address again and he told 'em you know you all need  
15 to come and get him, cause I don't know if he's got a gun, I don't know, you know, I don't  
16 know...

17 TP That's what you're listening to him say on the other phone.

18 VM Yeah, this is what I'm listening to him say.

19 TP Ok, Ok.

20 VM And he gave them the address, he gave the address 2 or 3 times, I was, I was thinking,  
21 just saying, "Well Momma, I know that you (inaudible) I know you want to come get the girls  
22 so let me give you the address, here's the address," I'm repeating the address. And, and he's like  
23 hold on, (inaudible) Momma done put me on hold. You know I'm saying, "I'll hold." You  
24 know I'm playing off this best I can. Cause, I, I mean, I mean, after what the detective told me I  
25 was like...

26 TP So then what happened? Did you hang up the phone?

27 VM Eventually I hung up the phone, but Ladell said, you know, they told him to keep me on  
28 the phone talking. So that they would know he was still there. Just keep me on the phone, just  
29

1 keep me on the phone. That's all, I'm constantly having this conversation on the phone and  
2 uh...his pager started going off.

3 TP Westside's pager?

4 VM Westside's pager started going off. So I said, "let me walk back here to the room and  
5 make sure they have clean clothes and diapers so I can start packing them their bag," and that got  
6 me away from him and got me back in my girls room. And I'm back there fiddling with clothes  
7 or whatever. I'm still talking. And uh..then uh...my friend Toy knocked on the door, she said,  
8 "What are you doing?" I said, "Nothing." And then my kids came out and they said, "T.T. I  
9 want to see my T.T." Which is Auntie to us."

10 TP Uh-huh (affirmative)

11 VM And so I let them go, that was the key for me to get them out of the house, out of the  
12 apartment, so I let them go with her, out of the apartment and then she's like, "Come around I  
13 need you to help me move this," "I'm on the phone talking to my Mom, but I can help you do  
14 that," just in the phone. He's still sitting in the apartment. But his pager kept going off. Then  
15 you know, I'm still talking and he's still telling the police officers, "Man he's still there. He's  
16 still there. My girlfriend and my kids are there by theirselves, please get somebody over there."  
17 And uh, he's saying, his pager keeps going of, keep going off, keep going, he's like I need a  
18 phone, I need a phone, and I was like, "well my Mom," you know, "I'm still talking on this  
19 phone." And he says, "Is that other phone working?" I said, "No, that phone got turned off."  
20 Just to keep him from going into that, into that apartment. And he was like ok. So he sat on the  
21 stairs, well he went to the back door of the apartment he was talking to a little kid and he went  
22 back down the stairs and he was sitting on the stairs. He went back in my apartment, got this  
23 shirt, he had a shirt that he didn't have on. He threw it over his shoulder, then he walked out the  
24 door. And I said, "Ladell he just walked out the door." And he was telling 'em, "Man, he just  
25 walked out the door. He just walked out the door. He's walking" And he was like, "What does  
26 he have on?" I said, "He's got on baggy blue jeans, a white shirt with some type of faded design  
27 on it and then he got a colored striped shirt thrown over his left shoulder. He's got the braids in  
28 his hair and he's got the, the, the little mustache, little beard. Whatever you want to call it.  
29 And he said, "Which way did he go outside, need to see which way he went cause he just walked



1 straight out the door.” And then 10 minutes later the other officers came and I wasn’t down, I  
2 wasn’t sitting downstairs, cause I was scared. I was sitting upstairs, waiting, cause Ladell said,  
3 “Hold on to the phone, I’m gonna call you right back.” Cause we don’t have a phone. We, the  
4 neighbor’s phone. Called to the phone, I’ll call you right back. Well he, he didn’t call right  
5 back but the officers came and then making sure that everybody was everybody walked into  
6 these other people, walked into the people upstairs apartment and ID’ed everybody. And  
7 (inaudible) “Where’s Vickson?” I’m like, “Here I am right here.” And he was like, “Ok, we  
8 need to talk to you. Where is this young man?” I was like, “He was here...for over 30 minutes.”  
9 And Ladell was telling you all he’s here, he’s here. Gave you all the address. He walked out the  
10 door. He kept getting pages. He walked out the door. And walked out the front gate. I don’t  
11 know which way he went cause I didn’t see him. I just saw him walk out the door.

12 TP And that’s when you get brought?

13 VM And that’s when they, yeah, they brought me down to the site where, where and uh,  
14 that’s (inaudible) that had him in handcuffs and uh, he just looked at me, I’m like.

15 TP Uh-huh (affirmative)

16 VM You know, what, you know, I’m saying...

17 TP Did he say anything?

18 VM No. You know I’m just looking like...what is going on? That’s, that’s what I, that’s what  
19 I’m still saying, is what is going on? Because they didn’t know...that, that Ladell was with, with  
20 you all. As far as they knew Ladell was still at work.

21 TP I understand.

22 VM And that’s what Ladell said, “Don’t nobody know where I am, you know where I am, so  
23 if he say anything, he ask you anything, as far as you know I’m still at work.” Cause...

24 TP Ok

25 VM You walk up to him a man and shoot him for a suburban, you will do anything. So I  
26 mean, you know...and I didn’t...

27 TP I understand. Vickson, I do appreciate it. Uh, I’ll get right back with you and find out  
28 who is going to take you back to your apartment. Ok?

29 VM Uh-huh (affirmative) Just, can I talk, can I talk to Ladell?

1 TP In just a minute. I'll find out what they're doing, ok?

2 VM Its hot in here. Now I'm hungry. (Tape stopped)
