
APPEARANCE RELEASE

This Release and any dispute relating thereto shall be interpreted, enforced and governed by the substantive laws of the State of New York, under the jurisdiction of the New York courts located within New York County. Grantor hereby submits to the jurisdiction of the New York courts.

Producer shall have the unlimited right to assign this Release and any or all rights herein granted. The provisions of this Release shall be binding on the undersigned and the undersigned's heirs, executors and administrators, and the rights herein granted to Producer shall inure to the benefit of Producer's successors-in-interest, licensees, and assigns.
